In toxic trap

Thousands exposed to stagnant tannery waste

Highly toxic tannery waste is now accumulating over a vast, densely populated area inside the flood protection embankment, with rising floodwater outside preventing the water from draining out into the Buriganga

More than 17,000 cubic metres of toxic waste from about 700 tanneries in Hazaribagh flow into Rayer Bazar, Hazaribagh, Katashur, Mohan Nawabganj and Alirghat every day.

Thousands of people living there are exposed to one of the worst land, air and water pollution in the city, as the liquid toxic is threatening to enter their

In many poor neighbourhoods, tannery waste is causing various illnesses as people are forced to wade through the toxic affluent now rapidly spread-

ing. Experts fear that the groundwater of the entire area is also contaminated. Experts at the Drainage Circle of the Dhaka WASA said similar water logging is prevalent 'everywhere' in the city. The flood protection embankment has blocked the city's water outlets and there is no adequate arrange ment to pump the accumulated water out.

They said millions of gallons of toxic industrial wastes have mixed with SEE PAGE 11 COL 7

Vigarunnisa Harried to watery grave closed for three days

The government has asked the Viqarunnisa Noon School and College to remain closed for three days to defuse tension arising from further extension of Hamida Ali's tenure as principal.

"The director-general of the Secondary and Higher Secondary Education Directorate has directed the school authorities to close the institution for three days to avoid any untoward incident," Education Secretary Mohammad Shahidul

Alam told The Daily Star yesterday. Some guardians were trying to mar the congenial atmosphere of the school, he alleged

The government hopes the school's newly elected governing body will select the principal from its senior staff. "We hope the institution will be able to restore the congenial atmosphere when the school reopens," the secretary added.

The budget session of the Jatiya Sangsad was prorogued last night with the main opposition Awami League (AL) staying off the House. The AL made its maiden appear-

ance in the eighth parliament late last month, ending the boycott of it since the very beginning.

"Joining of the main opposition party added a different dimension to the session ...But unfortunately, members from the party are absent on the day of prorogation " Acting Speaker Akther Hamid Siddiqui told the House before reading out the presidential order of prorogation at 10:30 pm.

Perks for NRBs mulled to up remittance

For the first time, the government will declare some expatriates as Important Non-Resident Bangladeshis (INRBs) to encourage them to remit more funds to the country.

The government formed a four-member high-powered committee headed by the State Minister for Expatriate Welfare and Overseas Employment Mohammad Quamrul Islam to determine what privileges the selected the INRBs would receive.

Foreign Secretary Shomsher Mobin Chowdhury, Commerce Secretary Sohel Ahmed Chowdhury and Executive Chairman of the Board of Investment (BOI) Mahmudur Rahman are the other members of the commit-

The committee already held its first meeting and will meet again next week, sources said. The INRBs would get various facilities when they come home and moral support from the government during their stay abroad.

The government is giving high priority to over two million NRBs so that they can contribute for the overall development of the country, a high official

Only Bangladeshis who remain abroad and earn a handsome amount of foreign currency would be given the INRB status, sources added.

Depending on their earnings and position abroad, some of them might be given Commercially Important Persons (CIP) status and some would be provided a Regular Remitters Card (RRC) to use the facilities, the source

Prior to the formulation of the committee, the NRBs did not get any attention or special facilities from the government regardless of the amount they SEE PAGE 11 COL 3

8 drown after police chase, no case accepted

Jamal Uddin Fakir, an activist of the Kapasia unit of the Bangladesh Chhatra League and president of the Shaheed Tajuddin Ahmed Smriti Library, was allegedly tortured in custody at the Kapasia Police Station.

On the morning of April 19, Jamal fled the custody and jumped into the Shitalakhya River. Police chased him down and poked him with a bamboo until he

To cover up the incident, police claimed that Jamal had jumped into the river, having fled the police station. Amid public outcries, the fire brigade divers on April 20 recovered the body with marks of injury.

Ramiza Begum, Jamal's mother, filed a petition with the Kapasia Magistrate's Court on May 2, this year, accusing the officer-in-charge and two policemen of the station of the murder. Twenty-year-old Jainal drowned in a lake in the city's

Sutrapur area to escape arrest by a police-BDR joint team on October 22, 2001. The incident took place when the team raided the Minto Club and nearby areas in the morning to arrest drug peddlers and addicts.

Govt orders ministries to fill up vacant posts

UNB, Dhaka

The government has asked authorities concerned to fill all vacant posts under 47 ministries on a priority basis for effective functioning of various government departments.

Official sources said the directive came from a regular meeting of the Cabinet held yesterday with Prime Minister Khaleda Zia in the chair. The meeting was told that there

are some 1.21 lakh vacancies against 9.30 lakh governmentsanctioned posts in 244 departments and directorates of the 47 ministries.

The meeting underlined quick recruitment to vacant posts of doctors, nurses, engineers, teachers. law-enforcement officers and technicians, particularly computer operators, in specialised organisations "in the interest of common people"

Of the situations vacant, there are some 13,807 vacancies under Health and Family Welfare Ministry, 11,263 under Primary and Mass Education, 9,346 under Home

Hasina claims at press briefing

Opposition leader and the Awami League (AL) chief Sheikh Hasina vesterday alleged that some 4.50 lakh leaders and workers of her party have been implicated in 'false' cases since Prime Minister Khaleda Zia's government

On the contrary, she said, nearly 35,000 identified killers, rapists, illegal gunrunners and criminals were acquitted of various charges under the directive of the law ministry.

Hasina was briefing newsmen at her Sangsad Bhaban chamber last night. The AL boycotted the last sitting of the budget session of the parliament

A court in Pakistan sentenced British-born Islamic militant Ahmed Omar Saeed Sheikh to death Monday for the kidnapping and murder of US reporter Daniel Pearl. Lawyers said Sheikh Omar, as he

is better known, and three accomplices, who were also found quilty of the killing and were jailed for life, showed no emotion as each verdict and sentence was read.

There was no immediate reaction from Pearl's family and widow Mariane, who gave birth to their son in Paris on May 28.

Lawvers for the defence, who described the verdict as unjust and arqued their clients' innocence throughout the closed-door trial, said they would appeal.

Omar and his accomplices Fahad Naseem, Salman Sagib and Sheikh Adil - were made to stand. one by one, as Judge Ashraf Ali Shah read each verdict and sentence.
