Law for energy regulatory body soon

BSS, Dhaka

The government will enact a law soon for setting up an energy regulatory commission to provide legal framework for restructuring the power sector

"The draft legislation for this purpose has been approved by the Cabinet and it is expected to be placed in parliament soon," State Minister for Power Igbal Hasan Mahmood said this vesterday at a luncheon here hosted by American Chamber of Commerce (AMCHAM) in Bangladesh.

With a pledge, he said, to make electricity available for all by 2020, the government has undertaken a number of reform measures for generation, distribution and transmission of power. The government is also working on a set of further reforms to be implemented in the sector, he added.

Iqbal Mahmood said the power sector reforms began with the creation of Rural Electrification Board (REB) in 1977 breaking the monopoly of Power Development Board (PDB)

Later, in continuation of the policy, Dhaka Electric Supply Authority (DESA) was established to take over power distribution system from the PDB. In 1992, the sector was made open for private sector participation through amendments to the Industrial Policy.

AL restates demand for CEC's resignation

The main opposition Awami League (AL) has demanded resignation of Chief Election Commissioner MA Syed for the "farcical" election to the Sandwip municipality.

"The voters were held hostage by armed cadres of the ruling party and were not allowed to vote, Abdus Samad Azad, the acting AL president, told newsmen after the party's central working committee meeting yesterday.

The Election Commission (EC) has already cancelled the July 20 elections, which was marked by zero-turnout in the face of threats and intimidation unleashed reportedly by ruling party activists.

The commission has also asked officials concerned to probe into the unprecedented incident, identify the people responsible and punish

The AL has blamed the CEC for engineering the heaviest defeat in the party's history in the October 1 general election and demanded his resignation.

Unocal has set some conditions, mainly financial, to supply gas to Petrobangla from the Moulvibazar field and hinted that its further investment depends on the Magurchhara compensation claim that the international oil company considers resolved.

The Unocal's reaction came after Petrobangla wanted to get gas supplies from its Moulvibazar field. Another issue which will

adversely affect our management's willingness to invest further capital is Petrobangla's most recent

request for \$685 million in compensation for gas consumed during the MB1 blowout of 1997 because we have indicated that we consider the matter resolved and the issue

closed," Unocal said in a letter. However, sources in Petrobangla said, the US oil giant expressed its willingness to sit anytime to discuss the matter.

Unocal in the letter said that in assessing the commercial viability and any additional capital in the Moulvibazar field, it must also be satisfied that its entitlement to cost recovery will be properly and promptly agreed upon and discharged and that there should

absolutely be no default in this respect.

The OBL (Occidental of Bangladesh taken over by Unocal) is again concerned that the experience to date indicates only extremely poor prospects for this. This view will not, we anticipate, change unless, at least the associated cost recovery pool date is agreed upon by OBL and

At least five more dengue patients were admitted to different city hospitals and clinics yesterday. According to the Directorate of

Health, at least seven people died of

dengue in different city hospitals since July 1. Of them, six died at the BIRDEM hospital and one at the Dhaka Medial College Hospital (DMCH). According to government estimates, a total of 193 dengue

patients were admitted to different hospitals and clinics across the country during the last 24 days. Of them, only three patients were admitted to hospitals outside Dhaka. Doctors said the number of dengue patients has suddenly

surged since June. They also expressed concern as a large percentage of the patients have been contracted with haemorrhagic dengue fever (HDF). According to unofficial estimates, the number of dengue

patients admitted to different hospitals and clinics since July 1 through out the country is more than 200. The control room of the health

directorate said last night that a total of 26 dengue patients were being treated at different city hospitals and clinics till last evening.

A total of 75 patients have been admitted to the DMCH since

Dengue strikes back Surge in rivers spurs flood

One person named Mahbubur Rahman, 30, of Joydev Village in Rangpur, drowned in floodwater Tuesday, when he was recovering some bundles of jute from the Manosh River.

Floods have taken on an alarming edge, as major rivers across the country are continuously surging.

Our Sylhet Correspondent said the water level in almost all rivers in the district crossed the danger mark. The Surma flows 119cm at Kanaighat Upazila and 56cm at the Sunamganj town above the danger mark. The onrush of waters coupled with rains has spurred floods in at least

six upazilas. The Kushiyara was flowing 117cm above the danger level at Amolshid

in Zakiganj Upazila yesterday. The floods in Kurigram took a menacing turn due to continuous swell-

ing of the Dharla and the Brahmaputra. Vast areas in Chilmari, Roumari, Rajibpur and Kurigram Sadar went

under water. The Ghaghot in Gaibandha flowing much above the danger level has inundated new areas in Fulchhari, Shaghata, Sundarganj and Gaibandha

In Jessore, the flood situation deteriorated following heavy rainfalls over the last two days. Rising waters of the Kapotakkha left about seven

The district administration distributed only 20 metric tons of rice and Tk

10,000 among flood victims. Our Rangamati Correspondent said the water level in the Kaptai Lake

rose further, as waters are rolling down from the hilltops round the clock. In Khagrachhari, torrential rains accompanied by the onrush of water from upstream submerged the lowlands in the district, leaving thousands

of people marooned. Merung Hazachhara in Dighinala Upazila has been inundated, leaving about 100 families confined to the camps for flood victims. Downpour and rising waters of the Chengi triggered erosion.

Our Habiganj Correspondent reported that the overall flood situation in the district was improving as the water level in the Khowai climbed down. The river is flowing 40cm below the danger mark.
