Probe body on SN Hall incident starts functioning

The inquiry commission, formed by the government to investigate the entry of police into Shamsunnahar (SN) Hall of Dhaka University and arrest of female students, began its work yesterday.

The commission requested those who were involved or concerned with the incident or who witnessed it to submit their names and addresses to its temporary office by July 31 for giving evi-

It asked the people interested to submit written statements on the incident to contact it by the

The one-member probe body of Justice M Tafazzul Islam would investigate to find out in which situation police entered the hall and whether the activities of the people concerned with the incident were lawful or not.

The contact address of the commission is: deputy secretary of the primary and mass education department, Room No 307, National Academy for Education Management (NAEM), adjacent to Dhaka College.

The deputy secretary has been given the secretarial responsibility of the commission.

Book bungling again

'Irrelevant, unnecessary' materials for primary students

Yet another move is underway to spend Tk 15 crore for buying 'irrelevant' books, this time for primary level

According to sources, the Directorate of Primary Education is going to purchase over 600 books for primary school libraries across the country. Sources said the books, which were selected by a committee, are mostly 'irrelevant, out of context and unnecessary'.

The Tk 24 crore project has been funded by the World Bank (WB) and the Asian Development Bank (ADB) and aims to stir creativity and imagination among

But most of the books on the new list for the 6-10year old children include are on poultry raising, shrimp culture, political lyric, love and many irrelevant tropics. Some of the books have nothing to do with the concept of the project, the sources said.

The committee earlier finalised a list to procure books worth Tk 9 crore, money for which was to be provided by the ADB, for thana model primary school libraries at Khulna, Rajshahi and Barisal divisions.

Now the authorities floated a tender yesterday to procure the same list of books worth Tk 15 crore for thana model primary schools at Dhaka, Chittagong and

Many of the listed books have not even been published as yet and authors of these books are activists of the ruling BNP.

As many as four books by one Amirul Islam Kagoji, a reporter of a ruling BNP mouthpiece, were included in the list. Kagoii's "Shera Monishir Jiboni (Life of the great

man) priced at Tk 550 is yet to be published. Most of the books were selected not by merit but by affiliation of the authors with the ruling BNP, the sources

The selection committee selected biography of Kazi Nazrul Islam and Rabindranath Tagore for juvenile by a homeopath doctor, B Hossain alias Badsah Hossain, by setting aside works of many famous writers.

Another committee recently selected as many as 52 books on late president Ziaur Rahman and Prime Minister Khaleda Zia for public college libraries. Of the 674 books on the list, many are on Islamic ideology. The selection committee ignored the very thrust of the project on the spirit of the country's liberation struggle and

The education ministry despite press reports on the issue has done nothing to address the gross irregulari ties, saying that the books were "appropriately

Tanguar Haor not cared for

Even two years after declaration of the Tanguar Haor in Sunamganj a Ramsar Site, implementation of the proposed Nature Conservation Project to preserve the flora and fauna of the 20,000-acre water body is not in sight.

The haor, the biggest natural sanctuary for birds and sweet water fish in the country, is being plundered for the last two years while the government is also being deprived of huge revenue. There are about 140 species of fish in the haor and a large number of guest birds also come here during winter.

declaration and lease the water body as was done earlier, it was learnt.

After declaration of the haor a Ramsar Site in January, 200, a Ramsar Charter was signed in the same

A Norwegian government delegation at a meeting in Dhaka in June last year agreed to finance implementation of the Nature Conservation Project. But there has been no progress so far in this regard, official sources in

After a long tug of war between the environment and the land ministries over ownership of the haor, the authority was finally vested with the environment ministry in February last year

A nine-member committee headed by the Sunamganj Deputy Commissioner was formed to lease the water body under certain new terms and condition to preserve the flora and fauna and to develop fish resources. The district administration floated tender on January 15 and on March 7 -- but t was stalled by an order from the environment ministry, the sources said

Environment Minister Shahjahan Shiraj visited the Tanguar Haor and later held a meeting at the ministry on May 30 this year. The meeting decided to create 'eco-SEE PAGE 11 COL 1

Lawyers criticise addl judge appointment

The government's decision on Saturday to appoint 11 additional judges to the High Court division has triggered strong resentment among senior lawvers who termed the appointments politically motivated.

The lawyers under the banner of the Sanmilitya Ainjibi Shamannaya Parishad (SASP) yesterday urged the chief justice to refrain from administering oath to the additional judges.

The lawyers further demanded confirmation of three judges who were earlier recommended by the chief nent cannot judge without confirming appointments of these three.

Those who were appointed additional judges on Saturday are Deputy Attorney Generals Abdul Awal, Barrister Tarique-ul-Hakim and Mizanur Rahman: Supreme Court lawyers Mir Hasmat Ali, Mashuk Hossain Ahmed, Sharifuddin Chakladar, Syed AB Mahmudul Haq, Salma Masud Chowdhury and Abdus

Meantime, the senior lawyers have alleged that the appointments of the three judges were not confirmed despite recommendation by the chief justice only because they were appointed during the Awami League In two separate meetings, the SASP and the bar

association observed that the government appointed the 11 judges ignoring an earlier assurance that the prime minister would hold a meeting with senior lawyers to resolve the on-going crisis over the appointment confirmation of the three judges.

They said the government would now have to shoulder all responsibilities in case of any untoward incidents. Talking to The Daily Star, Supreme Court Bar Association President Ozaer Faruk said, "The appointments of the 11 additional judges are politically moti

In a joint statement yesterday, 127 teachers of Dhaka University demanded immediate reopening of the varsity.

They noted with deep concern that when the protesting students called off their indefinite strike programme considering the congenial atmosphere of the institution, the DU VC took the unilateral decision of closing down the university sidestepping the syndicate.

The DU teachers protested the authorities' move to spoil the academic life of the students by turning the campus into a safe harbour of

HC rule baffles **NBL**

The National Bank Limited (NBL) is in a fix over the interpretation of a court verdict, which endorsed a Bangladesh Bank (BB) order, to strip one of its directors from office.

The BB had issued the notice on the NBL Director AKM Abu Taher in 1995 and again in 1998 for a default loan for which he was the guarantor. Taher went to court challenging

the BB order, taking the issue through different stages in the court of law since 1995. Recently, the Appellate Division

of the High Court on July 8 gave the final verdict, on the civil appeal filed by Taher, to vacate his post as the director of NBL. The court in its verdict said the

post "had ultimately been vacated, with the expiry of two months from September 9, 1995 when the notice under Section 17 of the (bank com-

Form the time the BB served the notice Taher never relinquished his directorship. In fact, he was re elected to the board twice in 1999

and 2001 and continues to serve. Along with Taher, who is also a lawmaker of the Jamaat-e-Islami, two other directors of the NBL also went to court receiving the same notice from the BB.

The court finally gave its verdict on three civil appeals filed by the three NBL directors on July 8, allowing the appeal of two directors and dismissing the other director, AKM Abu Taher.

The verdict means Taher's directorship would be left vacated for one year as per Section 17 of the Bank Companies Act.

The NBL however, is yet to take any decision regarding the fate of the director. Also the central bank's SEE PAGE 11 COL 7
