# Clamour for blood, beds

Desperate search for platelet, clinics send back patients

The dengue-struck city is going crazy over platelet crisis. And the situation has turned even worse as most clinics have run out of beds to take in new patients

The Bangladesh Red Crescent Society (BRCS) is now swamped by hundreds of people who need an emergency supply of platelets to save their dear ones down with dengue haemorrhagic fever (DHF).

The BRCS is supplying around 100 bags of lifesaving platelets, while the demand is three times

donors," said a BRCS official. "Supply of fresh blood is running out and we are left with little to cope with the

Platelet is needed for the treatment of DHF, the critical stage of the dengue infection. At this stage, blood becomes thin and as a result. it leaks from various organs of the body, sending the patient into a shock. The recovery rate from such a shock is rare.

Officials predict that the demand for platelets may rise even more with the rise in dengue infection.

Meantime, seven dengue patients have been admitted to the DMCH, four to the Shishu Hospital, five to the Mitford Hospital, three to BIRDEM, four the Bangabandhu Sheikh Mujib Medical University Hospital, one to the Government Employees Hospital and 30 to different private hospitals and clinics

## Five get life term for killing Tayebi

#### Main accused goes scot-free

The metropolitan sessions judge court Monday awarded life-term to five people for the murder of the Indian citizen Jibran Tayyabi in 1999. The court, however, acquitted three of the accused including the prime suspect Yeasin Rahman Titu as the court felt "the prosecution failed to establish the charge under section 302/34 of penal code against him (Titu) beyond shadow of all reasonable doubts by the evidence so far adduced."

Metropolitan Sessions Judge Fazlul Karim delivered the 97-page verdict before a packed courtroom for nearly

two hours that sentenced five people to life imprisonment. The convicts, aged between 24 and 33, were Osman alias Mohammad Osman, son of Solaiman of Doulatpur village, Ali Akber alias Didarul Alam, son of Jayedul Haq of Harin Khain village, Zillur Rahman, son of Haji Shaheb Mia Sawdagor of Assia village, Zahid Hossain alias Kiron, SEE PAGE 11 COL 4

## Not probing enough

Committee under fire for not collecting samples from rotten lots, skipping suspect silos

A day before filing its report on alleged wheat scam, the food ministry-formed probe committee has come under fire for not collecting samples from rotten lots and not inspecting some granaries which allegedly purchased feed-grade

Meanwhile, a day after issuing instruction for maintaining a status quo in wheat stocks in all public silos, the one-man secretarial probe body formed at the prime minister's directive left Dhaka for Bogra yesterday on a fact-finding mission.

Secretary in-charge of civil aviation and tourism ministry Shafiqul Islam, who heads the oneman probe body, would inspect silos in Bogra and Pabna today and tomorrow to probe the alleged wheat scam.

Earlier on Sunday, Islam clamped restrictions on transfer of wheat from one silo to another in the interest of an in-depth investigation. Meantime, the food ministryformed four-man probe committee SEE PAGE 11 COL 1
