## Foggy DCC fogging

#### Patients pay high for blood cell separation; 94 more infected with dengue

The Dhaka City Corporation's (DCC) fogging campaign to kill aedes mosquito has proved futile to fight the dengue outbreak, with most areas still to see any DCC man on operation.

Many residents in various areas termed the campaign an 'evewash'. And meantime, 94 more dengue patients were admitted to different hospitals and clinics vesterday.

"We are surprised by the DCC's inaction. They know that aedes mosquitoes exist in large number here, but we have not noticed any fogging," said one housewife in Jhigatala.

Banani, where the aedes mosquito larvae was found at an alarming level, remains virtually

untouched by the DCC campaign. "I have not seen or heard any fogging machine," said Mrs Jubair Hossain, a resident of Road No. 13


Manju Ara Rahman of Hatirpul also said there had not been any insecticide spraying there.

Residents in Lalbagh, Islampur, Bongshal, Kalabagan, Banani and Gulshan said whatever fogging was done there was mostly confined to the houses of government high officials and ward commissioners.

The ward commissioners appear on the spot only when there is a TV camera," said another



resident at Gulshan.

Meantime, for the attendants of dengue patients, money and luck are two factors to get hold of the lifesaving platelet

Hundreds of people are thronging the Bangladesh Red Crescent Society (BRCS) blood centre, private blood banks and other diagnostic centres for platelet.

The government and autonomous facilities in the city are proving totally incapable to provide emergency facilities.

Taking advantage of the panic and crisis, some private blood banks are making windfall by selling platelet for as high as Tk 10,000 a bag.

At the same time, people are crowing the private diagnostic centres for dengue confirmatory test costing around Tk 700 to Tk

None of the government hospitals in the city including the DMCH have facilities to test for dengue and as a result, patients admitted to these infirmaries are now forced to do the tests outside

In the face of the emergency, the Sandhani Blood Centre, an institution with 14 units across the country run by medical students, started separating platelet from blood for SEE PAGE 11 COL 4

#### 7 cops sued for July 29 assault on DU teachers, students

### Secretarial probe also detects wrongdoing

The one-man secretarial committee, formed to probe into the alleged wheat scam, has also found imported wheat in government silos and seized two sacks with Punjab Agro Industries Corporation of India seals.

The committee, headed by Shafiqul Islam, secretary-in-charge to the Ministry of Civil Aviation and Tourism, collected samples from six Bogra granaries and gave its preliminary observation at a meeting at the district circuit house yesterday.

Islam's is the highest-level probe body formed so far to look into widespread allegations of feed-grade Indian wheat purchase instead of home-grown foodgrade wheat during the 135-day countrywide internal procurement drive that ended on July 31.

The committee, formed on August 10 at the prime ministerial directive, is scheduled to submit its report by August 25.

Two other bodies have also probed into the Wheatgate. The Ministry of Food committee is to submit its report to Food Minister Abdullah Al Noman today while the Directorate of Food investigation committee was suspended on Saturday.

In another development, transfer of insect-infested 900 metric tonnes of wheat from Khulna to Barisal was suspended yesterday at the intervention of a ruling party lawmaker. Also, more than 600 metric tonnes of wheat were stolen from a public godown at Khulna.

Murder muddles manpower

Manpower export to Malaysia is under a renewed threat following the killing of a female university student in that country allegedly by an expatriate Bangladeshi worker.

The worker - Shamim Reza - stormed into a house in Shah Alam area and stabbed to death 19-year-old Juriati Osman, a student of the University of Technology in Mera, on Sunday night. He was caught and handed over to police, according to a message received from the Bangladesh Mission in Kuala Lumpur.

The motive behind the killing and details about the worker could not be known immediately.

The news of the killing quickly spread all over Malaysia and created anger among the people
