M-16 link another conspiracy, says Hasina

Awami League (AL) President Sheikh Hasina yesterday said police implicated five AL leaders in an arms possession case upon an instruction by the ruling party high-ups.

"It's part of a conspiracy by the four-party alliance against the opposition," Hasina said in a statement. She also said law enforcers are

harassing her party members since the ruling party's assumption of power and urged the government to stop repression on opposition leaders and activists.

On July 4, the Detective Branch of Police arrested four persons and seized an American-made M-16 rifle at Uttara in the town.

The arrested are Shafiqul Islam Lablu, Zahirul Islam Russel, Fazal Rabbi Sufal and Abdur Razzak Khan. Lablu and Russel confessed in SEE PAGE 11 COL 3

600 tonnes of wheat stolen from Khulna silo

More than 600 tonnes of wheat have been stolen from the Khulna central food godown, sources said.

The food ministry in a letter on July 30 asked local officials of food department to supply 4500 tonnes of wheat to carrying contractors by August 7. But till August 11, only 2106 tonnes were supplied. The godown now has a wheat stock of 639 tonnes, the sources pointed out.

One source however said the shortage would be more than 1000 tonnes if the stock is checked immediately. Carrying contractors have

alleged that officials of the godown were not allowing them to take delivery of the rest 2306 tonnes of wheat although they produced necessary documents for this.

"This is because of the shortage of stock due to theft committed in h a section of officials o local food department," one source said seeking anonymity. Carrying contractors said they are suffering financial loss due to non-supply of wheat within the stipulated time. They also alleged that wheat supplied to them was of low quality, purchased during the procurement drive. When contracted, Manager of the godown Biswas Zafar Ahmed however said there is no shortage of stock. But he admitted allegations of theft and said the entire godown area is insecure with thieves and pilferers having easy access.

The central bank investigation has also found out that the NCCBL, One Bank and Dhaka Bank sanctioned Tk 114 crore to Agarwal in direct loan and other facilities. Of Tk 23 crore sanctioned as direct loan, only two crore was for Agarwal and the rest for fictitious accounts. When asked whether there

The investigation teams are When asked whether there going through papers of eight would be any action against man-

agement of these banks for sanctioning loans to fictitious accounts, the central bank governor said, "We are probing the issue. Once we complete the investigation, we will decide what can be done."

"The investigation is now not only confined to the loan sanction process but also to find out whether there is any foul play in withdrawing cash assistance and whether the people in question have any connection with hundi transactions," Ahmed added.

Disclosing the preliminary findings on Agarwal, Huda said, "We have started the second phase of our investigations to find out whether the process of loan sanctions was right and whether the loans were sanctioned against proper security. Also we will try to find out whether there is any connection with hundi."

Plunderers shave Ong Ong Off savings

Speakers at Prothom Alo-EBL roundtable also blame poor public confidence

Speakers at a roundtable discussion yesterday said plundering of people's money by the wealthy section of the society is responsible for the low growth in savings and investment in the country.

They said the savings rate remained very low due to lack of proper savings instruments and people's confidence on banks and financial institutions.

They also blamed a section of businessmen and industrialists for siphoning off people's money instead of investing it in productive sectors.

The speakers underscored the need for good governance in the economic sector for bringing discipline and boosting savings and investment in the country.

They urged managements of banks and financial institutions to expand their network and bring rural people into various savings schemes.

The roundtable was jointly organised by prominent Bengali daily Protham Alo and Eastern Bank Limited (EBL). It was held at Hotel Sonargaon.

Khondoker Ibrahim Khaled, managing director of Pubali Bank Limited, presented a keynote paper titled "Savings is the Ladder of Prosperity".

Bangladesh Bank Governor Dr. Fakhruddin Ahmed, renowned economist Prof. Muzaffar Ahmad, former advisors of care taker government Rokya Rahman and Dr. Wahiduddin Mahmud, economist Prof. Abu Ahmed, Prof Amirul Islam, BIDS research fellow Rashidan Islam, managing director of Mercantile Bank M Taher Uddin, managing director of EBL K Mahmud Sattar former BAIRA president Mohammad Noor Ali, President of Foreign Investors Chamber of Commerce and Industry Wali Bhuiyan, Mirza Azizul Islam, Chief Executive officer of Chittagong Stock Exchange Waliul Maruf Matin and Nasir Hossain of EBL took part in the discussion.

Protham Alo Editor Motiur Rahman moderated the discussion.

Prof. Muzaffar Ahmad called upon the authorities concerned to train small savers to build entrepreneurs

from among them. This will boost savings and investment. He said the actual savings rate in the country is much higher than the official rate. "The bounded acting is 7

higher than the official rate. "The household saving is 7 to 8 per cent but if we consider the non-monitory sector, the savings rate may go up to 30 per cent". The official savings rate is not increasing because

The official savings rate is not increasing because people have lost their confidence on the savings system.

Dr. Wahiduddin Mahmud said although there is no specific statistics, it is assumed that a huge amount of money is siphoned off the country regularly.

Those who earned crores of taka through smuggling, taking bribe, loan default and corruption are mainly responsible for siphoning off capital.

"This is not a problem of market economy. Rather, it is related to good governance of the economy."

Wahiduddin Mahmud alleged that big businessmen and industrialists in the country often abuse people's savings instead of helping capital formation.

Hundreds of sick industries and loan defaulters prove this.

On the other hand, those who did not invest significant amounts of bank money, ultimately plundered people's savings.

Bangladesh Bank Governor Dr. Fakhrudin Ahmed underscored the need for strong corporate governance in the financial sector.

He regretted that 'criminals' in the financial sector were never sent to jail in our country for plundering people's money. Loan defaulters are more powerful than managements of banks and financial institutions.

He blamed the government and the officials concerned in the banking system for loan default. He emphasised self-imposed discipline among the officials to improve the situation.

He said there is a section of people, mainly the middle class, who do not take loan either from micro creditors or

Govt to seek offers from more cell cos in Nov

The government will invite more cellular phone companies in November to start mobile phone service. Moreover, private companies will also be invited to set up fixed line telephony in April 2003.

"This will revolutionise the country's telecommunication sector in line with the prime minister's recent announcement to open up the sector to private investors," Syed Marghub Morshed, chairman of the Bangladesh Telecommunication Regulatory Commission (BTRC), said at a press conference at his office yesterday.

"The licences will be awarded in a transparent way to bring dynamism and competition in the sector," Morhsed said.

He said there is a huge potential for development of the telecommunication sector in the country, as the regulators want to provide more telephone access to people.

He said the state-owned Bangladesh Telegraph and

Telephone Board (BTTB) would facilitate other operators since it has a huge infrastructure, skilled manpower and experience.

He said the mobile operators now largely provide mobile-to-mobile connections without access to the fixed line network.

"To resolve this problem, the BTRC would ask the fixed line service provider, the BTTB, for an engineering audit to find out how the mobile operators can get access to its network," he said.

Morshed said the Canadian CIDA has come up with a technical assistance to assess telecom frequency and recommend spectrum management in cooperation with the Infrastructure Investment Facilitation Centre (IIFC). He said the BTRC has already given permission to three companies -- Grameen Shakti, Rangs IT and Square Informatics -- to transfer data through satellite. SEE PAGE 11 COL 8
