Donors find CHT calm, ready to inject funds

A joint assessment mission report on the Chittagong Hill Tracts (CHT) yesterday revealed that the prevailing law and order situation in the majority of areas in the region is sufficient for resumption of development assistance.

The 78-page report said donors are now ready to provide financial and institutional support to economic and infrastructural development in the CHT

The mission comprising representatives of the government and donor agencies under the United Nations Development Programme (UNDP) reported that the level of donor assistance stopped in the CHT following the abduction of three international road engineers on February 16 last year.

The foreigners working for DANIDA were abducted from Rangamati. The victims, however, were rescued unharmed after a

month of hostage.

"The incident prompted many development organisations and donor countries to cease their development work in the CHT." Michael Heyn, leader of the mission told reporters at a function in the city vesterday The report said kidnappings

and extortion of development workers have continued, though on a reduced scale, mostly due to regional party conflicts and fundraising through illegal toll-taking.

Tribal and non-tribal differences. unresolved issues relating to land. elections and the law and order situation continue to create tension and the potential for conflicts. However, the mission recom-

mended an immediate restart of development activities under all but one of the 27 police stations of the CHT

The mission carried out an 11day assessment from June 1 and talked with a wide spectrum of


people, including administrative officials, in all the three hill-districts to prepare the report

The objective was to assess and provide an overview of risks and physical safety and security of staff - Bangladeshi or expatriates -- who may visit or be stationed in the CHT for development work.

Earlier, the government and the UNDP agreed in May to review the safety and security of local people and foreigners and the possibilities of renewed development assistance after the donor community recently showed interest in resuming development assistance to the CHT

"The reason for the mission stems from the fact that many of the Bangladesh's development partners are ready to resume and, in some cases, increase their socioeconomic development assistance t o

Ministry probe buys 10 more days

Burdened with 160 different wheat samples collected from granaries across the country, the Ministry of Food committee, now investigating the procurement scam, could not submit its report yesterday and has sought ten more days to complete the task

Chemical tests of the samples at the laboratory of the Directorate of Food would take some time, forcing the committee to ask for extension, Yakub Ali, who heads the four-man probe body, told The Daily Star yesterday.

Some truth in reports on wheat scam

Food Minister Abdullah Al Noman has acknowledged that there is some truth in media reports over the last two weeks on the wheat procurement scam. "I cannot claim that there is no basis for the reports." he told The Daily

Star at his office yesterday. However, the minister refused to say anything more on the issue lest it be

interpreted as interference in the ongoing investigations.

When asked about his recent visit to a silo at Pabna and his subsequent claim that the wheat stocked there was of good quality, Noman said, "No interference was meant. I just said the wheat in that particular Pabna godown was not poultry feed and consumable. I did not certify all wheat stocked in public granaries across the country."

Official security for Hasina restored

UNB, Dhaka

The official security for Opposition Leader Sheikh Hasina was restored yesterday,four days after it was withdrawn.

Special Branch (SB) withdrew four of its men on August 10, out of eight, who were engaged in the security of the former Prime Minister

The SB car, which was in the motorcade of Sheikh Hasina went to her residence at Dhanmondi vesterday morning, an SB official said.

The secretarial committee is likely to recommend that the government should not allow any wheat procurement after the May-June period when possibility of getting local wheat is low.

The committee might also recommend that rules and regulations for internal wheat procurement

Some Supreme Court judges' being apathetic and embarrassed to hear the proceedings and the government's dilly-dallying over clearing off legal tangles have left the trial of should be more bold. killers of nation's architect

Mind-boggling it may appear when one considers the fact that the trial court took two years to deliver a verdict in the Bangabandhu Murder Case. And yet, it's going to take the Supreme Court no less than, and it may well be longer, five years to do away with it.

Rahman staggering all the way.

Plainly, the case stands no chance of finding its way to the cause list before February 2004 unless a judge is appointed to the Appellate Division on an ad-hoc basis. Five of the seven-men

Appellate Division are unable to hear the case when at least three judges

of the division are required Two former chief justices have reportedly said the judges felt embarrassed to hear the case without assigning any specific understandable reason and they

A glance at the headway the case has made to date should present one with the agonising tale of trial so

far. Of relevance, it has been twentyseven years since the nation's independence leader was slain along with much of his family while holding the highest executive office.

The trial court delivered a verdict on November 8, 1998, only two years after the case was filed. The judgement ruled that fifteen former army men are to die for the carnage

in a military putsch on August 15, 1975. The killers remained immune to

prosecution for twenty-three years, thanks to the infamous Indemnity Ordinance legalised through a constitutional amendment in 1979.

Appalling yet is the fact that as many as six justices have expressed their embarrassment to hear the case in no more than two years. The first precedent in this case was set when a High Court Division judge felt embarrassed to hear the death reference confirming the verdict of the trial court. Later, two more judges followed suit. Earlier. the case was refused by benches five times. However, the High Court disposed of the case in April 2001, convicting 12 of the 15 accused to death.

DENGUE ALERT 123 more infected

Platelet crisis still runs high as more and more dengue patients poured into hospitals in the city vesterday

Some 123 more people infected with dengue have been admitted to hospitals. The official figure however put the number at 87. The total number of infected people since January this year stands at 1950 with 25 deaths so far.

At the Red Crescent Blood Centre at Mohammadpur, 55 people collected platelet while 30 more were on the waiting list till 7pm yesterday

But according to the centre officials, the figure was feared to exceed 160 by midniaht.

"I was referred from the Dhaka Medical College Hospital to collect one bag of platelet. My niece has been diagnosed with dengue haemorrhagic fever and her condition is stated to be quite critical," said Sufia Begum.

Md Didarul Alam, an attendant of a patient at Nibedita Children's Hospital, said his nephew's platelet count had reached 20,000.

Meanwhile, the government has not yet taken any move to arrange separation of blood cells in most of the hospitals where a large number of dengue patients have been admitted.

Many patients complained to The Daily Star that simple diagnostic tests like blood tests and platelet count had to be done from outside

"The government does not reckon dengue outbreak as a problem," said SEE PAGE 11 COL 1
