# Six CPM men shot dead in West Bengal

An indefinite curfew was imposed on a town in West Bengal yesterday after militants shot dead six members of the ruling Communist Party, police said

West Bengal Police Inspector General Chayan Mukherjee said six militants, armed with sophisticated weapons, raided the party's committee office in Dhupguri town, 550 km from the state capital, Kolkata, on

Mukherjee told AFP the militants, who arrived on three motorbikes, sprayed the cadres with bullets, killing four on the spot, while two more died in hospital on Sunday.

"The militants carried AK-47 and AK-56 rifles, and they threw a number of high-powered hand grenades to cover their escape," he

### Murders at Tejgaon

Nizamuddin Bhuiyan, an industrialist, Dinesh Chandra Sen, an assistant sub-inspector of police and Abdul Khandakar Harun, a smalltime trader, on Saturday afternoon.

Alauddin and his younger brother Mohammad Raqib had a gunfight with the police. Later, they were caught from a waterbody and beaten to death by a mob at Khilaaon in the evenina.

Police carried a manhunt in different parts of Tejgaon and arrested Shadat Hossain, a local youth, and Fazilatunnesa. a local resident, on Saturday night for their alleged involvement in the killings. Police recovered a bloodstained shirt of Alauddin from the residence of Fazilatunnesa. Police also picked up Minu Begum, the criminal's first wife, and his mother Samosta Banu for interrogation.

Alauddin's younger sisters --Parveen and Yasmeen -- admitted to newsmen that their brothers were engaged in extortion and other criminals activities. His father, Tara Miah, is a former employee of the Teigaon Polytechnic Institute

Local people claimed that the Teigaon police were not sincere enough to check criminal activities since they received huge amount of money from the underworld. Although several people were killed in the last few years, police did not take any initiative to improve the law and order situation

Locals said Alauddin and his brother would have gone scot-free this time again had a police officer not been killed. Witnesses said plainclothes men beat up Alauddin and Raqib to death at Khilgaon. Locals said Alauddin used to pay
