# DAP projects zapped

### Govt braces for Japanese ire to protect nat'l interest

Protection of national interest reigned over concern for deterioration of relations with the largest bilateral donor as the government cancelled two diammonia phosphate (DAP) fertiliser projects on Chinese and Japanese suppliers' credit

The Bangladesh Chemical Industries Corporation (BCIC) informed the Japanese and Chinese contractors of the decision on August 17. The policymakers finally opted for the decision, convinced that the pro-

jects would have put a huge financial burden on the country, sources said. The Japanese were not happy and said it could have an adverse impact on business relations between the two countries

The fertiliser projects - Tk 392.97 crore DAP-1 and Tk 451.70 crore DAP-2 - were undertaken last year on Chinese and Japanese suppliers' credit. Had authorities gone for implementation of the projects, production cost

of fertiliser would have been Tk 12,374 per metric tonne (MT) at the DAP-1 and Tk 12,228 per MT at the DAP-2. Import cost of di-ammonia phosphate

Earlier on August 8, Japanese Ambassador to Bangladesh Jiro Kobayashi wrote to Finance and Planning Minister M Saifur Rahman that his government "is concerned that the cancellation of the project will affect adversely business relations" between the two countries

"As a result of the cancellation of the project, when the claim for compensation regarding the project is submitted to the government of Japan from the Japanese contractors and the insurance is paid, it is highly probable that the Japanese government will take an action to stop accepting new export and insurance regarding business activities with Bangladesh," the Japanese ambassador wrote.

In the first week of January, the Ministry of Industries prepared a proposal to cancel the project. However, the decision was delayed by a long time in the face of strong lobbying by a quarter, sources said.

"Due to the delay in decision making, we have to pay more as compensation to the contractors," said a government source.

On July 17, the issue was raised at a meeting of the cabinet committee on economic affairs. However, the committee could not take any decision although all members but one were for immediate cancellation of the pro-

According to sources, one influential minister got in the way of the committee making any decision at the meeting.

Earlier, Saifur said the government had not approved the two DAP fertiliser projects as "we thought it might create a situation like KAFCO's and a

### **Charge-sheet** in Bappi murder case today

The charge sheet in the sensational Rubayet Ahmed Bappi murder case will be submitted to the Chief Metropolitan Magistrate's Court, Dhaka, today, police sources said.

Bappi, a student of class III of Armanitola Government High School, was abducted by his cousin Shipon on August 5 and taken to

Failing to realise a ransom of Tk 20 lakh from Bappi's father, Shipon and his four accomplices -- Ripon, Sankar, Sanjit and Sharif -- strangled the child and dumped the body into the river Shitalakhya the same eve-

The decomposed body of Bappi was recovered from the river after 10 days of massive search.

Police has so far arrested Shipon, Ripon Sankar, Jahid, Rafigul Alam and Hena Begum. Another accused,

#### Killers of Bappi won't be spared, PM assures parents

# Schoolgirl abducted, rescued at Rupgani Angry locals keep city road under siege for 3 hrs

Police rescued a Class X girl of a city school three hours after her abduction from the Badda area by six local

Thousands of angry locals, students and teachers of the school put up barricades on the Kuril-Badda Biswa Road as a police subinspector who was informed about the abduction minutes after the incident allegedly did not take any initiative to catch the abductors.

The barricade was later withdrawn as the police became active following the widespread protest and rescued the girl. Police also arrested six abductors including Zahiruddin, 26, Iqbal, 25, Badal and Sumon from Rupganj who were taking the girl with them on the

After the rescue and arrest, Badda police mysteriously remained tightlipped about the whole affair. Despite repeated requests, they refused to give out information about the whereabouts of the girl and her abductors

The girl aged around 16 was abducted in front of her school at

The locals who heard the girl screaming informed a police subinspector, Moklesur Rahman, about the abduction and requested him to chase the car. But the police officer told the people to contact the police

#### Khasru lashes out at Moudud

Former law minister Abdul Matin Khasru has accused his successor Moudud Ahmed of issuing untrue, cleverly phrased, self-contradictory and misleading statement about the Bangabandhu Murder Case.

Reacting sharply to Moudud's comments made to the press on Monday, Khashru said the government was not appointing an ad-hoc judge at the Supreme Court on one hand and blaming the lawyers on

"It's the jurisdiction of the president to appoint a judge on ad-hoc basis, but the president cannot do it without consulting the prime minister. Therefore, the prime responsibility of appointing such a judge mainly lies with the government, the former law minister said in a statement yesterday.

# Pebbles in rice found at Kurigram granary

The district administration of Kurigram has detected pebblemixed rice in a government granary in Nageshwari Upazila and sealed two rice-loaded sacks for further

The district administration sources claimed that the suppliers, in connivance with some food officials, mixed pebbles.

"I don't say the rice was of low quality, but there were pebble-mixed rice....we collected rice samples and requested the district controller of food (DCF) to look into the matter", said Mezbahul Alam, the deputy commissioner (DC) of Kurigram who also visited the

Talking to this correspondent over telephone, Quazi Nurul Islam, the DCF, who inspected the Nageshwari local supply depot (LSD) on Thursday, however, told that pebbles in rice sacks are common and in this case 'very negligible' in terms of quantity. "Besides, mixing pebbles would

not be cost-effective for businessmen because pebbles sell at higher price than rice", the DCF added When contacted, the Upazila Nirbahi Officer (UNO) of Nageshwari, Atiqur Rahman said the pebble-mixed rice was first detected during the distribution of rice among flood victims under the test relief programme Rahman said, "We just acted on

a complaint of Bamandanga Union Parishad chairman Mainul Hag Prodhan that the pebble-mixed rice was being distributed among his local people...and the chairman also informed us that the rice sacks had

the seals of Ahad Rice Mill. "

In a raid on the Nageshwari LSD the district administration officials found two sacks of rice, supplied by the Ahad Rice Mill, contaminated with pebbles. Several food officials. including the upazila controller of food, were also present during the

"There were large pebbles mixed in the rice and we sealed them off...such pebbles will not escape anybody's attention", the UNO said. In this season, about 10,004 metric tons of rice was procured against the target of 13,614 metric tons. Local rice millers, certified by the food department, usually supply rice to the granaries, official sources

Local people alleged that this year the millers bribed the food officials between Tk 1,000 and Tk 1,200 for getting allocation for supplying rice

# Govt opts for mid-course

12,500 two-stroke polluters to go off street on Sept 1: 5,500 to stay till Dec 31

Under pressure, the government has once again given concession to twostroke polluters by allowing 5,500 vehicles to ply until December 31, the deadline set by the High Court.

However, on the flip side, some 12,500 two-stroke three-wheelers out of the total 18.000 will be grounded from September 1.

As per the agreement signed vesterday between the Bangladesh Road Transport Authority (BRTA) and the Dhaka Auto-Tempo, Auto-Rickshaw, Auto-Truck Malik-Sramik Oikya Parishad, 5,000 two-stroke auto-rickshaws launched in 1995-96 and another 500 launched in 1996-97 will ply until December 31.

These vehicles have to tag special BRTA stickers on windshields from September 1. Besides, the body of every vehicle will be painted white with a yellow stripe. Sources said the government had

to backtrack on the previous decision due to inadequate preparations of the communications ministry for
