Tk 9cr power bill unrealised in Sherpur

Electricity bill amounting to Tk 9 cr have been lying unrealised in Sherpur under the Sherpur Divisional Power Development Board. Of the total amount, Tk 5 cr was lying outstanding in Sadar upazila alone. Power Development Board (PDB) sources said out of the target to realise Tk $2.20\,cr$, only Tk $1.82\,cr$ arrears were realised during the last fiscal.

Official sources said they snapped 855 connections for non-payment of bills amounting to Tk 45.75 lakh during the period. They also said they filed 13 cases and served 18 legal notices to subscribers for non-payment of bills of Tk one cr. It was learnt that some big defaulters remained out of official action due to their underhand deal with some

Postmaster sued for stealing visa

A case was filed against the postmaster and peon of Morichcha bazaar post office in Ukhia upazila for stealing a visa sent from Saudi Arabia. The case was filed against postmaster Meher Ali and peon Mohammad Yunus Bhulu on Thursday.

Police said Kamaluddin, son of Haji Syed Ahmed, who is living in Jeddah recently sent a visa for his younger brother by registry post in the name of his father. But Haji Syed Ahmed received the open envelope on July 24 and went to the postmaster and inquired about the missing visa but the postmaster and peon refused to give the same. C'nawabganj safe route for smuggling

Various frontiers of Chapainawabganj are being used as safe routes to smuggle gold to India. A section of jewelry traders with the help of transport workers and people in the bordering area smuggle gold worth crores of taka to India every month.

Women are considered as safe carriers to hand over the precious metal to the destinations at the Indian side. One carrier is not used repeatedly so that the members of the law enforcing agencies could not mark them. They even come from Dhaka via different routes as passengers. Khaserhat-Binodpur, Ranihati, Hayatpur and Sona Mosjid frontiers have become a safe route for smuggling gold to India.

Valuables worth Tk 5 lakh looted

Valuables worth about Tk 5 lakh were looted and 10 passengers injured in a robbery in a night coach at Alamkhali in Sadar upazila on Magura-Jhenidah road recently. According to a delayed report, a gang of robbers boarded the Dhaka bound night coach from Khulna on the night of July 27 and when the coach reached the point they beat the passengers indiscriminately and decamped with cash and valuables at gunpoint.

Katakhali canal in Healthcare in city corporation areas Sirajganj needs reexcavation

An environmental committee was formed in Sirajganj recently which is headed by the local municipality chair-

The new committee organised a press conference at the municipality and demanded immediate eviction of illegal land grabbers and re-excavation of the historic Katakhali canal

The committee also submitted a memoradum to Prime Minister Khaleda Zia who visited here recently to see the flood affected areas herself. In the memorandum the commitee demanded immediate reexcavation of the canal and removal of illegal occupiers. The committee sought it for the interest of healthy environment of Sirajganj town and its surrounding areas.

The land grabbers are also trying to establish their illegal occupation applying their undue influence.

It is worth mentioning that after the formation of the four-party alliance government, Sirajganj SadarAC (land) instructed the illegal land grabbers to immediately remove their unauthorised occupation. But after the lapse of three months no tangible action was taken till filing of the report due to reasons unknown to all.

The British government dug the long canal named Katakhali canal" which was connected with the Jamuna river. The British Government dug it for the preservation of environment and also for the interest of trade and

commerce. At that time Sirajganj was termed as second Calcutta because of its importance as a major centre for trade and commerce. Jute was the main trade of businessmen who used to run their business from here to Calcutta. British and Indian traders built many business centres on both sides of this 'Katakhali'canal

Labourers came here from Bihar and excavated this canal. Country-made boats, launches and steamers used to ply along this canal. Fish of different species were also available in great quantity at that time. The canal divided the eastern and western part of the district

So, the British governor Sir Illiot constructed a beautiful bridge over this canal which is called the Illiot Bridge or "Baro pool.'

In the decade of sixties the then President of former Pakistan Ayub Khan established Water and Power Development Authority (WAPDA) and built the Bramhaputra Flood Control Embankment stretching from Bera in Sirajganj to Kaunia in Rangpur. But now this canal is virtually dead as it has no connection with

After the liberation of Bangladesh some local influentials grabbed land of the canal and built residential and business cantres. But the officials concerned are indifferent to check the illegal activities. Now in fact there is no existence of the original canal



A culvert on Dhubaura-Goshgaon road in Mymensingh collapsed five years ago, but it is yet to be repaired. Local people suffer a lot, especially in the rainy season due to lack of a bridge.

Eco-tourism complex in Khagrachhari planned

Highway robberies are on the rise on Dhaka-Khulna highway as valuables worth about Tk 1 cr were looted from 10 night coaches on the road in last one month.

Police said over 100 passengers were injured during the robberies which took place in between Daulatdia ghat and Jessore.

On August 10, the highwaymen boarded a Khulna-bound night coach from Dhaka in the guise of passengers and looted valuables of the passengers when the vehicle
