The secretarial committee to probe the wheat scam submitted its report yesterday stating that in many cases government silos bought foreign wheat instead of homegrown one at the fag end of the 135-day internal wheat procurement drive.

Besides, the report also blamed four ruling BNP lawmakers and frontline local BNP leaders for wheat

purchase irregularities, sources said. A syndicate comprising some ruling party men and officials of the food ministry and food directorate was directly orchestrated the scam, the probe report noted.

Boy rescued, Tk 3.42cr forex Computer glitch haul at ZIA

Customs authorities at Zia International Airport (ZIA) recovered foreign currencies valued at Tk 3.42 crore from under seats of a Dubai-bound Biman flight just before its take-off on Monday night.

The currencies were being smuggled out of the country, customs officials said.

Acting on a tip-off, a customs team, headed by Joint-Commissioner Sultan Mohammad lqbal, searched the aircraft and recovered the currencies in two packets kept under seats 35D, E of economy class of the flight BG-025.

State Minister for Civil Aviation and Tourism Mir Mohammad Nasiruddin who was at the airport at that time ordered prompt action to find out the culprits and said whoever found responsible will be punished.

Passengers were yet to board the plane and only crewmembers were inside, customs sources said.

After the recovery, the customs officials asked the crew about it, but they kept mum.

"It is not possible to keep such a packet under seats without the knowledge of the crew," a top customs official later said.
