tomorrow to protest attack

Opposition Awami League has called a countrywide dawn-to-dust hartal tomorrow protesting the armed attack on party chief Sheikh Hasina's motorcade at Kolaroa in Satkhira.

AL Presidium member Abdus Samad Azad announced the programme at a hurriedly called press conference at the party's central office at Bangabandhu Avenue in the city yesterday after-

At the press conference, AL leaders strongly condemned and protested the attack. They alleged that ruling party cadres led by Rafiqul Mazhar, elder brother of BNP lawmaker in Kolaroa, launched the attack to kill Hasina.

Samad Azad said the decision to call hartal was taken at an hour-long emergency meeting of senior leaders at the party's central office after receipt of the news of attack.

"We have already informed all party units across the country and urged the leaders and workers to make the hartal a success", he said.

Samad Azad came down heavily on the BNP-led four-party alliance government and said it will have to bear the responsibility for the attack. "Such attacks on our party chief and other leaders and workers are on since the present government came SEE PAGE 11 COL 7

Private developers have filled up acres of low-lying land on the city's eastern fringe, flouting a recent government directive and relevant laws

Several hundred acres of lowland have already been filled up with many trawlers and engine boats carrying earth to the areas of the Banasree-Aftabnagar project of Eastern Housing Limited and Bashundhara project of East West Property Development (Pvt) Limited, local people said.

The developers have reclaimed these areas to expand their projects without obtaining Rajuk approval

Rajuk Chairman Iqbaluddin Chowdhury admitted that developers engaged in "illegal and unlawful moves."

Local people also alleged that the developers had employed different means to acquire lands from private owners.

Environmentalists and town planners have, meanwhile, expressed concern over such indiscriminate filling of lowlands and cautioned that this

Wrecks of sunken ships at the outer anchorage of Chittagong port and at different spots in the Karnaphuli river pose a threat to movement of ships to and from the port, sources

Ship operators find movement of their vessels risky because of the unsalvaged wrecks. The port handles over 1500 cargo vessels annually, mostly of foreign

Delay in dropping tender

raises fuel crisis fear

The BPC tendered for import of refined fuel oil worth around Tk 1,500 crore on May 16 this year. In the group A of the tender for the

supply of 1,210 lakh barrels of kerosene and 660 lakh barrel of iet fuel, the Axon-Mobil joint venture of Extep became the lowest bidder quoting US\$ 27.66 a barrel, while the Energy International quoted 21 cents more a barrel.

But the tender was cancelled and the BPC was directed to tender again at a meeting of the purchase committee on August 17.

Accordingly, a tender announcement was published in different dailies on August 21 with September 30 as the deadline for submission of tender documents

The import of fuel oil under the fresh tender may not be possible before October, the sources said. The ERL, the lone refinery in the

country, has been directed to continue the production of jet fuel. However, the ERL will be able to produce only one third of the demand that stands at 12,500 metric tons a day.

Meanwhile, BPC officials expressed concern over the OSD (officer on special duty) order for BPC Acting Chairman Babul Chakrobarty and transfer of BPC Secretary AH Khan to Sylhet.

The officials think the orders issued by the establishment ministry Sunday night are punitive measures for the controversial consignment of jet fuel

SAPTA meeting delayed again at Pak request

The final meeting of the fourth round negotiations of SAARC Preferential Trading Arrangement (SAPTA), scheduled for September 2-4 in Kathmandu, has been postponed again at the request of Pakistan, commerce ministry sources said.

Most of the SAARC countries took preparations to participate in the meeting to endorse a list of commodities for duty benefit among the seven SAARC countries. A four-member Bangladesh delegation was supposed to attend

It is for the second time that the within a span of four months at the request of the same country. The meeting was earlier scheduled for

A commerce ministry official said yesterday the ministry came to know about the decision in a letter from the SAARC Secretariat on Tuesday.

Pakistan said it could not take adequate preparations for the meeting and requested for shifting to the last week of December. However, no date has been fixed.

All the seven SAARC countries have already exchanged their 'wish lists'. In its 'wish list', Bangladesh has sought duty benefit for more than 100 items for export to each of

the six other countries. India has sought duty benefit for 369 items. Pakistan for 3064 items. Nepal for 1631 items, Sri Lanka for 248 items, Bhutan 156 for items and Maldives for 243 items to

ETV plans to file writ

The management of now defunct Ekushey Television may file a writ petition against the government for "enforcing" the court verdict on it.

"We will first consult our attorneys and seek their advice to proceed further," an official of ETV told The Daily Star yesterday seeking anonymity

The ETV management is frustrated the way the government "forced" it to shut its terrestrial and satellite transmission following the court verdict, he said.

At 10:50 pm on Thursday, ETV went off air through a formal announcement on its satellite band. Earlier, at about 5:00 pm on that day, BTV shut down ETV's terrestrial channel.

The ETV authorities had a plan to continue transmission on satellite band following the Supreme Court verdict, which upheld the High Court verdict declaring ETV's license illegal.

ETV had earlier applied to the Bangladesh Telecommunications Regulatory Commission (BTRC) for licenses for both its terrestrial
