## Benazir's nomination papers rejected, Sharif's accepted

Pakistan's election officials rejected yesterday former prime minister Benazir Bhutto's nomination to stand in October elections, saying she had been convicted of failing to answer corruption charges.

"She's been convicted by an accountability court. She's not qualified to contest elections," Ikhlaq Hussain Larik, the local returning officer in the southern town of Ratto Dero, said in announcing the deci-

A lawyer for Benazir, Avaz Soomro, accused the election authorities of "double standards" and said he would challenge the decision before an election tribunal.

Around 100 supporters of Benazir shouted angry slogans in protest against the decision.


Benazir, who lives in self-imposed exile in London, was nominated as candidate in two towns in her native Sindh province.

#### Anomalies in JU mark sheet

### Discord over appointment of alternative examiner

The Jahangirnagar University (JU) authorities and an examination committee of the JU are in sharp disagreement over the order for appointment of an 'alternative examiner' for checking a number of answer scripts for the second time, dropping the mark sheet prepared by the internal examiner.

The authorities gave the order following detection of gross anomalies in the mark sheet, sources said.

The examination committee for honours final examination of 1999 of the department of Government and Politics at a meeting on Monday refused to comply with the university authorities' order for appointment of an alternative examiner.

The order is not in conformity with the university examination rules 29 ordered appointment of an and appointment of an alternative examiner is not valid in the context of anomalies found in the mark sheet, it said.

"The examination committee does not agree to bear the responsibility of carrying out any order that is not in consistence with the university rules", it said in a letter to the JU authorities. If any such move is made, the authorities have to bear the responsibility, it added.

Results of the examination which ended on December 12 last vear have been 'stalled' for an indefinite period following detection of gross anomalies in the mark sheet prepared by the internal examiner, the sources mentioned.

The vice-chancellor (VC) on July alternative examiner, but he is yet to take any action against the internal

"The authorities do not even dare to question the internal examiner for the irregularities because she is very much influential", a senior teacher at the JU said, seeking anonymity.

A tabulator had first detected the irregularities while checking marks given by the internal examiner and the external examiner. In a letter to the VC on May 23, the tabulator said the mark sheet was full of over writing. Besides, the internal examiner submitted marks of 92 students although 91 students sat for the **SEE PAGE 11 COL 3**

# Pitfalls lurking on city roads

The city is bedeviled by multifarious problems gradually making it hard to live in. One such problem is the many hazards lurking on the city roads.

One such hazard is the large number of open manholes as their covers were stolen due to lack of proper vigilance by law enforcement. Such manholes present potential death traps for unwary road users particularly after dusk. Even during daytime, many city roads are flooded after heavy rain such that these open manholes are submerged and become indistinguishable. It is easy to understand the gravity of the risk which all vehicular and foot traffic are exposed to. Under the circumstances, it is of paramount importance to make sure that the essential covers of these manholes are protected at any cost.

Another serious hazard on the roads is posed by iumbo garbage containers placed along the roadside. Already under heavy strain due to the burgeoning traffic, the city roads are further constricted as these huge dumpsters take up considerable amount of road space. This makes it very difficult for vehicles to negotiate these obstacles, raising the risk of road accident. The most galling aspect of these dumpsters is that they are almost always full and garbage spills onto the road as city corporation's garbage trucks do not empty them regularly. The spilled garbage gives out violently nauseating stench all around, vitiating the surrounding environment

The other hazard is posed by the numerous rickshaws plying the city roads at night without any kind of light, which greatly raises the prospect of road accidents. In the event of power failure when streetlights

are out, this ominous phenomenon is all the more pronounced and greatly compounds the associated

Pedestrians in the city has increased to mammoth proportions and zebra crossings have been marked at road junctions and other convenient points to help facilitate movement of foot traffic. But the lack of civic sense about the importance of using these designated crossings is evident from the general tendency of pedestrians to make a dash for the other side of the road whenever there seems to be an opportunity Zebra crossings are designed for pedestrian safety but few seem to have the patience to wait for the goahead from the traffic police or the green light to cross over to the other side through zebra crossing. Many city-dwellers are unaware of even the rudiments of traffic rules and do not regard jaywalking as a violation of traffic rules. In this respect, it is important for the traffic policemen to enforce the use of zebra crossing in order to ensure better road safety.

Apart from zebra crossings, foot over-bridges have been constructed at different points in the city where there are no zebra crossings or where the traffic moves very fast. But once again, these overbridges are scarcely used by people who prefer risking their lives to taking the trouble to get on the bridge. These bridges have become the favourite haunts of a large number of hawkers doing brisk business in various merchandises. Beggars and vagabonds also take shelter there creating such an unwholesome environment that some pedestrians,

# Dengue strikes back, CCC yet to wake up

Though dengue has struck back, adequate preparedness programmes are not at hand and the Chittagong City Corporation (CCC) is yet to launch a massive anti-

mosquito drive. About 20 dengue patients were admitted to Chittagong Medical College Hospital (CMCH) so far. However, there was no death from the disease, hospital sources said.

The Chief Conservancy Officer of CCC when contacted said measures will be taken shortly to launch a crash programme to eradicate menacing mosquitoes. He said larvicides have been sprayed in drains and other mosquito breeding grounds.

surveillance committee formed last year has been reactivated and it is monitoring the situation. But other sources said the

awareness and keep surveillance are still maintaining a low key. The CCC finished its job by holding a seminar on dengue a few

days back and initiating publicity

through megaphones in different areas of the city. In that seminar, a decision was taken to open a 'dengue corner' in the city to provide 'first aid' to dengue patients and to send the 'serious' ones to CMCH. Ward

programmes in their respective

Talking to The Daily Star, CCC Mayor Mohiuddin Chowdhury said, "Initially we maintained a low-profile as the dengue situation in Chittagong is not so alarming as in Dhaka. Now we are trying to activate our people to launch dengue prevention campaign and awareness programmes. We have revived activities of the dengue committee".

CCC officials claimed that the dengue patients admitted to CMCH were possibly infected with the virus during their visits to Dhaka.

They also claimed that the recent heavy rainfall in Chittagong came as a 'blessing' and washed commissioners were asked to away the aedes mosquito larvae.
