Marwari businessman killed

A 'Marwari' businessman was chopped to death by miscreants in the Katgari area of Kishoreganj upazila in Nilphamari on Friday night.

The victim was identified as Hetla Marwari, 50. Police and witnesses said some criminals called Hetla out of his shop at dead of night and chopped him to death The cause behind the killing could not be known immediately.

Bhabesh Marwari, younger brother of the victim filed a case with the local police station. Police already visited the spot.

UP member beaten to death

A union parishad (UP) member was beaten to death in day light by the miscreants at village Char Dehunda in Karimganj upazila following previous enmity on Wednesday

Police and witnesses said the gang numbering 17/18 led by co-villager Fazlur Rahman abducted the victim Helaluddin, 45, a member of Dehunda UP, on his way to Kishoregani town in the afternoon. He was taken to Fazlur's house where the criminals beat him to death. On information when Helaluddin's father Abdul Mannan came to his rescue the miscreants also assaulted him grievously. Police later recovered the body and sent it to sadar hospital morgue for autopsy. Police Super of the district visited the place of occurrence. The criminals went into hiding

Decomposed body of girl recovered

The decomposed body of a young girl was recovered from a canal in Sadar upazila on Saturday

The victim was identified as Masuda Akhter, 20, daughter of Meer Hossain, o village Satswati

Police and family sources said some criminals abducted Masuda on Tuesday night when she came out of her house to respond to the call of nature. Later they slaughtered the victim after rape and dumped the body in Sahapur canal, Local people found the body floating in the canal on Saturday. Later police recovered the body and sent it to the hospital morgue for autopsy. Victim's elder brother, Noor

Housewife beaten to death

A housewife was beaten to death allegedly by her in-laws at East Sakhipur ir Sakhipur upazila on Friday night.

The victim was identified as Hamida Akter, 28, wife of schoolteacher Abdu Awal. Police said Hamida's in-laws hit her with hammer and beat her to death over a family feud. Later police arrested Abdul Awal, his mother and sister in connection with the killing. The body was sent to Tangail General Hospital morgue for autopsy

Gold bars, Bangladesh currency seized

UNB, Chapainawabganj

The Anti-smuggling Task Force seized 23 gold bars and Bangladesh currency amounting to Tk 7.50 lakh from a private car at Dariapur on Chapainawabganj-Raishahi road Wednesday.

Acting on a tip off, the team led by a magistrate intercepted the car at the point early in the morning and seized the gold bars and currency. The driver, however, managed to disappear from the scene. Earlier, contrabands including electronic equipment, wine, hemp and phensidyl worth Tk 8 lakh seized by the border guards in different raids were destroyed at Bangladesh Rifles (BDR) six battalion headquarters on Thursday in presence of local newsmen.

Two trucks with smuggled goods seized

Police seized two trucks loaded with Indian smuggled goods worth Tk 20 lakh from the Zamuki area in Mirzapur upazila on Dhaka-Tangail road on Aug 22.

Acting on a tip off, they raided the Dhaka bound trucks coming from Dinainui and recovered unauthorised huge medicine, spare parts, cumin and yarn. The drivers, however, fled from the scene. A case was filed in this connection.

Acid-attack on three of a family

Three members of a family including a female union parishad (UP) member received serious burn injuries in an acid attack by a gang of miscreants at village Sakua in Karimgani upazila on Wednesday night.

Police said the miscreants following a previous enmity hurled acid on Dehunda of night when they were asleep. They were rushed to the local upazila health complex and following deterioration of their condition they were shifted to sadar hospital where the condition of Ambia was stated to be critical. A case was filed in this connection accusing five people.

Two Hazari bahini cadres arrested

Police in separate raids arrested two cadres of Hazari bahini from the Sahdebpul area in the town on Friday-Saturday

The arrested were identified as Dildar of Dhumsadda village in Sadar upazila and Anil Chandra Banik of Sripur village in Fulgazi upazila. Police said they nabbed them along with a gun from the Sahdebpur rail crossing area. Both were wanted in a

Cotton farming may fall short of

UNB, Magura

The target of cotton cultivation this season may not be achieved in Magura due to heavy downpour and water logging.

Cotton Development Board sources said a target was set up to bring 5300 hectares of land under cotton cultivation and they provided high yielding cotton seeds, fertiliser, insecticides and loan to the cultivators. But many cultivators could not sow the seeds due to water logging and heavy rainfall at the beginning of the season. The seeds which they sowed have been damaged due to the same reason.

Polythene shopping bags still on sale in Brahmanbaria

Banned polythene shopping bags have flooded different markets in rural areas in Brahmanbaria, posing a threat to environment.

A section of polythene manufacturers in connivance with some dishonest traders, are supplying environment hazardous polythene bags to the shopkeepers at cheap

Polythene bags are on display for sale at different markets at Nasirnagar, Sarail, Nabinagar and Annanda fish market in the town.

Shopkeepers, as well as, consumers were found using polythene bags in the markets, especially in the cloth markets.

When asked some consumers told newsmen that they prefer using polythene shopping bags as they are cheap. A polythene shopping bag costs Tk 1 to Tk 2 whereas a jute or cloth bag is sold at Tk 6 to Tk 12.

Vegetable and fish traders said

that they find it very difficult to sell kitchen items without polythene shopping bags as most of the customers come to the market, without shopping bags and demand bags.

A section of unscrupulous polythene traders are still engaged in marketing the banned item by confusing small traders, hawkers and even the villagers that there was no ban on white and coloured polythene bags.

Although using polythene shopping bags is a punishable offence, the concerned authorities have not yet taken any measures to stop the sale and use of polythene shopping bags in Brahmanbaria

The environment conscious people urged the authorities concerned to take strict measures against the manufacturers, sellers and users of polythene shopping bags to stop this hazard which has done serious damage to the envi-

Rains damage crops on 1,000 hectares in Jhenidah

Standing crops on 1,000 hectares of land have been damaged in Jhenidah due to recent continuous rainfalls.

Vegetable on 500 hectares have been damaged while crops on both the banks of the Nabaganga in Jhenidah, Chitra in Kaliganj, Kapatakkha in Kotchandpur and Mohespur upazilas have also been affected by rains.

When contacted, the Department of Agriculture Extension (DAE) sources said that transplanted Aman on 2500 hectares of land have been affected in the beel (water body) areas of Jhenidah.

Not only the agricultural plots but Jhenidah town areas have also been affected badly because of continued rains. People of Jhenidah town suffered a lot due to lack of proper drainage system. Hundreds of families in the town remained marooned in their
