Hasina slams gas tariff hike

Leader of the Opposition in Parliament Sheikh Hasina vesterday protested the increase in gas tariff which she said will cause fresh sufferings for the people.

In a statement, she said the government has increased the tariff not to rationalise the price, but to meet its own interest. Terming the decision anti-people, the statement stated that the incumbent coalition government is raising the gas tariff in a bid to create an atmosphere to export the country's gas.

The opposition leader further said people would foil any move by the government to export gas overlooking the country's interest

On Monday last, the government made an upward revision of gas tariff for the second time in seven months. Earlier in January, the government raised the tariff by 4.62 per cent. As per the government decision, the new rate took effect on September 1.

The Bangladesh Bank (BB) has made it mandatory for banks to go for consortium in sanctioning loans over 50 per cent of their paid-up capitals to a person or a single group.

Also, a bank cannot sanction direct credit of more than 30 per cent of its paid-up capital to a person or a single group. The remaining 20 per cent loan facility can be given as non-funded credit like letter of credit or through other

However, the new rule, made effective from yesterday, will not be applicable to public organisations that take loans against government guarantee. Earlier the banks were free to provide loan facilities up to 100 per cent of its paid-up capital to a person or a group taking clearance from the Bangladesh Bank.

The authorities have taken the move to check the trend of centralisation of a bank's total loan portfolio to a few persons or business groups and also minimise risks of large loans, according to sources.

According to banking sources, a major portion of the loans of a number of private banks has become non-performing, due to exposure to a few persons or business groups who often pressure those banks into sanctioning loans and rescheduling those

The central bank move came after management of different banks had requested it to bring changes to large loan rules. Any loan that crosses 15 per cent of a bank's paid-up capital is considered as large loan.

A committee of commercial banks' managing directors, headed by Khondokar Ibrahim Khaled, Pubali Bank MD, submitted a proposal to the BB proposing changes to large loan rules.

The BB issued a circular yesterday and asked all banks to bring down the limit of large loans already sanctioned to a person or a single group within 50 per cent of their paid-up capitals. The banks that have working loans of more than 50 per cent of their paid-

up capitals to a person or a single group will have to bring those down within the limit by December 2003. In case of term loans, the banks have till December 2004 to comply with the new rule. "As the earlier policy was very risky for the banks, we brought the

changes to check centralisation of a bank's loans to a few person or business group," BB Deputy Governor Nazrul Huda said. In India, Pakistan and Sri Lanka, he said, banks can sanction loan up to

20-30 per cent of the paid-up capital to a person or a single group. "The new rule will encourage the banks to sanction loans on the basis of consortium that will ensure quality of loans and transparency in the loan

Kyoto Protocol in clear

Russia, Canada, Japan, China spell out support

The troubled UN pact on global warming got a big boost at the Earth Summit yesterday when Russia followed Canada in promising it would ratify the Kyoto Protocol soon, and Japan and China spelt out their support.

Ratification by Russia will mean that the climate change pact will take

effect, despite US opposition to it. The pact is designed to reduce the emission of so-called "greenhouse gases" which prevent heat from radiating out into space, causing temperatures to rise worldwide, with resultant droughts and the melting of the ice-

caps, causing the sea-level to rise. "Russia has signed the Kyoto Protocol and now we are preparing for its ratification. This ratification we hope will occur in the very near future," Prime Minister Mikhail Kasyanov said in a speech at the 10-day summit in Johannesburg.

In Moscow, Russian President Vladimir Putin said: "We are positive about this process and the aims of the Kyoto protocol. We intend to ratify.' On Monday, Canadian Prime Minister Jean Chretien said the Canadian

parliament would be asked to vote on ratification "before the end of this

Chinese Prime Minister Zhu Rongji told the summit that China had deposited its instrument of ratification with the United Nations on August 30. 'The Chinese government attaches great importance to climate change. In recent years, the Chinese government at all levels has exerted tremendous efforts to address this problem," said a statement issued by the

In an apparent appeal to Russia, it added: "China hopes that other developed countries will ratify or approve the protocol as soon as possible so as to nable it to enter into force within this year.' Japanese Prime Minister Junichiro Koizumi said his country would "do its
