The commanders and freedom fighters of Chittagong (South) District Unit of Bangladesh Muktiyoddha Sangsad (BMS) have protested the announcement of a new convening committee.

In a joint statement here on Tuesday, the unit leaders also expressed their utmost surprise at the announcement of a new committee as there already exists an elected committee.

The statement alleged that one Ali Akbar, who was a seven-year-old boy at the time of the liberation war, was made the convener of the new committee.

"There was no freedom fighter named Ali Akbar in any of the three previous lists of freedom fighters" the unit leaders also challenged.

'self-declared' central commander was made convener of the new committee in an unethical way.
