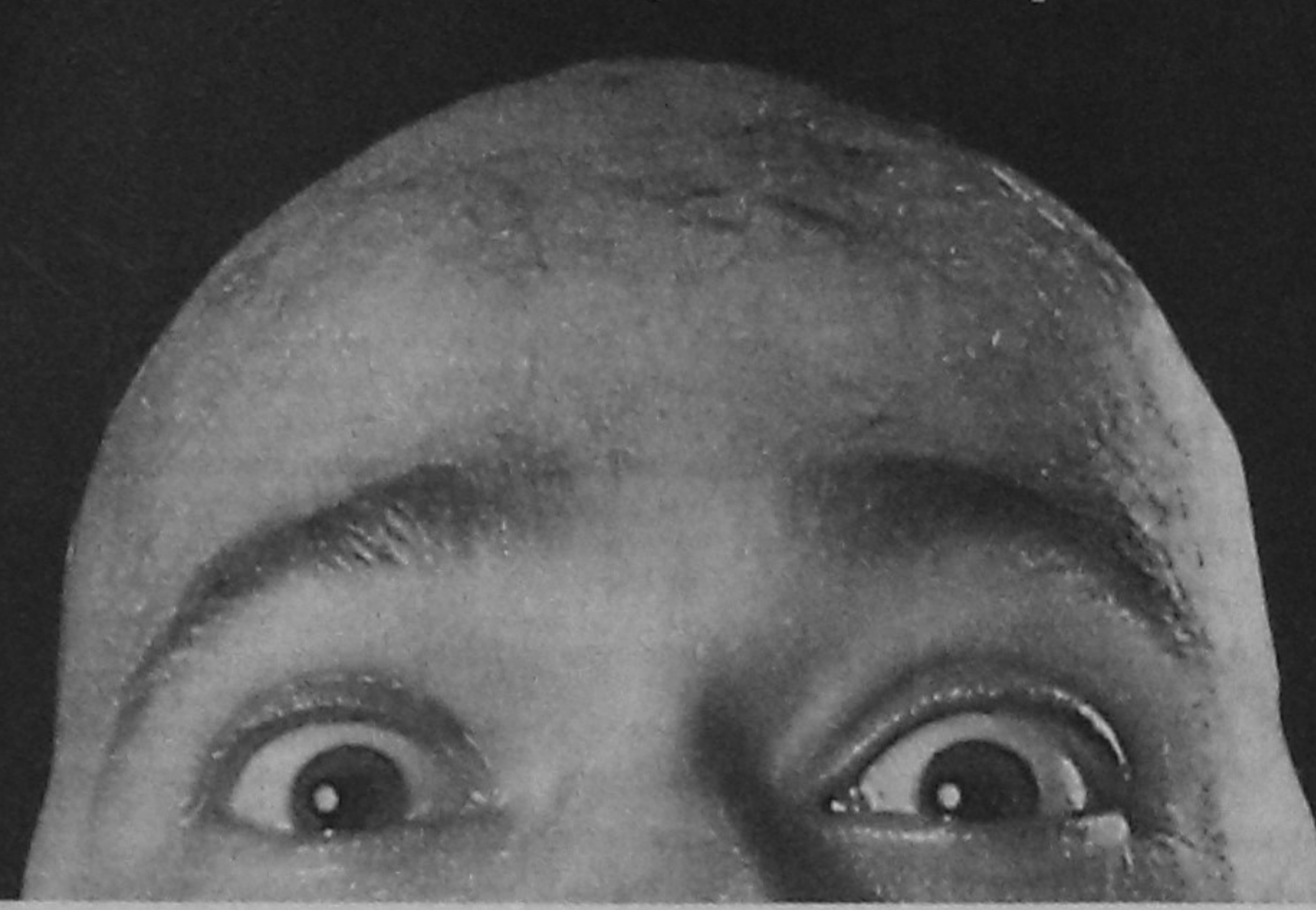

Shipu Murder Case Hearing adjourned till Sept 7

Two more prosecution witnesses in the Shipu Murder Case, were cross-examined in the First Additional Metropolitan Sessions Judge's Court, Dhaka yesterday.

After the cross-examination, by the lawyers of the accused Judge Mohammad Sirajul Islam adjourned the hearing till September 7.

During the cross-examination Mohammad Farooq Hossain, Po-

lice Inspector, Dhaka Range, and the 19th prosecution witness in the case told the court that as per a directive from the officer-in-charge (OC), he registered the petition of the complainant as an FIR at about 10.30 am on May 25, 2000.

Another witness Dr Syeda Chowdhury, medical officer, Forensic Department of Dhaka Medical College Hospital (DMCH) told the court that she prepared a postmortem report of Shipu's body on May 25, 2000.

Earlier, 18 prosecution witnesses were cross-examined.

Iftakhar Ahmed Shipu, 38, a mobile phone trader at UAE Moisture Market in the city's Banani area, was shot dead on the night of May 24, 2000.

Victim's brother Istiaque Ahmed filed a murder case with Gulshan thana accusing six people including Jewel, son of former Awami League lawmaker Kamal Ahmed Majumder, the following day.

Advocate Syed Shamim Ahsan Habib and Mahbub Ahmed appeared in the court on behalf of the accused.

CU officers begin work abstention

The Chittagong University Officers' Association (CUOA) began its two-day work abstention yesterday to press home their five-point demand.

The demands include raising the service age limit to 65 years and implementing the proposed promotions for the officers.

The administrative activities at the university were disrupted seriously due to work stoppage.

At noon, over two hundred officers joined a rally under the banner of CUOA at the officers' lounge.

Presided over by association president Kazi Mohammed Jalal Uddin, the rally was addressed by general secretary Zaker Ahmed, Selimur Rahman, Shahjahan Rashid, Farhad Hossain Khan and Monoranjan Das.

Speakers at the rally threatened to go for a tougher action programme to realise their demands.

The association will announce their next action programme at a press conference today.

Students of respective halls who secured first, second and third position in various events have been asked to be present at the function in due time.

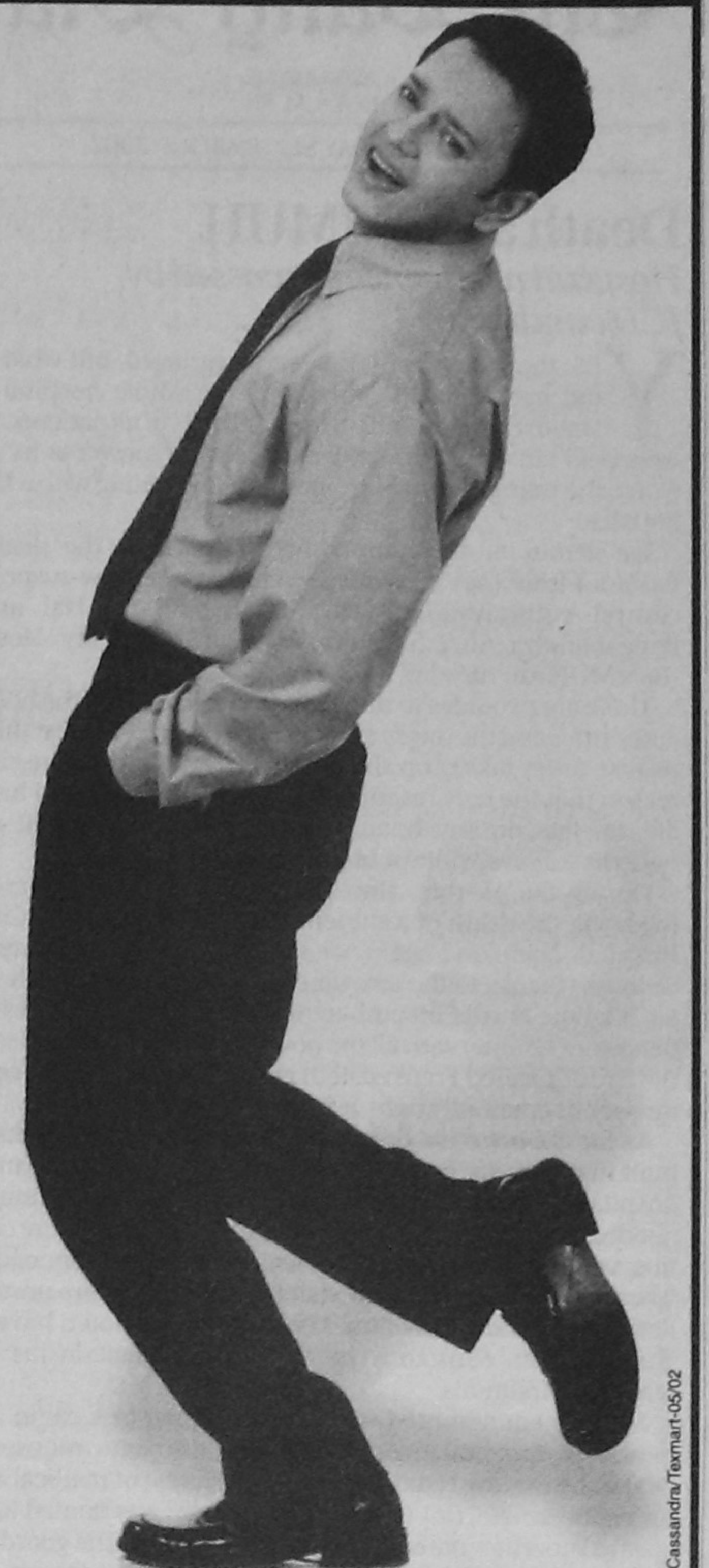

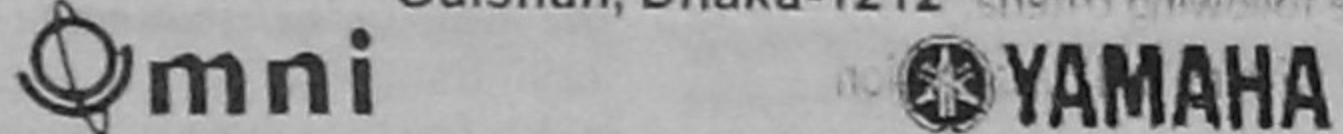

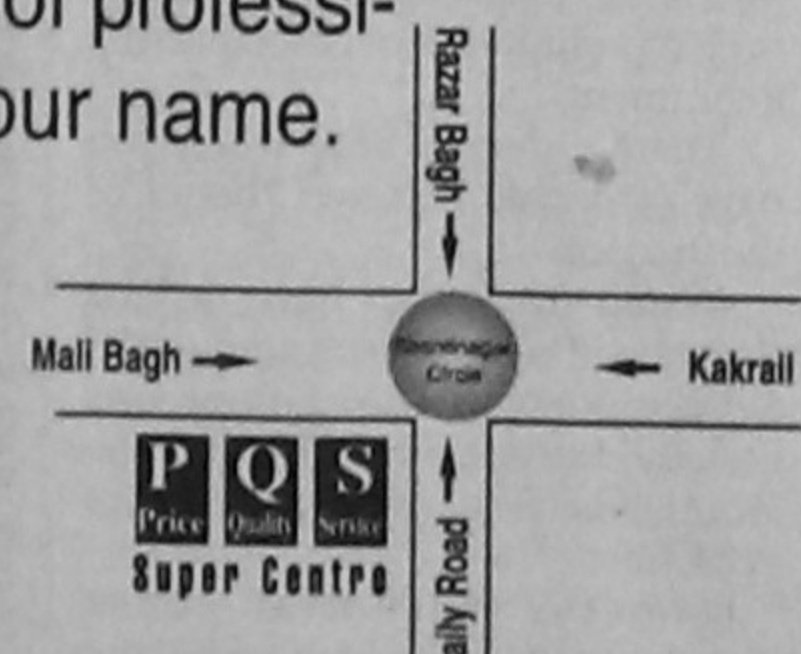
