After examining 11 witnesses, the judge pronounced the verdict with Masum Ali standing on the dock. Fishermen catch 600,000 Hilsa fries every day

Six lakh hilsa fries (Jatka) are being netted every day from the rivers Meghna, Padma, Baleswar and other rivers, fishermen said.

'Jatka' is available abundantly in the aforesaid rivers in the southern region.

About 300 maunds of hilsa reached the wholesale fish market at the Port Road in Barisal town from different places every day from August 31 to September 1. Of the quantity, about 200 to 250 maunds are hilsa fries.

According to the retail fish sellers in Barisal, unscrupulous fishermen maintain an unholy link with wholesale fish traders, staffers of the Fisheries Department and members of the law enforcing agencies. The fishermen have turned the rivers in the southern region a free zone for hunting undersize 'Jatka' throughout the fishing

As a result indiscriminate fishing of 'Jatka' is going on unabated defying government ban on it in the ongoing

Trisha Murder Case

Six prosecution witnesses cross-examined

Six prosecution witnesses (PWs) in the sensational Trisha Murder Case were cross-examined in the court of the District and Sessions Judge Court, Gaibandha last week.

The witnesses were Anowerul Hasan Sabur, Chairman of Gaibandha Municipality, Dr Amal Chandra Shaha, Emergency Medical Officer, Gaibandha hospital, Kiron Chandra Roy, magistrate, AM Syeed Iqbal, Sub-Inspector of Police, Saidur Rahman and Anwar Hossain, fire brigade personnel.

In the cross examination prosecution witnesses submitted their respective deposition before the court, Witness Anowerul Hasan Sabur told the court that on being informed they rushed to pond of Idris Ali and found Trisha dead. Local people recovered her and caught three accused Modern, Shaheen and Asha.

Burglary at Moulvibazar Collectorate

A theft was committed at Moulvibazar Collectorateon Monday night last.

Four colleges in Faridpur run short of teachers

An acute shortage of teachers has been prevailing at different government colleges in Faridpur greatly hampering studies of the students.

The colleges are Government Yeasin College, Government Saroda Sundari Mahila College, Char Bhadrason Government College and Madhukhali Government Aynuddin College.

All these Colleges were nationalised in between late seventies and

The colleges are being run till now with the same number of teachers absorbed in the posts of lecturer and assistant professor during the period of nationalisation

Since then no posts of professor. associate professor, assistant professor and lecturer has been created, according to the Enam Committee report.

Besides a good number of posts of assistant professor and lecturer created at the time of nationalisation

are still lying vacant in all the four colleges.

As a result the college administration has been facing problems to run the college effectively. Though the number of students has doubled or tripled in these colleges in the last two decades, no post of lecturer, assistant professor, associate professor and professor has been created anew till now to cope with the increasing number of students.
