### **Moudud for** time frame for trial

# Residential area in commercial grips

### Shopping complex sprouts up at Dhanmondi without Rajuk nod

In a blatant violation of relevant rules, a six-storey commercial complex has been built inside Dhanmondi residential area in the city, causing severe traffic congestion and noise pollution with consequent public sufferings.

The complex -- Mainland City -- at Road-8 on the western side of Dhanmondi playground has been built without approval from the authorities. Its owner is now trying to get it approved, sources said

The owner has defied government rules regarding non-residential' and 'commercial' use of residential plots in the city's designated residential areas.

In 1996, commercial use of plots on four Dhanmondi roads -- roads 2, 16 (old 27), Satmasjid Road and Mirpur Road -- were allowed on payment of government-fixed conversion fee and with proper approval.

According to government rules, residential plots can be converted into commercial ones only in those roadside areas that have been declared commercial sites. It also requires a conversion fee of Tk 15 lakh for commercial use of a residential building.

But Road-8 where the commercial complex is situ

ated is not covered by these rules, sources pointed out. The complex also does not have adequate parking facilities, resulting in serious traffic jam in the area throughout the day, particularly during peak hours.

When contacted, owner of the huge structure Quazi Hamidur Rahman said he did not seek approval for converting his residential plot into a commercial one as some engineers of Zone-2 of the Public Works Department (PWD) had 'assured' him that they would arrange the approval. The engineers had also told him that there was a plan to allow commercial use of plots on Road-8 because it is very close to Mirour Road. he added

Meanwhile, residents of the area strongly protested the move saving that it would totally destroy the residential character of the area. Criticising approval of 'unplanned conversion' of residential plots into commercial. ones, they alleged that a move is on to do this for 'hefty bribes' from some greedy plot owners.

Asked about this, Executive Engineer of Zone-2 of the PWD Shahidul Islam said he knew nothing about it

## Six killed in separate incidents in city

Six persons including two businessmen were killed in five incidents in different areas of the city yesterday.

Of them, two businessmen were gunned downed in a single incident, two alleged extortionists were beaten to death in separate incidents, an unidentified person was strangled and an alleged criminal was shot dead by rivals.

The businessmen were identified as Abdul Mannan, 27, and his friend Mohammad Babul. Both were residents of Muradpur High School Road in Shyampur area.

Witnesses said when the two men were coming out of Mannan's residence at about 2:30 pm, a gang

led by one Israfil fired several shots. killing them on the spot. "It was a pre-planed killing," said one wit-

Israfil was once very close to Mannan and had married his niece Rasheda. But later he abandoned Rasheda and this led to a feud with Mannan. Killing of Mannan might be a sequel to this, local people said. However, it was not clear why Babul

The duty officer at Shyampur Police station said a case in this regard was yet to be filed and that their investigators were on the spot.

An alleged extortionist, Tofazzal Hossain, 25, was beaten to death by a mob at Bashankat in Kafrul area

vesterday morning

The incident occurred when a gang including Tofazzel was demanding toll from a lady yesterday morning. As she Raised an alarm, local people chased the gang and caught Tofazzal . He died in mob beating

and sent it to the Dhaka Medical College Hospital (DMCH) morgue

Kafrul police recovered the body

Police said the gang went to the area for extortion. No case was filed. Another alleged extortionist, Mohammad Wajed Ali, 38, who was fatally injured in mob beating, died at the DMCH vesterday morning.

# US forces under rocket attack in Afghanistan

US forces came under rocket attack in eastern Afghanistan vesterdav, a day after the first anniversary of the September 11 attacks on the United States.

Colonel Roger King, a spokesman at Bagram airbase north of Kabul, said one rocket landed 400 yards north of the US special forces base at Gardez and another in a small village to the northwest. There were no reported casualties.

King said there were also no injuries when a special operations convoy was attacked with rocketpropelled grenades in the eastern province of Kunar on Wednesday

from nearly a half a mile away, the maximum effective range of the Russian-made weapons.

"Two out of three were duds." he said. adding that the other rocket caused no damage. Rocket attacks on US special

forces near the Pakistani border have become almost routine. However, American attempts to catch the attackers have failed just as routinely. Although no casualties were

They appreciated the recent move by the United Arab Emirates (UAE) government to prohibit use of children below 15 years of age and who weigh under 45 kg as camel jockey. The speakers observed that many Bangladeshi

children are being used as camel jockey in Arab countries but the actual figure was yet to be ascertained. It is very difficult to identify Bangladeshi children who have been trafficked to Arab countries as they immediately forget their mother tongue and home address, they

Addressing the function as chief guest, State Minister for Expatriate Welfare and Overseas Employment Mohammad Quamrul Islam assured all out cooperation on the part of the government in repatriation

and rehabilitation of the trafficked children. He called upon the civil society and non-government

organisations to extend co-operation in this regard as the government alone cannot solve the problem. Immense poverty and acute food scarcity in the


country are the main reasons for which the children and parents are easily trapped by the traffickers, he noted. He said the Bangladesh embassy in the UAE has been asked to collect the figure.

The seminar was also addressed by the BNWLA President advocate Sigma Huda, Executive Director advocate Salma Ali, ILO representative Masud Hasan Siddiqui and Coordinator of ATSET Emranul Huq
