HE rest of Asia often views Japan as a country belonging not to the continent despite the geographic reality. The main reason for such an assessment rests on the economic strength of Japan, which places the country in a position parallel to those situated far beyond the continent. This economic strength of Japan also drifted the nation further from the continent it belongs to and in many aspects of social and cultural life, Japan in recent years was seen busy copying trends and styles that are essentially western. The rapid industrialization of Japan was also accompanied by new social norms that go beyond the conventional understanding of Asia. Although traditional eastern values are still preserved and practiced in many ways, particularly in matters related to family bondage, a new set of social norms that are essential by-products of western urban culture is rapidly replacing them, and by doing so drifting Japan further apart from the continent Asia where the age old understandings are still predominant in manv wavs.

The trend has obviously triggered the emergence of some form of an identity crisis among a group of Japanese who firmly believe in Japan's Asian origin. As Japan's economic crisis has deepened during the last decade, the sense of country's Asian belonging is once again finding its way even among people who during the bubble years were happy considering their country as an essential part of the west located only in Asia as a result of some strange geographic coincident. With the economy of some parts of other Asia moving rapidly towards an advanced stage, this trend would definitely find further ground to bring Japan back to the ranks of Asian states in true sense.

If the process of economic development can provide stimulus for bridging the artificial gap that has been created during the post World War II period between Japan and the rest of Asia, a better understanding of other Asia by the people of Japan would definitely serve as an additional factor that would help achieve that goal. There is no shortage of people in Japan who subscribe to such understanding and they are relentlessly trying to put these ideas into practice through their individual as well as collective efforts based on goodwill and mutual understanding. Japan's western city of Fukuoka is a unique example of how such understanding can turn into a collective approach and help people getting better knowledge about next-door neighbours.

Fukuoka is the largest city of Japan's Kyushu Island and situated at the closest proximity to the continent Asia. This geographic location has rightfully endowed the title 'Japan's gateway to Asia' to the city. Historically the city was in close contact with the continent and during Japan's pre-modern period ships from Fukuoka regularly sailed to Korea, China and Vietnam; places with which the region had strong business ties. Although Japan's long period of self-imposed isolation during the Tokugawa period disrupted that historic contact, it didn't take much longer for the island of Kyushu to re-establish the broken tie after the era of self-imposed isolation came to an end.

As the twentieth century was coming to an end paving the way for a period of optimism based on mutual respect and understanding, Fukuoka once again came forward with the initiative of forging a meaningful tie with Asia that would help people of Japan to know about the continent and its culture better. The idea of Asia Month is an essential by product of such an understanding of the leadership of the city. Established in 1990, the Asia Month's programme has three different sides that cove


a broader aspect of the region in general. While the Asia-Pacific Festival provides the audience with the opportunity to view first hand the presentation of cultural programmes by troupes invited from different Asian countries, a festival of film focusing on Asian cinema allows the viewers to have a better understanding of the societies through their reflections on films. Finally, Fukuoka Asian Cultural Prizes honour leading personal ities from different Asian countries for their achievements in a particular field, which also help fostering mutual understanding among different Asian nations.

Traditionally the programmes of the Asia Month start at the beginning of September and continue for almost thirty days. This year's thirteenth Asia Month programs are now already on as cultural troupes from a number of Asian countries are busy showing their artistic skills to the people of Fukuoka. The film festival, scheduled from September 13, is to show 27 films from 15 Asian countries including Japan. Bangladesh too has her due share at the festival as Tanvir Mokammel's 'Lalsalu' being chosen to represent the country at a specially design nated part for this year's festival where the world of Islam is to get a rightful focus through the medium of film. The organizers of the festival came up with this unique idea as the western media had variously presented distorted and faulty understanding of Islamic societies after the September 11 incidents. Films, according to the organizers of the Fukuoka Film Festival, can be of great help in correcting any wrong image about a particular society, and they are hopeful that the Festival would provide the people of Fukuoka with the right opportunity to get to know more about Islamic societies through films that have been produced in those countries. Hence, the choice of 'Lalsalu' can be considered as a perfect one as the film, based on a powerful novel by Syed Waliullah, traces the other side of exploitation in the name of reli gion that runs contrary to the teachings of Islam.

The names of the laureates for this year's Fukuoka Asian Cultural Prizes were announced in July and the four recipients have been invited to attend the award giving ceremony on September 19. They will also speak at seminars being organized as part of the Asia Month. The aim of the Fukuoka Cultural Prizes is to preserve and foster Asian culture and promote the recognition of its prestigious value. The prize is regularly been awarded in three categories since 1990. Besides a grand prize, there are also academic as well as arts and culture awards. Each category carries financial reward as well as a special citation recognizing the winners'

Four distinguished personalities from four different countries have been selected for this year's prize from a broader list that was compiled after approximately 4,000 nominators from 54 countries submitted their nominations. The laureate for the 2002 grand prize is the renowned Chinese film director Zhang Yimou, who consistently depicted the hardship of life in contemporary China in his films and made significant contribution in the advancement of Chinese cinematography. Two distinguished historians from Australia and Sri Lanka. Professor Anthony Reid and Professor Kingsley Muthumuni, were chosen for the academic prize, while the arts and culture prize goes to the Malaysian cartoon-

Last year's grand prize winner being Professor Mohammad Yunus, Bangladesh enjoys prestige in events related to Fukuoka's Asia Month celebration. The participation of 'Lalsalu' at this year's film festival no doubt helps keep that tradition high.



Sustainable development: Is the road too far?

ASADULLAH KHAN ETWEEN the last Earth Summit in Rio de Janeiro, and the just concluded Johannesburg Summit in South Africa, scientists reckon that there has been little progress in cleaning up the mess. Shockingly, the road to the just concluded summit was littered with unkept promises and shattered treaties. The world today seems no better a place than what it was in 1992. In taking stock of the whole scenario, people both in the developed and underdeveloped world find to their utter shock and dismay that air pollution has now become a major killer with three million people dying of it every year, carbon emission doubled in three decades with the U.S. pumping 16 percent above 1990 level making it a major polluter. In the water front, forty percent of world population now faces chronic shortage of fresh water for daily needs. Although we live in a world that is 70 per cent water, only 2.5 per cent is fresh, and only a fraction of that is accessible. At present 1.1 billion people lack access to clean drinking water and more than 2.4 billion lack adequate sanitation. Added to this is the problem of contaminated water that kills around 2.2 million every year. In Bangladesh, in spite of the fact that we have 4m hectares of inland water support area, water crisis was building up since long because of declining surface water availability during lean period. Other than this, water quality degradation, especially of surface water due to poor sanitation, industrial effluents and pesticide run off has added to the woes. Compounding with this problem arsenic contamination of ground water and poor surface water quality has put the country in a

Water scarcity and water stress experienced in the length and breadth of Bangladesh that are directly linked to human activities run counter to sustainable development in the country." "Unless we take swift and decisive action", says U.N. Secretary General Kofi Annan. "by 2025 two-thirds of the world's population may be living in countries that face serious water shortages". Arguably, agriculture accounts for two thirds of the fresh water consumed. The Johannesburg summit endorsed a proposal that envisages "more crop per drop" approach. The proposal calls for more efficient irrigation techniques, planting of drought and self-tolerant crop varieties that require less water and better monitoring of growing conditions such as soil humidity levels. Improving water delivery system would also help reducing the amount that is lost enroute to the people who use it. The programme it envisages is WASH -- Water, Sanitation and Hygiene for All -- a global effort that aims to provide water services and hygiene training to everyone who lacks them by 2015. In spite of the fact that world wide population growth has eased, in poor Asian countries the growth is still horrific. Mentionably, world population increased 48% from 1975 to 2000, compared with 64 per cent from 1950 to 1975. But even as this deceleration continues, the population is expected to level off eventually, perhaps at 11 billion sometimes in the last half of this century. In the Cairo conference on 'population" attendees pledged \$5.7 billion, to reduce birth rates in the developing world and acknowledged that giving women more education and reproductive free-

dom was the key to accomplishing

that goal. Even a global calamity like AIDS has yielded unexpected dividends, with international campaigns to promote condom use and abstinence helping to prevent not only disease transmission but also conception. Such efforts have paid off in a big way. According to U.N. head quarters, the average number of children produced per couple in the developing world -- a figure that reached a whopping 4.9 per cent in the early part of the last century -plunged to just 2.7. In many coun-

tious diseases such as AIDS. malaria, cholera and tuberculosis are having a Malthusian effect. Rural-land degradation is pushing people into cities, where crowded and polluted living conditions create the perfect breeding grounds for sickness. There is reason for concern which the Johannesburg summiteers must have noted. World wide at least 68 million people are expected to die of AIDS by 2020 including 55 million in sub-Saharan Africa. The situation would be far

reliable access to safe nutritious food and 800 million of them -including -- 300 million children are chronically malnourished. Around the world, just 15 cash crops such as corn, wheat, and rice provide 90 per cent of the world's food, but planting and replanting the same crops strip fields of nutrients and make them vulnerable to pests Slash and burn planting techniques and over reliance on pesticides further degrade the soil. Beset with agricultural failure, fragile ecosys-

scarcity. With a rate of loss at 90,000 sq. km per year since 1990, 2.4 percent the world's forests has been destroyed. Around the world, biodiversity defined as the full variety of life from genes to species to ecosystems is in trouble; 800 species have become extinct and . 11000 more are threatened. Experts have shifted their focus from individual species to threatened habitats known as "hot spots". The countries with the most hot spots in the world are Ecuador, Madagascar and the

We can't think of development alone in total disregard of the environment. ... Development that takes little account of sustainability is ultimately self-defeating.

tries in Europe and America the fertility rate is well below 1.5. A little more than 30 years ago, global population growth was 2.04 per cent

a year, today it's just 1.3 per cent. Sunny, as the global averages look, things get a lot darker when you break them down by region. Even the best family planning programmes do no good if there is neither the money nor governmental expertise nor education to carry them out and in less developed countries -- which currently account for a staggering 96 per cent of the annual population increase -- all these are sorely lacking. In India, Pakistan and Bangladesh the growth rate is still near 2 per cent. While Europe's population was three times that of America in 1950. to-day the two continents have about the same count. Astoundingly, at the current rate Africa will triple Europe in another 50 years.

In the poorest part of the world, most notably Asia and Africa, infecless tragic if rich nations did more to help the developing world reduce birth rates and slow the spread of diseases. To make the WASH programme, mooted in the summit, a success it must target at women who must be provided with basic education and job training. In our country as well as in most other places of Asia, we have hardly made any headway in this sector. Understandably, while any factor that eases population pressures may also help the environment. On the other hand, educated mothers not only have a stepladder out of poverty, but they also choose to have fewer babies. Moreover, any developmental effort aimed at improving the environment worldwide will require good healthcare for the young since there are more than one billion people aged 15 to 24.

The West although have noticed but blatantly ignored the fact that up to a third of the world is in danger of starving. Two billion people lack

tem, erratic weather and other factors. Bangladesh now faces serious problem in feeding its people. Because of dismal poverty situation and population boom, land clearing for agriculture principally through shifting cultivation in the hill forests goes apace. In Bangladesh forest areas are being destroyed through logging, mostly illegal for timber industry related to the current building boom. Experts opine that all remaining forest patches will be destroyed within 10-15 years at the current rate of destruction. Again half the world's wetlands have been lost and one-fifth of the 10,000 fresh water species has been extinct. On the other hand, increasingly

the land is under threat. One third of global land has been converted to food production, but three quarters of this area has poor soil. So far harvests outpace population growth, but the future is clouded by the loss of land to urban development, soil degradation and water

Philippines, Each has lost two-thirds or more of its biologically rich rain forest and the remainder is under assault. After ten years since Rio in 1992 the fact remains that things haven't changed meaning the air is just as grimy in many places, the oceans just as stressed, wild life and forest resources in ever increasing

Shockingly, the World Summit on Sustainable Development in Johannesburg that wound up on September 2, attended by about 100 leaders. scientists and NGO workers could hardly invoke the amount of interest and action it called for. It is worth recalling that at Rio developed countries agreed to spend 0.7 percent of their GNP towards development assistance. But instead of increasing, the figure has come down from 0.34 percent in 1992 to 0.22 percent now. The developing countries opine President George W. Bush's pulling out of the Summit as a ploy by the U.S. to bypass

on the firm commitments it had made at Rio. The blueprint for sustainable development for the earth that was agreed upon at Rio, in 1992 under Agenda No. 21, with annual cost of \$600 billion with the North's agreeing to contribute \$125 billion as development assistance to poorer countries, fell down to just \$53 billion in 2000. In consequence, at Johannesburg, key environmental issues such as saving forests and protecting biological diversity have been pushed to the background. Noticeably, the progress of most of the environmental treaties agreed upon earlier has been dismal. Most noteworthy, the U.S. has derailed the global treaty on climate change by refusing to comply with the agreements at 1990

multilateral negotiations and renege

But the problem is mounting up with dark clouds hovering al The amount of crops animals, biomatter that we extract each year from the earth inhabited by 6.1 billion people exceeds what the planet can replace by an estimated 20 per cent. Experts have opined after detailed analysis that it takes 14.4 months to replenish what we use in 12 indicating a deficit spending of the worst kind. It is high time we realize the dangers we are going to face. For too long, too many people have believed that natura limits to human well-being have been conquered. And too many have put their faith solely in technological breakthroughs as the inevitable answer to any resource constraints or other vulnerabilities that might emerge. But sustainable development means equitable distribution of wealth and opportunities. Sustainable development is an exceptional opportunity -- economically, to build markets and create

iobs: socially, to bring people in from margins; and politically, to reduce tensions over resources that could lead to violence and to give every man and woman a voice and a choice in deciding their own lives. not at the expense of future generations. In our march towards progress and development we have begun to recognize the perils inherent in the prevailing model of development. Noticeably, as forests have been felled and aquifers drawn down, as the atmosphere has filled with toxins and oceans have been fished to exhaustion and the climate itself has started striking back, the world has seen the dangers of business as usual.

It is high time that societies throughout the world work in a way to ensure that economic growth and environmental protection go together, be not at odds. We can't think of development alone in total disregard of the environment. Even then for the poorest members of the human family in Bangladesh in particular, development means the chance to feed, school and healthcare for themselves and their children. Undeniably true, the U.S and some countries of East Asia and China are going ahead with developmental efforts at a breath-taking speed that brings distress, disease suffering and hardship to the world at large. These sort of development that takes little account of sustainability is ultimately selfdefeating. Prosperity built on the despoliation of natural environment is no prosperity at all, only a temporary reprieve from some immediate
