# CAG reports gather dust

Only 18pc reviewed by JS body since independence: TIB

### HIGHLIGHTS

- 66.4 per cent audit objections worth US\$ 3.8 billion remain untouched.
- CAG office submitted 770 audit reports with 16085 objections to the parliament till July 16, 2002. Only 18.3 per cent or 141 reports reviewed so far.
- Some ministries take 16 years to act on audit objections.
- CAG audits 22,885 government units every year.

The parliamentary standing committee on public accounts has reviewed only 18 per cent of the reports prepared by the office of the Comptroller and Auditor General (CAG) since independence.

Moreover, the crucial watchdog of government expenditure, popularly known as the public accounts committee (PAC), could not deal with 66.4 per cent of the CAG objections that involve \$3.8 billion, according to Transparency International Bangladesh (TIB) investigative studies on the CAG and the PAC

Professor Muzaffer Ahmad, a member of the TIB board of trustees presented the findings on the opening day of a two-day National Integrity Workshop at the CIRDAP auditorium in the city yesterday.

Professor Khan Sarwar Murshid, chairman of the TIB board of trustees. chaired the workshop attended by lawmakers, politicians, researchers, senior journalists and high government officials.

The TIB reports put the PAC failure down to its own limitations and the government's negligence

ICAB slaps 3-yr ban on a CA firm

The Institute of Chartered Accountants of Bangladesh (ICAB) has suspended its member Ahmed Khan & Co for three years on charges of fabricating financial statements of a publicly traded company.

The suspension was made at a meeting of the ICAB Council on Monday on the basis of findings of an investigation by the disciplinary Committee of the institute.

ICAB officials said proprietor of Ahmed Khan & Co. Haider Ahmed Khan FCA has been found guilty of "professional misconduct."

### **BCL** leaders Liaquat, **Babu freed**

## Charges framed against five

Judge Sarker Abul Mansur fixed September 25 for trial of the case. Rubayet Ahmed Bappi, 8, a

student of class III of Armenitola Government High School was abducted by Shipon from their Becharam Dewri residence in the old city on August 5 for ransom.

Later, Shipon and his four accomplices took Bappi to Demra. They strangled Bappi the same day and dumped the body in the river Shitalakhya.

The committee came to the conclusion that the member failed to report "material misstatements' which was known to him and "committed aross nealigence in the conduct of his professional duties.'

The ICAB Council suspended the member till September 15, 2005 and ordered him to submit his certificate of practice to the ICAB Secretary for retention by the institute.

The ICAB launched the investigation against its member following a complaint from the capital market regulators. The Securities and Exchange Commission (SEC) alleged that the member while auditing balance sheets of the publicly traded company, Mark Bangladesh Shilpa & Engineering, "failed to detect irregularities or willingly concealed facts without reporting to the shareholders."
