DU reopens today

Academic activities at the Dhaka University (DU) resume today after 67 days of unscheduled closure.

The university authorities said necessary steps have been taken for resumption of classes and other activities in a peaceful atmosphere on the campus.

Newly appointed Vice Chancellor (VC) of the university Prof SMA Faiz is likely to visit different faculties after resumption of classes.

Different student organisations will bring out separate processions welcoming the students back to the campus

Most of the resident students have already returned to their respective halls, which were reopened on September 29 for their convenience

When contacted, the VC told The Daily Star he hoped that no untoward incident would take place on the campus after the reopening of the university. The authorities were monitoring the campus situation round the clock, he said.

The DU was closed on July 28 by the then VC Prof Anwarullah Chowdhury in the wake of a massive students agitation. The students staged demonstrations on the campus protesting the July 24 police atrocities at Shamsunnahar Hall and demanded resignation of the VC. Against this backdrop, Prof Chowdhury stepped down on July 31

On August 29, the DU Syndicate had decided to reopen the university on September 12. Later, it changed the decision.

The new VC has sought cooperation of all teachers of the university to put an end to violence on the campus and ensure a conge nial academic atmosphere.

According to a 12-point SC directive, the government is supposed to separate the judiciary by October 26. A cabinet committee meeting yesterday reviewed a report on absorbing officials of the administration cadre who serve as magistrates into the proposed judicial service.

But the issue could not be resolved and the committee will sit again on the ssue. The date has not been fixed.

The meeting over, Industries Minister and chief of the cabinet committee MK Anwar told journalists that the separation of the judiciary cannot be completed before the October 26 deadline and the government will seek fresh time

The SC issued the directives in December 1999 for the separation of the udiciary. Since then, the then AL government sought extension of the deadline seven times, the caretaker government twice and the BNP-led coalition government four times

Raju's killers still at large

Police are yet to arrest the killers of Ward Commissioner KM Ahmed Raju and BNP leader Sanaullah Hag Nuri.

Meanwhile, Officer in charge of the Mohammadpur Police Station MA Kuddus Khan was closed Tuesday night following the killing of ward commissioners in the city since the April 25 DCC the ward commissioner and BNP election, the latest one taking place in Mohammedpur in leader

No case was filed with the Mohammadpur Police station till 7:00 yesterday evening in connection with the killing of Raju and Nuri, commissioner of ward No 44 and acting general secretary of ward No. 46 of the Dhaka City Corporation, respectively.

Meanwhile, 28 people arrested for suspected involvement in the killing of the ward commissioner were produced before the Chief Metropolitan Magistrate's Court yesterday. The court placed them on a two-day remand for interrogation.

Unidentified gunmen shot and fatally wounded Raju and Nuri in front of the ward commissioner's office at Town Hall in Mohammadpur in the city. They were rushed to the Bangladesh Medical College Hospital and Nuri was shifted to the DMCH where the on-duty doctors declared him dead. Raju was moved to the Combined Military Hospital (CMH) where he died Tuesday evening.

Police and other sources believe the ward commissioner might have been killed due to conflict in the local leadership. Raju was recently made convenor of the Mohammadpur unit of the ruling Bangladesh Nationalist Party (BNP) which might have angered his rivals


Satkhira blasts Hunt on for the 'lucky escapers'

The government is seriously considering closure of over 10,000 non-performing educational institutions, said the education secretary.

"The decision will help the government ensure the standard of education and save Tk 300 crore a year, now being wasted," Education Secretary Mohammad Shahidul Alam told The Daily Star.

Performance by more than 30 per cent of educational institutions does not live up to the mark, he said

"The education ministry has identified over 10,000 educational institutions (about one-third of the total), including conventional schools and madrassahs for closure," Alam said.

The ministry initiated a study last November on the standard of education of about 30,000 institutions in the country, he said.

The ministry will submit the report to the cabinet for finalisation after completion of the study.

"A political consensus is needed for finalisation, since many institutions were set up with political motives," he said.

About such decisions in the past, he said the decision of closure largely depends on the cabinet.

The saved funds of about Tk 300 crore will be used for teachers salary, infrastructure development and projects to be taken to enhance the standard of education, he added. The prime minister is keeping track of the study initiated after a cabinet decision last November.

Pointing to mismanagement of these institutions, he said some vested quarters are drawing deceased teachers' salaries. Also, there are some institutions where no students passed examinations.

The education secretary has said the ministry will suggest integration of very bad-performing institutions into good ones, but some institutions will definitely be closed down due to their poor performance.

US President George W Bush may use force against Iraq in a manner "necessary and appropriate" to protect US national security and enforce UN resolutions, according to a deal with House leaders released yesterday. "The president is pleased that

the resolution gives him the tools he needs to deal with Saddam Hussein's threat and that it does so in a way that does not tie his hands," Bush spokesman Ari Fleischer told reporters.

The US leader has told the United Nations that if it fails to approve a tough new weapons inspection regime to strip Saddam

of any nuclear, chemical or biological arms, Washington will act alone or with its allies.

Fleischer, announcing the deal shortly after the White House made the agreed-upon resolution public, said Bush believes that chances for approval by Republicans and opposition Democrats in the House was

The resolution requires Bush to notify House and Senate leaders before any military action, or not later than 48 hours after it begins, that diplomacy has been exhausted or is doomed to fail.

It also mandates that he assure the leaders that attacking Iraq will not hamper the war on terrorism he declared after the September 11,

DU, BUET admissions set for a setback Aspirants may have to wait for a while

Stalemate at the Dhaka University (DU) and the Bangladesh University of Engineering and Technology (BUET) will delay enrollment of undergraduate students this year.

Officials of both universities said the possibility of holding admission tests by this December is slim. The probable delay will cause a backlog of at least one year, admis-

sion seekers and guardians fear. On the other hand, private universities have already begun admission procedures for the

2002-2003 session, just after announcement of the HSC results on September 18.

The DU reopens today after a closure of 67 days and the BUET reopened on September 28 after a disruption of academic activities since June 9.

The BUET held admission exams for the previous academic session in November 2001 and the DU in January 2002.

The DU vice-chancellor, Professor SMA Faiz. told The Daily Star that the academic council would decide on the test schedule. The university is thinking of

reducing session jams by curtailing scheduled vacations. "And this will happen only after consultations with the university bodies," Prof. Faiz said

Prof. M Zoynul Abedin, director of students welfare, BUET, told The Daily Star that it would take at least three months more to conclude classes and examinations of the current academic session. "It's not possible to take in new students before that," he said.

"We have lost at least six months to the campus unrest over the last few months and it will affect BUET students and admission

seekers alike," Prof. Abedin said. Talking to The Daily Star, Nazmul Islam, who topped the combined merit list of the Dhaka Education Board, said he intended to study at the BUET, but the recent academic standstill has made him think twice.

His father Saiful Islam said he was considering sending his son abroad because of campus violence and session jam here.

Equally frustrated is Nafisa Tanjum Nipun, who stood ninth in the humanities group in the Dhaka Education Board, "I will enroll at a private university if I can afford. But I prefer to study at the DU," Nipun said.

Talking about the unwanted delay in admission exams, Principal of the Notre Dame College Benjamin D'Costa said, "It's painful to see young learners facing such unwanted backlogs at the very beginning of higher education."

About 4,500 undergraduate students enroll at the DU every year under its different faculties and institutes of science, arts, social sciences and business studies and 810 at the BUET, with an average of 70,000 admission seekers a year.
