Climate confce on Call renewed to implement Kyoto protocol

The Eighth Session of the Conference of the Parties (COP-8) to the United Nations Framework Convention on Climate Change (UNFCCC) began in New Delhi yesterday with a call for all countries to implement the Kyoto protocol on global warming before it gets too late. "We must bring into force the protocol without delay,"

said TR Baalu, India's environment minister, who was appointed Wednesday as president of the conference. 'The rise in temperature is already beginning to

affect physical and biological systems," Baalu told some 4,000 delegates from 170 nations, including Bangladesh. "Frequent floods and droughts are having serious

impacts. Depleted moisture combined with heat stress is projected to reduce the global yield of major foodgrains," he added

Baalu said the impact of climate change would be felt most in developing countries, as global warming would aggravate poverty and increase hunger through a rise in food prices.

"But developed countries are required also to demonstrate their lead role in modifying longer-term emission trends, and in this respect they are committed specifically to adopt mitigation policies and measures,' Baalu said. "Those with the least resources have the least capacity to adapt and are the most vulnerable."

The ten-day two-week conference in New Delhi will discuss the implementation of the 1997 Kyoto protocol on global warming. Senior environmental officials are due to join in the talks here next week. The agreement is opposed by US President George W. Bush, who leads e world's largest national polluter

Mohamed Elyazghi, the outgoing president of the convention, urged all nations to sign up for the Kyoto protocol.

"Those countries who have already joined the protocol have already shown the way and we urge all parties to jump on the train which is already moving," Elyazghi told the conference

Minister, the Food Ministry vesterday decided to sell one lakh tonnes of wheat and 50.000 tonnes of rice in the open market through OMS (open market sale).

Wheat will be sold at Tk 8 per kg and rice at Tk 12.50 per kg, Food Secretary Khairuzzaman Chowdhury informed newsmen following the PM's instructions.

Rajuk razes down Fu Wang encroachment

Rajuk bulldozed some illegal constructions of the Fu Wang Group Limited from the Gulshan-Banani-Baridhara Lake vesterdav

Under the supervision of a magistrate, a team accompanied by police and army flattened the pillars around the lake area at plot No. CS 461 and Mouza-Bhala in Gulshan

Top Rajuk officials said the company had illegally encroached upon the wetland claiming to have purchased it from a 'so-called private landowner'.

According to the master plan, the land is designated as wetland of the lake.

Some pillars were also found to be constructed in the middle of the lake

Sources said Fu Wang Limited bought the wetland from one Shamim Ara Rafig, who claimed herself to be the original owner.

Sources in the Raiuk said, when the so-called landowner had applied to the Rajuk in 1997 for land

use clearance, the then Chief of the Town Planning division. Zakir Hossain, allegedly realising 'hefty bribes' provided the clearance.

Although clearly defined in the map as a wetland of the lake, he claimed it to be otherwise.

The land-use approval was also provided to at least 12 other people, sources in Rajuk said.

Moreover, earlier, the Rajuk had also approved the construction of two high-rises in the Gulshan Lake. The files of these approvals could not be found, sources said.

A committee formed by the Ministry of Housing and Public Works is looking into the matter, said sources in the ministry

The Wetland Protection Act, 2000 has barred any transformation of the existing structure of wetlands for other purposes

A top official of Rajuk, preferring anonymity, said if necessary the Rajuk would get into legal battle to save the land from illegal encroachment.

Yann Martel wins Booker Prize for 'Life of Pi'

Canadian writer Yann Martel on Tuesday ran out a narrow winner of the Booker Prize, one of the world's most prestigious literary awards, for "Life of Pi," his quirky fable about a boy's survival after a shipwreck

"I feel like I am in the arms of a beautiful woman," said the overjoyed Montreal novelist after landing the coveted prize. "I am overwhelmed, delighted and honoured," he told reporters.

Martel, who gave his acceptance speech in both English and French, was the hottest favourite in the 34-year history of the renowned prize after organisers mistakenly put out his name as the winner last week when doing a test run on their website

Two people received splinter delayed for 2 hours

The Inter City Upaban Express was delayed for about two hours when some army men beat up three railway staff members after failing to buy tickets from the ticket counter here at the Sylhet Railway Station Tuesday night.

Sources said a group of army men went to the railway station at 10:00am on Tuesday and asked for 27 tickets for the Dhaka-bound Inter City Upaban Express scheduled to leave at 10:00pm. But because of scarcity of tickets due to the Shab-e-Barat holiday rush, railway officials issued only 14 tickets for First Class and Shovan Class, saying that more tickets might be available later at

At night, the soldiers went back to the counter and asked for the rest of the tickets. But at about 9:00pm when four tickets were returned, the staff at the counter immediately sold them to some people other than the

At this, the army men became

furious and forcibly entered the ticket booth and beat up three of the staff members there. They also entered a train compartment, forced some passengers out and occupied their seats.

Later, the passengers of the compartment informed the matter to the Station Manager, who somehow managed to convince the army men to vacate the seats

The manager then informed the deputy commissioner, Railway officials and officials at the cantonment about the matter. Shortly afterwards, army officials reached the station and expressed sorrow for the incident. But they also expressed their concern about allegations of ticket sale on the black market. The train however left the station at 11:40pm instead of the

scheduled 10:00pm. Railway officials said army troops are supposed to buy their tickets much ahead of their journey and are not supposed to travel in the seats of civilian passengers.
