### 6 get life term in Kushtia **AL** leader murder case

Additional District and Sessions Judge's Court, Kushtia on Thursday sentenced six people to life-term imprisonment in Awami League activist Taher murder case.

The convicts are Asadul, Toffazel, Khedu, Solaiman, Hamidul

According to the prosecution, the accused stabbed Abu Taher at village Jamtola in Daulatpur upazila on April 23, 1993.

Taher was admitted to Kushtia Sadar Hospital where he succumbed to his injuries on April 27. Victim's father Golam Rabbani filed a murder case with Daulatpur police station accusing the six.

After examining the records and witnesses, Judge Anwar Hossain pronounced the verdict.

# MP Auranga arrested, 9-shooter gun seized

226 including 75 listed criminals netted, 42 firearms recovered on 9th day of army drive

army camp in the city yesterday after he was arrested with arms and ammunition in the ongoing anti-crime drive.

Independent member of parliament Hemayetullah Auranga, a BNP leader and two leaders of its student wing Jatiyatabadi Chhatra Dal (JCD) were arrested in the city early yester-

A nine-shooter gun along with some ammunition was recovered from Auranga's Hatirpool residence when he was arrested during an army raid at about 5 am. He was taken to Tejgaon army camp.

Auranga, expelled from Awami League prior to the last parliamentary election, was elected from Madaripur-1constituency

Auranga is accused in a number of criminal cases filed with different police stations in the city. He is reportedly involved in underworld crime, sources said. Auranga maintains close links

with some influential political leaders who on many occasions backed him in the past. Awami League, while in power

(1996-2001), ordered police to arrest Auranga and two of his associates Hannan and Liakat. But police failed to arrest them.

# A council may steer future army drive NAZMUL ASHRAF

The government is considering formation of a national security council to steer the army in any future anti-crime crackdown like the current one across the country, a highly-placed source said yester-

If formed, added the source, the council will have the authority to decide on deployment of the army for anti-crime drives if anv in future.

"This will help remove legal complications about calling-out of the army to assist the civil administration in fighting crime," he said, referring to the legal debate over the current army drive.

Terming the plan premature, another source in the Prime

discussed and yet to take on concrete shape.

Referring to discussions among the authorities concerned, the sources said the President is likely to head the proposed security council, which may include the prime minister, the home minister, chiefs of three services and heads of the civil and

military intelligence agencies. "But the army's participation in anti-crime crackdowns will never be a permanent arrangement even if the proposed council is set up," said another source. The plan aims to restore peace in society, he added.

With the plan shaped, the law ministry will examine it and the move will proceed further if the ministry finds it practical, the source pointed

Yet, the government is also weighing other options in its prom-

ised fight against crimes, he said. Meanwhile, the government is planning to pull out the army in

phases with the start of Ramadan.

A fresh deployment of the army may be needed, if the law and order deteriorates, said a home ministry

Admitting that the notorious criminals are yet to be netted in the current army-drive backed by police, he said: "Continuation of the ongoing joint drive depends on its outcome. Moves are under way to nab the absconding criminals and their godfathers.

## Selim shown held in motorcade attack case

#### Produced in court, remanded again

Awami League leader Sheikh Fazlul Karim Selim, MP, has been shown arrested in a case filed with Keraniganj Police Station in connection with an attack on the motorcade of the then leader of the opposition in parliament Khaleda Zia on June 17 last year.

The lawmaker was produced before a first class magistrate's court. Dhaka, yesterday. The court granted a prayer from the CID to show him arrested in the motorcade attack case and placed him on remand for

Earlier in the day, Gulshan police produced Selim before the Chief Metropolitan Magistrate's Court, Dhaka, at 3:45 pm on expiry of a three-day remand. Arrested on Monday, he was remanded in a case filed under Section 54 of the CrPC.

The lawmaker alleged in the court that he was mentally tortured during interrogation while on remand. He said although Gulshan police took him on remand, he was interrogated by the Joint Interrogation Cell (JIC) at Cantonment Police Station.

"I was kept with other detainees

and was handcuffed always. I was not given food timely. They gave me a bed sheet but did not allow me to sleep," the Jubo League chairman told the court.

When he wanted to know why he was kept handcuffed, the interrogators said this was done as per a directive from the higher authorities, Selim said.

"In the last three days, my family members and lawyers came to meet me, but they were not allowed."

Police submitted before the court a forwarding report seeking detention of the lawmaker. The report said he gave some important information about anti-state activities during interrogation and that he would be shown arrested in cases filed with different police stations across the country.

Selim should be detained till submission of the police report to prevent him from anti-state activities. the report added.

Defence lawyers submitted four separate petitions for his bail, treatment in jail custody and division in jail

### New ordinance **Ample scope** to persecute political opponents: AL

Opposition Awami League has sharply reacted to promulgation of the new ordinance for speedy trial of criminal offences, saying this has been done to persecute political opponents at will.

The new law has been introduced hurriedly in the form of an ordinance bypassing the parliament with a motive to 'eliminate the opposition', they said

Under the Special Tribunal for Speedy Trial Ordinance, promulgated by President lajuddin Ahmed on Thursday, the government will list cases to be sent to special tribunals for trial of six criminal offences within 135 days. The offences are murder, rape, possession of illegal arms, narcotics and explosives and

Talking to this correspondent yesterday, some top AL leaders said the authority to select cases will give the government ample scope to persecute political opponents by referring their cases to special tribunals and dropping those of ruling party men.

The ordinance came eight days after the army launched a countrywide drive against criminals.

# Ctg port to have video surveillance system

The Chittagong Port Authority project to install a 'vessel traffic video surveillance system' at the estuary of the Karnaphuli shortly to monitor ship movement and other activities at the outer anchorage in the sea, official sources said.

"The proposed video camerabased surveillance system is aimed at ensuring modern maritime monitoring facilities, combating piracy and smuggling, averting accidents at the port channel and outer anchorage and also checking revenue leakage," a senior official

The project already received a 'go-ahead' from the higher authorities and tender for it would be floated soon. Implementation of it Patenga and the other near Norman would take about six months. Many foreign ports have such

When contacted, Harbour Master of Chittagong Port Quamrul Islam, who heads a committee formed to oversee implementation of the project, said, "When the system is introduced, it will be easy for us to monitor ship arrivals, to avert accidents and to take quick action in cases of piracy. It will also help check revenue leakage by giving a clear picture of ship arriv-

He mentioned that at present they sometimes get misleading reports about arrival of ships and

their stay at the outer anchorage In the first phase, two video cameras would be installed -- one at

point light house to cover the outer anchorage only. Later, three more around the port to monitor the entire port areas including jetty points, Quamrul said.

The new surveillance system would also help detect arrival of 'ghost ships' and help the navy coast guards, law enforcers and customs personnel in their opera-

tion at the outer anchorage, he said. Ship movements are now monitored with 'VHF operation' which is not so dependable, port sources mentioned.

Meanwhile, incidents of piracy in and around Chittagong port have affected its image. In the past nine months of this year, about 30 such incidents took place in the port area.

## **Dredging in Passur comes** to a halt

on September 10 last year for

Chittagong on the pretext of engine repair. The ship left Bangladesh without notifying the Mongla Port Authority (MPA). The MPA failed to bring the
