Gold smuggling at Sylhet airport

Five customs inspectors relieved of duties

Five Customs inspectors had been relieved of their duties from the Osmani International Airport in Sylhet on charge of their alleged involvement with the recent incidents of gold smuggling.

After several big gold hauls in the airport, different agencies of the government reported that a number of officials in the airport are directly or indirectly involved with smuggling. The officers are, Kahirul Enam, Romangshu Bardhan, AK Majid Khan, Md Nasir Uddin, Mazharul Islam and Shafiul Azam.

Finance Minister, State Minister for Civil Aviation and State Minister for Finance made several visits to the airport and discussed the issue of gold smuggling going on in the airport for a long time. On August 13 gold worth about a total of Tk three cr had been seized from four passengers in the airport. The passengers who travelled to Sylhet from Dubai had been caught along with the aforesaid quantity of gold in their possession. They

are, Ekramul Haque Parvez of village West Mollartek in Dhaka, Alauddin of village Doloirmati in Kanaighat upazila, Wahid of Arambag in Sylhet city and Shahabuddin of village Saleswar of Beanibazar upazila.

Detective Branch (DB) of police detected the incident. They claimed that in connivance with the Customs officials, gold had been smuggled into the country. Customs Inspectors helped the four passengers to get out of the airport without any checking, DB police claimed. While fleeing they had been caught outside the Customs Lounge. Later, some of the Customs officials tried to say that the passengers had been ready to pay the government duty against the allowed quantity of gold. They also gave an official report stating such a story. But the DB police told that the passengers should give proper declaration about gold before departing the Customs

But, the Commissioner of Customs in Sylhet told that on the basis of prior information, we nabbed the smugglers with the assistance of DB men. Since then both the departments claimed success

Local entrepreneurs are reluctant to set up industries here due to various reasons including lack of bank loan facility and unabated smuggling along the Indian border in Jhenidah and nearby Jessore and Chuadanga districts.

Jhenidah BSCIC industrial estate now a grazing ground

DELWAR KABIR, Jhenidah

The industrial estate of Bangladesh Small and Cottage Industries Corporation (BSCIC) in Jhenidah is now a grazing ground.

The industrial estate was not developed properly till now though the BSCIC authorities started development activities in 1988on 15.70 acres of land near Dhanharia village, about three- kilometre east of the Jhenidah-Magura highway. An amount of Tk 2.56 cr was spent for earth filling, pump house, construction of link road, office building and drains in 1998.

BSCIC sources said they planned allotment of plots like 61 A type, 25 B type and 11 special (S) type ones among the entrepreneurs . But till October 20, only 31 A type, eight B type and nine S type plots were allocated for 32 industrial units.

Only five unit owners started operation for a nursery, one textile industry, one tyre retreading unit, two chemical fertiliser factories. The tyre retreading unit has been closed for more than a year. Now only four industrial units exist in the BSCIC estate.

Some entrepreneurs told this correspondent that they are least interested in establishing industries here, because of unabated smuggling of goods from the Indian borders along Jhenidah, Jessore and Chuadanga districts. Furthermore, easy bank loans for establishing industries are not available, they

ained. Hoodlums are also a constant threat here, they added.

When contacted with the BSCIC authorities, they further informed that for want of budget, they have been facing problems. They are not in a position to repair the pump house which went out of order a few months back. For want of money they can not clean the drains, maintain the roads and other works.

One estate officer, a technical officer, an accountant, a guard, a peon and sweeper have been posted by the BSCIC authorities, but since 1998 they are being deprived of their monthly salaries. As the project ended on June 30 in 1998, they have to depend on lump sum allocation of the authorities. It has been hampering normal activities of the estate, BSCIC

An entrepreneur requesting anonymity said some entrepreneurs from Jessore, Kaliganj, Narail, Chittagong, Kushtia and some other places received plots to establish industries.

He further complained that he sought loan from the Shilpa Bank at Jhenidah. But the Shilpa Bank authorities did not grant loan amounting to Tk five lakh which he applied for. While talking to the manager of Bangladesh Shilpa Bank at Jhenidah, he admitted the fact and said they cannot grant any loan proposal below Tk 50 lakh. The bank only grants a big amount of money to big entrepreneurs, the managed informed.

Four sued in Khulna for misappropriation of Tk 69.65 lakh

The Bureau of Anti-corruption (BAC) has filed six cases against four people for misappropriating nearly Tk 70 lakh through forgery from an Agrani Bank branch.

As per the case, lodged with local police, Lutfor Rahman, a godown keeper of the bank on the city's labal Road, in collusion with some income tax officials embezzled over Tk 69.65

Heroin, phensidyl recovered
