Ziauddin Ahmed Jewel, son of former Awami League lawmaker Kamal Ahmed Majumder, and four others were sentenced to 40 years in prison yesterday, nearly two vears after they shot dead Ifekher

trader, in the city's Banani area. Another accused in the sensational murder case was given three-

vear rigorous imprisonment. Besides Jewel, the others jailed for 40 years are Naimuzzaman Zobayer, Shafiul Alam, Joy Hasib, Kazi Sharif Ahmed Saikat. The one sentenced to three years in jail is Kazi Arif Ahmed Sagar, Saikat and Sagar are brothers.

Three of the convicts -- Jewel Zobaver and Shafiul -- have been absconding since the murder of Shipu and they were sentenced in

The Inter-Service Public Relations (ISPR) in a press release yesterday said the reports published in different newspapers on the death of police constable Kalachand Tripura of the Rajakhali police camp under the Pekua Police Station in Cox's Bazaar were not correct.

US concern at army drive

11 die as bus falls into canal in Faridpur

UNB, Faridpur

At least 11 people were killed and 20 others injured in a road accident at Dhuldi on Faridour-Daulatdia highway vesterday

Police and witnesses said a Jessore bound passenger bus from Narayanganj fell into a canal braking the railing of Dhuldi bridge at about 2.15 pm as driver lost control over the steering.

Army, police and fire brigade personnel rushed to spot and recovered 11 bodies from inside the bus. which was under water till 6 pm.

The injured passengers were rushed to the Faridpur Medical

College Hospital. Of the dead, driver of the bus Abdus Salam, 35, and two children -Yeanabi, 11, and Laboni, 5, -- were

Verdict not fair, says Shipu's wife

Khaleda Iftekhar, wife of slain businessman Iftekhar Ahmed Shipu, has rejected the judgement in her husband's murder case as "totally unacceptable".

The brother of the victim who is also complainant of the case said he would appeal with the higher court against the verdict.

Talking to The Daily Star at her Banani residence in the city, Khaleda commented that her family was terribly disappointed with the verdict and that they have been deprived of fair judgement.

Khaleda further said their two children are now unable to comprehend what they have lost and what has been done to address it. But as they will be growing up they would realise that the killers of their father escaped capital punishment. The convicts should have been handed out capital punishment as they were directly involved in the killing, Shipu's wife observed.

The verdict was sympathetic to the accused, not to the victim or his family, she said. Shipu's mother Rabeya Ahmed was too sick to comment on the verdict.

Shipu's brother Ishtiaque Ahmed told The Daily Star in his Banani residence that he was 'not at all happy with the verdict'. He said he SEE PAGE 11 COL 6

Army recovers AK-47, M-16 from Ctg

The army seized eight sophisticated weapons, including an AK-47 and an M-16 assault rifle, from the border areas in the hilly district of Khagrachhari yesterday, the 14th day of the countrywide crackdown on criminal.

Also yesterday, the residence of a former state minister was raided in Khulna and a listed criminal and

accused in a sensational murder case was arrested from Fatikchhari in the Chittagong Hill Tracts.

In the capital, meanwhile, troops picked up three Jatiyatabadi Chhatra Dal (JCD) activists, including the vice-president of the party's Narail unit, from the south gate of the Bangladesh Secretariat.

Our Chittagong correspondent reports that an army team seized a cache of illegal arms and ammuni

tion from a Kanchannagar tea garden in Fatikchhari.

The AK-47 and the M-16 aside, the seizure list includes two singlebarrel guns, a cut rifle, a light gun and huge ammunition plus an arms carrying pouch.

During another raid in the same area, the troops arrested Nurul Abedin Paran, accused of killing Advocate Nurul Islam in Laxmipur. SEE PAGE 11 COL 4
