Lessen losses of natural calamities for poverty cut

BSS, Dhaka

Experts of disaster management, representatives of donor agencies and researchers at a meeting on Poverty Reduction Strategy Programme (PRSP) here yesterday underlined the importance on reduction of risks of natural disaster and lessen overall losses of natural calamities for poverty eradication.

They said mitigation of disaster and national economic devel-

opment are very much correlated with each other. So, losses derive from natural disaster and its risks should be downgraded to ensure sustainable economic growth as well as for its expedition, they added.

Disaster Management and Relief Minister Chowdhury Kamal Ibne Yusuf presided over the function while Relief Secretary MM Mozaharl Hoque presented the PRSP proposal at the meeting, a press release said.

Secretary, Economic Relations Division (ERD) Anisul Hoque Chowdhury, Secretary, Rural Development and Cooperative Division Dhiraj Kumar Nath, member of the Planning Commission Dr. Momtaz Uddin, researchers on disaster management from different embassies, experts and representatives of the non-government organisations took part in the discussion.

Speakers said poor people comparatively, are victims of most of the natural disasters including flood, cyclone, water surge, and erosion.
