Deadlock at Vigarunnisa University Guardians seek PM's intervention

Guardians of 133 students of Vigarunnisa University have sought intervention of the prime minister for resumption of academic activities of the university.

The frustrated guardians made the appeal at a press conference at Dhaka Reporters Unity auditorium yesterday after they failed to have any cooperation of the authorities concerned in this regard.

The university was closed on September 13 following scuffle between the University Foundation and the School and College Governing Body.

After the closure, signboard of the university was removed, construction work of university building was stalled and the school governing body is not letting students

"Whenever we call them over telephone to know the situation, members of the governing body say addressing the press conference.

The University Foundation gave us so far eight dates for reopening the university but failed, he said alleging that none of them disclosed the fact.

The foundation told us twice that a new building would be constructed at Moghbazar but denied later, said Shegufta, a first batch student of English.

Some guardians said the tussle between the foundation and the governing body erupted over the construction of the 22-storied university building which ultimately

"We studied in the school and college for last 12 years but our teachers now do not hesitate to misbehave with us whenever we go there", said Naushin, another first batch student of English.

Plan to integrate donors in arsenic mitigation

The Local Government Ministry is preparing a national plan to integrate all donor agencies working for mitigation of arsenic contamination for well-coordinated efforts in this regard.

LGRD and Cooperatives Minister Abdul Mannan Bhuiyan disclosed this when a 6-member delegation of the World Bank called on him at his secretariat office yesterday.

He said currently a number of organisations and donor agencies including DANIDA, UNDP and WB, are working separately for mitigation of the arsenic problem in the country but those isolated efforts are not bringing satisfactory results.

As the arsenic contamination is detected in the ground water of almost all parts of the country, a coordinated effort is a must for resolving the problem urgently, he added.


