2 more die after release by army

Another person died at the Dhaka Medical College Hospital (DMCH) yesterday after he was arrested by army on Saturday at Tejkunipara in the city and released after interrogation the following day.

And in Barisal, one Yunus Shikder, who was arrested during the anticrime drive on October 30 from Jharnabhanga village under Mehendiganj police station, died at the Barisal Medical College Hospital (BMCH) on Wednesday. He was in jail custody.

Meanwhile, army arrested seven people in the capital including the organising secretary of the central committee of the opposition Awami League's (AL) student front Bangladesh Chhatra League (BCL). A wardlevel AL leader was also arrested in Malibagh.

The latest deaths pushed the casualty figure in the ongoing Operation Clean Heart up to 22.

The dead, Rashedul Hasan, 33, son of Abdul Khaleque and a resident of 201 Tejkunipara in the city's Tejgaon area, was an assistant film director. According to family sources, an army team went to the Tejkunipara residence, which is owned by his uncle Abdul Malek and took Rashed for

Sources said the army later turned Rashed over to the Tejgaon Police

"We expect that in future he (Advani) will not make such comments about Bangladesh for the sake of friendship between the two countries," he added

In late September, the PDB in a letter told the ministry that since the contract between the TPE and the PDB was still not effective, the government must approve release and mobilisation of the equipment to the project

It said the TPE has to pay the huge port charge and demurrage for having kept the equipment for such a long period. The Russian company agreed to the arrangement at an earlier meeting at the energy ministry. But so far, the minutes of the meeting have not been

sent to the PDB The PDB does not have the fund to pay the customs duties and VAT on the equipment. The PDB letter also told the ministry that it needed to be officially ensured that the TPE would pay the duties and VAT or any other taxes on the equipment that the PDB might reject after inspection. The TPE would also have to assure that it

would take back the rejected equipment at its own cost. The ministry then told the PDB to inspect the equipment at the Ghorashal site and arrange fund for the

In such a context, the PDB in its letter last month requested the ministry to request the Planning Commission for Tk 37 crore allocation. At the same time it reiterated its reservations about the project.

Earlier this year, under political pressure the PDB attached some conditions for its accepting the equipment. It said the TPE would have to take a team of five PDB engineers to Russia to verify the origin of the equip ment. Other conditions are that the PDB cannot be held liable 'if any legal proceedings take place in future regarding the TPE project'.

The contract with the TPE signed in May 2000 remains ineffective till date, as the TPE did not pay its first tranche of the supplier's credit. To the contract effective, the contractor needed to pay 10 per cent of the

Seed crisis prompts sales control

Officials asked to list needy growers for fixed-price distribution

The government has asked sales centres and dealers of the Bangladesh Agriculture Development Corporation (BADC) to hold on to their Boro stocks in view of inadequate supply. They have been instructed not to

release their remaining stock unless sanctioned by deputy commissioners (DCs) and district agriculture Meanwhile, the DCs and AOs

have been asked to prepare lists of needy growers to make sure they get the remaining seeds from dealers and sales centres at the govern-

ment-fixed rate of Tk 15 per kilogram. Instruction, in this regard, has also been conveved to the BADC dealers and sales centres.

There have been press reports that Boro growers in different districts came out on streets and laid siege to dealers' stores for seeds at government-fixed price.

Refuting the press reports, Agriculture Minister Motiur Rahman Nizami told some newsmen on Wednesday that there was no crisis of Boro seeds in the country. "It is possible to meet the present demand for Boro seeds as the government, NGOs, other voluntary bodies and farmers have huge

stocks this year. He said there was no reason for concern as the private sector and the government have 'produced or procured' more Boro seeds this year

Official sources said, out of 8,000

MT of Boro seeds available with the BADC this year, around 6.500 MT have already been sold to farmers, in many cases at exorbitant prices, due to hoarding by a section of BADC

Two dealers have been prosecuted in Sunamganj for selling seeds at higher price than fixed by BADC. Supply of seeds for the ensuing

Boro season fell short as the BADC procured 8,000 MT of seeds last year against its target of 10,000 MT as its contract growers produced less due to non-payment of dues for

The contract growers may not produce seeds for BADC next year also as the government is yet to clear their Tk 8 crore overdue bills for last year's seed production.
