The Investigation Officer (IO) of the case submitted a charge sheet against Mostafa Chowdhury and eight others on May 14. The 10 included the names of Nabirul's father Shahidul Islam and he found charges against them

during investigation. All the accused, now on bail, were present in the court during the hearing.

Special Public Prosecutor (PP) Fazlur Rahman Khan appeared for the state while Advocates Sahara Khatun and Habibur Rahman for the accused.




