

### **Cabinet okays** speedy trial tribunal bill STAFF CORRESPONDENT

The cabinet yesterday approved the Speedy Trial Tribunal Bill, 2002 aiming for quick disposal of trial for six major criminal offence murder, rape, illegal arms, explosives, drugs and hoarding.

The bill was approved at a regular weekly meeting of the cabinet held at the Prime Minister's Office with Prime Minister Khaleda Zia in the chair.

The Speedy Trial Tribunal Bill, 2002 is expected to be placed at the Jatiya Sangsad on the first day of the winter session beginning November 14.

Earlier on Sunday, the government formed six tribunals in the six divisional headquarters of Dhaka. Chittagong, Rajshahi, Khulna, Barisal and Sylhet to try the six varieties of cases.

# 73-year old picked up by army dies in jail custody

An elderly person, who was picked up by the army on November 2 morning and handed over to police later in the day after interrogation, died Sunday evening. He was in jail custody. Our Tangail correspondent reports that an army team

picked up Abul Kashem, a 73-year-old farmer of Bhagura village under the Dhanbari police station, from his residence at around 6:00am on November 2. Next day, he was produced before a first-class mag-

The main opposition Awami League (AL) has opted for direct election to form its new central committee in the upcoming triennial central council.

The decision was made at an important meeting of the AL Central Working Committee (ALCWC) in the city vesterday.

This would be the first time since 1981 the AL would have a new central committee to be elected by grassroots councillors. Since the return of party President Sheikh Hasina in 1981 ending her six-year self-exile, the party councillors in

the previous councils of 1983, 1987, 1992 and 1997 delegated power to the party head Hasina to select party leaders including the general secretary.

The major policy shift, which political analysts view as fallout of the party's debacle in the last general election, has been widely acclaimed in the party rank and file. It is also seen as a major step toward the pursuit for practising democracy within the party.

The process of democratisation within the party began earlier this year when the party succeeded in electing new leaders for its student wing, Bangladesh Chhatra League

(BCL), through direct polling by student councillors from across the country. Sheikh Hasina chaired yester-

day's two-and-half-hour meeting of the 67-strong ALCWC at the party's Bangabandhu Avenue headquarters.

Later, AL presidium member Abdul Jalil briefed newsmen about the outcome. Jalil said a threemember election commission was formed to oversee the voting in the coming council, dates of which have been deferred.
