## SSC system may undergo changes

Grading system will be introduced in Higher Secondary Certificate (HSC) examinations from next year and the existing system in Secondary School Certificate (SSC) examinations may be changed

In SSC, the difference of marks between 'A' and 'A +' may be reduced to 10 from present 20 and a new slab -- 'B+' -- may be introduced

Marks obtained in fourth subjects may be counted in determining the Grade Point Average (GPA), which is not done now.

The education ministry is working on proposals on grading system, made by Prof. Mohammad Junaid, Chairman of Dhaka Education Board, sources

The ministry has also received proposals from different educational institutions and heads of organisations working on the education sector for

changing the grading system in SSC, they said. The present grading system disheartens brilliant students as it fails to accurately assess merit, they said, reflecting views of teachers and guard-

The proposals also include application of different methods for different

papers to assign marks and separate marking for two papers, the sources

When contacted, Education Minister Dr. Osman Farruk said, "The grading system will be introduced in Higher Secondary Certificate Examinations (HSC) after necessary modification and improvement"

He said there are some problems in the grading system 'but we will continue the system by making necessary changes'.

Prof. Junaid said in his proposals said the big difference of marks between grades in SSC examinations is creating problem.

A student getting 79 marks is now bracketed with a student scoring 60 marks. This is a big difference. Merits of the two students are not same. This evaluation even affects academic life of students, he said. The proposals said students can be more benefited if Bengali first and

second papers and English first and second papers are evaluated sepa-Students have become rejuctant to take a fourth subject as its marks are

not included in the result. In many educational institutions, teachers of fourth subjects can lose their jobs.

The grading system in SSC was introduced in 2001.

### One to die for killing wife

One person was sentenced to death by a court in the city yesterday for killing his wife for dowry.

Judge AHM Mustaque Ahmed of the First Additional District and Sessions Judge's Court, Dhaka sentenced Faruque Zaman alias Jashim to death for killing his wife Taslima Akhter alias Khushi. He was convicted under Section 302 of the Bangladesh Penal Code (BPC).

Jashim killed his wife at their use at South Shaota Manikganj on August 20, 1999 as her mother failed to give him Tk 25,000 as dowry.

The verdict said the convict can file an appeal with the High Court within seven days of delivery of the

Jashim is the son of one Anisuddin. Taslima Akhter Kushi is the daughter of one Rupban of

Talbagh Bank Colony in Savar. A day after the killing, the victim's maternal aunt Maina had filed a murder case with Savar thana

accusing Jashim. The investigation officers of the case submitted charge sheet against Jashim on August 1, 2000.

The court framed charges on February 22 last year and the trial began on March 23. Fourteen prosecution witnesses were crossexamined.

#### 14 Khulna JCD leaders acquitted of Shibir leader murder charge

The Additional District and Sessions Judge's Court, Khulna, on Saturday acquitted all the 14 charge-sheeted accused in Shibir leader Abul Kashem Pathan murder case.

Abul Kashem Pathan, assistant general secretary of Government BL College students' union was gunned down on the campus of Khulna City College on October 23,

A murder case was filed with Khulna thana by Shibir leader Murad Hossain the same day.

Fourteen leaders of district and city units of Jativatabadi Chhatra Dal (JCD) were named in the FIR as accused in the murder case. Of them, JCD central vice-president Wahiduzzaman Chanchal was murdered in 1998 as a sequel to intra-party rivalry.

The rest 13 charge-sheeted accused are Shafigul Islam Hossain, Arifuzzaman Apu, Mehedi Hasan Mintoo, Shafiqul Alam Tuhin, Belal, Tiku, Murshid Kamal, Hasanur Rashid Miraj and Shaikh

## **Green Road blues**

## Traffic tangle and digging define the thoroughfare

It has been quite a while since people living on and around Green Road in the capital found the ride not as bumpy and road as dusty or muddy as it is now.

That this was the reality only three years ago may sound ridiculous for those who have to cover their face choking in dusts and sulk being stuck in traffic tailbacks. Come rain or shine -- the dread-

ful Green Road, spanning the stretch between Panthapath and Science Laboratory crossing and its surroundings, is playing on the patience of commuters and pedestrians alike. Weekdays or weekend, this dug-out road tests the limit of both man and machine.

You might mistake it for a marshland rather than a road when it rains

in the area. The road remains waterlogged for at least 15 days if it rains for even a day. Even when it is not raining, the pockmarked road along with sloughs makes it impossible for commuters to travel through.

The repulsive rubbish, mud and rainwater, and potholes and traffic tangle make it a hellish place to be. It does take toll on the business.

"We lost a number of clients since it is annoying for them to come to this place during rains," says Shyamol Kumar Dey, of Sagarika

Driving to Green Road tuns out to be a tough task even for the most skilled of driver. "Incidents are there when the sloughs make motor cars immovable." said Altaf Hossain, a businessman on Green Road

Areas close by like Crescent Road, Kanthalbagan Bazar Road, Central Road, Free School Street, part of Kalabagan and especially Bhuter Gali are no good either. Snarls are a sure sight since most of these roads are as good as narrow

To make matters worse, the city corporation has dumped huge concrete pipes on one side of the road. These drainage pipes take over almost half of the road, reducing it to an alley. "These pipes are here for last seven to eight months," points out Saikat Hasan, shopkeeper at Busy Buy, a department store on Green Road. He also says the worn-down road has caused a
