Dicey DCC deals

Official-outsider nexus manipulates Tk 50cr road repair work

Some officials of the Dhaka City Corporation (DCC), working in tandem with a group of outsiders, allegedly manipulated appointment of contractors for a Tk 50 crore road carpeting work. DCC sources said. The tender committee passed

the work order of the project on October 31, while the mayor was on an official tour of China. And two of the DCC officials who are allegedly involved in the scam had earlier faced disciplinary action for corrup-

tion after internal investigations. schedules to get the work on the Official sources said that on September 20 the authorities published the tender notice of the work of the mechanical engineering division-2 in five 'obscure newspapers', so that the DCC-enlisted 800 contractors were left out of the

Cabinet okays

The cabinet yesterday approved three bills for amendment of existing arms, explosives and drugs control laws.

The bills - the Arms (Amendment) Act, 2002, the Narcotics Control (Amendment) Act, 2002 and the Explosive Substances (Amendment) Act, 2002 - provides for completion of inquiry into relevant offences in 30 days.

If the inquiry is not complete within the timeframe due to unavoidable circumstances, a maximum of seven more days will be allowed.

In such a case, the investigation officer will have to explain in writing to the court why he or she has failed to complete inquiry within the stipulated time.

Prime Minister Khaleda Zia presided over vesterday's meeting at the cabinet room of the Prime Minister's Office (PMO).

Cabinet members and state ministers in-charge of different ministries aside, the cabinet secretary and the principal secretary to the prime minister were also present at the meeting.

The Awami League yesterday walked out of the Jatiya Sangsad protesting introduction of a bill titled The Speedy Trial Tribunal Act, 2002" in the parliament, which the opposition party described as a black law

The AL lawmakers, led by the Leader of the Opposition Sheikh Hasina, walked out of the House angrily as Speaker Jamiruddin Sircar allowed Law Minister Moudud Ahmed to introduce the bill amid noisy protests in the opposition bench.

Moudud tabled the bill seeking speedy trial for certain offences,

The AL said the proposed law would be violative of the constitution and would create discrimination in the process of trial in the country.

requested the speaker to withdraw the speedy trial tribunal bill and another on setting up of a police staff college, which she said contained an untrue statement. Hasina and some other opposi-

tion lawmakers also feared that the proposed law would be abused politically since it would authorise the government to select cases to be tried in the proposed tribunal.

The proposed law suggests that the government will choose criminal cases involving murder, rape, and possession of illegal firearms, explosives and narcotics for speedy trial in a maximum of 135 days.

The Nagorik Committee has said the country's proven gas reserve is about 6.2 trillion cubic feet (tcf) and projected reserve around 5.8tcf. With this amount it is possible to meet domestic demand only till 2014.

Whatever amount of gas the country may decide to export, it will only bring forward the time for importing the same at a higher cost since the total volume of gas is guite low, the committee members said at a press briefing at the Dhaka Reporters Unity auditorium in the city yesterday.


