# Main accused in Goswami murder case nabbed

City roads now teem with thousands of rickshaws, mostly illegal, clogging

traffic and making futile police department drive to streamline them

Detectives on Sunday evening arrested Zillur, the principal accused in the schoolteacher Swapon Kumar Goswami murder case.

Zillur, who remained absconding since the schoolteacher was shot dead at North Road in the city's Bhutergoli area on October 26, was arrested on the eighth floor of the Eastern Plaza at 5:30pm on Sunday.

He was taken to the Detective Branch (DB) headquarters and held there in custody till he was produced before the Chief Metropolitan Magistrate's court, Dhaka, at 3:00pm yesterday with a prayer for a seven-day remand. Magistrate Mamun-al-Rashid granted a three-day remand for interrogation.

### DMCH nurses go on strike

Nurses at the emergency of the Dhaka Medical College Hospital (DMCH) went on a wildcat strike yesterday afternoon, after one of their colleagues was beaten up by the police at the entrance of the emergency.

The strike call was given when a constable of Mohammadpur police station, attending an injured patient, beat up an on-duty male nurse, who had failed to arrange a trolley for the patient.

The strike, however, lasted until 7:30pm. The director of the hospital Brigadier General Nazmul Huda and SEE PAGE 11 COL 1

number of criminal cases including those involving three murders.
Police had earlier arrested six

persons in connection with the killing of the schoolteacher Swapan of the Government Laboratory High School. Four of them -- Swapan's two students SM Sabbir Rahman Shantanu and Tanvir Sharif Apon, and Rifat and Johnny -- were remanded.

Police had also arrested the father of Shantanu, Moshiar Rahman. He was later released on bail. Biplab, another accused in the case is still absconding.

According to the confessional statements of Apon, Rifat and Shantanu, the premeditated murder of Swapan was carried out by Zillur who fired three shots on the schoolteacher as he was on his way to school in the morning of October 26. Shantanu and Apon were also present at the murder spot.

Shantanu and Apon were students of class VII at the Government Laboratory High School while Rifat was a class X student at New Model School.

## Programme to protest 'gas export move'

### 2 Jubo League activists jailed in Khulna

Two Jubo League activists were convicted yesterday in a criminal case under the Speedy Trial Act and awarded five years of rigorous imprisonment (RI) and a fine of Tk 5,000 each, or another year of RI in case of non-payment.

The convicted are Ahsan Habib and Babu. Magistrate Moinul Islam of the Speedy Trial Court handed down the verdict.

The prosecution case in brief is that the accused, on September 6 this year, demanded a toll of Tk 20,000 from the acting registrar of Khulna University Prof Amir Ali and threatened to kill him if he failed to pay. The following day on September 7, the accused went to the Khulna University to exact the money when they were caught and handed over to the police of Batiaghata Thana.
