Deport criminals Dhaka asks Kolkata, shocked at release of 7

The Bangladesh mission in Kolkata, in a letter, has requested the West Bengal government to hand over the two top criminals arrested in Kolkata last Saturday.

Meanwhile, a top official of the foreign ministry expressed the government's frustration at the release of seven other criminals after their arrest by the Kolkata police.

"As per diplomatic norms, the West Bengal government should have informed Bangladesh about these arrests," he said expressing his disappointment over the handling of the issue by the Kolkata police and the West Bengal govern-

On Saturday night, the Kolkata police arrested Liaquat, Arman, Kala

Abbas and four others from the city's New Market area. However, they later released all excepting Liaquat and Arman

The West Bengal government or the Kolkata police did not convey the message to the office of deputy high

commissioner till Tuesday. However, Bangladesh was officially informed vesterday.

Meanwhile, the deputy high commissioner requested the West Bengal government to hand over the most wanted criminals to Bangladesh so that they could be tried under our laws.

The foreign ministry official

"the Kolkata detective chief could pass the information to the local press, yet he could not inform our deputy high commissioner. This is not acceptable.

He further pointed out that the detective chief even claimed to have handed over the seven criminals to Bangladeshi authorities, "How could he lie so blatantly? The deputy high commissioner does not know anything, yet they have been handed over to us!

"How could the police release someone with a name like Killer Abbas? It's the police who gave the names of the released criminals to the press." he noted.

Indian press on wrong track

A section of the Indian press is apparently trying to corroborate an international campaign that Bangladesh is a haven for al-Qaida

and other terrorist networks. At the same time, it is also trying to portray Bangladesh as an anti-Indian nation.

The news coverage on the arrest of Liaquat Hossain and Arman Khan in Kolkata show how misinformed some of the leading publications

Both Liaquat and Arman are top criminals of Bangladesh. They are wanted for murder, extortion and all sorts of criminal activities for many years. They are not known to have any links with any fundamentalist

But newspapers like The Telegraph, Anandabazar Patrika, Sangbad Protidin and a host of others described Liaguat, Arman and other criminals arrested

'Limited autonomy' for central bank

Tk 5 lakh fine proposed for divulging bank info

The central bank is finally going to get autonomy, albeit limited as it appears now.

A committee to be headed by the Bangladesh Bank (BB) governor would recommend monetary policies, but the BB would seek the finance ministry's approval for their implementations.

The committee would include

Instead of the finance ministry, the governor would be accountable to the standing committee of the parlia-

The decisions were taken at the first meeting of the cabinet committee on amendment to banking laws held yesterday at the Secretariat.

The committee reviewed the Bangladesh Bank Order, 1972, Bank Company Act, 1991 and the

Order, 1972 in the meeting chaired by Finance and Planning Minister M Saifur Rahman.

As an amendment to the Bank Company Act, 1991, the committee has proposed inclusion of two depositors in the boards of commercial banks to protect their interest.
