tourist visas. All the three were extensively interrogated before they were brought to the capital early yesterday morning.

Police also seized from the journalists passports, a video camera, 10 videocassettes and some other documents. Police kept them at the Detective Branch (DB) headquarters at Minto Road in the city before producing them before the Chief Metropolitan Magistrate's (CMM) Court, Dhaka at about 1:30pm.

Additional police forces were deployed at the court premises from early morning to avoid any untoward incident. Tight security was there at the courtroom during the hearing.

Police prayed to the court for a 10-day remand for each of them. DB inspector Mizanur Rahman told the court that the two journalists had flown in at Zia International Airport (ZIA) on November 6 concealing their professions and real identities.

"They showed fake ID cards to the immigration officials on arrival at ZIA. They interviewed and took video footage of one Habibur Rahman at the North Gate of Baitul Mokarram on November 15," he further informed.

Before leaving Dhaka for Chittagong, Rahman continued, the two journalists also recorded statements of several people and took footages of the Baitul Mokarram National Mosque.

They also gathered information about the mosques and madrassahs in Dhaka.

The DB inspector further informed the court that Sorrentino and Zaiba Malik left Dhaka for Chittagong on November 18 and stayed at Faisal Hotel. During their stay, they went to the residence of slain college principal Gopal Krishna Muhuri, talked to his family members and relatives, and recorded their statements. They also exchanged views with a Chittagong correspondent of the Daily Janakantha.

He said, "The two journalists and their local guide also visited Cox's Bazar, Kutubkhali of Ukhia and Manikchhari of Khagrachhari and collected various information."

"They also met some religious devotees of the areas and recorded their information tactfully. Their motive was to give a distorted image of the present political, social and religious situation of Bangladesh and to portray the religious devotees as fundamentalists like the Taliban and Al-Qaida to the foreign

Call for new action plan for education

City seminar expresses concern over quality downslide

Speakers at a discussion yesterday expressed concern over sagging standard of education standard and asked the authorities concerned should detect the pitfalls and drawbacks of the National Action Plan-1

They were participating in a seminar, titled Engendering National Plan of Action II for Education For All (NPA-FFA), organised by the Campaign for Popular Education (CAMPE) and the Women for Women in cooperation with the Royal Netherlands Embassy and the Swiss Agency for Development and Cooperation (SDC). Bangladesh.

Nurul Islam Khan, NPA-EFA consultant for primary and mass education department, presented the NPA draft.

Professor Rehman Sobhan, chairman of the Centre for Policy Dialogue (CPD) who was chief guest at the seminar, identified the structural weaknesses responsible for the failure of the NPA

He called upon the non-

governmental organisations (NGOs) to establish 600 schools of quality education and asked donors to mobilise grants to construct toilets for female students so that their attendance may increase.

Mahfuz Anam, editor of The Daily Star, who attended the seminar as a special guest, expressed his frustration over the deterioration of the quality of education. He said lack of qualified teachers

and teachers' training is one of the reasons for the decrease in education standard. He also said one should look into

the NPA-1 and find out why it failed to yield to better results before adopting another action plan.

The Daily Star editor mentioned he would take measures to bring out an education page in his daily to work as catalyst towards quality education

He suggested forming an advocacy group comprising educationists and media people for creating a positive rapport in the society. Nurul Islam said the NPA-1

aimed at establishing a knowledgebased and technology-oriented learning society for all. Islam proposed the establish-

ment of a reliable and verifiable database with Management Information System (MIS) and Geographic Information System (GIS) interfacing with the nonformal sub-systems, both in the public and NGO streams.

He suggested providing adequate facilities, including separate and well-maintained toilet facilities for girls and boys and revising and updating curriculum keeping in mind the new technology era with its information superhighway. Islam also underscored the need
