

Zakat stampede kills 37

70 more hurt as people jostle for money, clothes in Gaibandha

At least 37 people, 33 women and four children, were killed and 70 others injured yesterday in a stampede when several thousand poor people jostled frantically to collect Zakat clothes and money at Godown Road in Gaibandha town, some 190 kilometres northwest of Dhaka

Our Gaibandha correspondent reports that the stampede took place at 6:30 in the morning at the gate of an abandoned jute mill where thousands of poor people had queued up to collect the clothes and money.

As the impatient crowd forced the donors to open the mill gate and begin distribution well ahead of the 10:00am schedule, those up front were pushed from behind, fell onto the ground and were trampled. As many as 33 women and four children died on the spot while 70 others sustained iniuries

Police however admitted to death of 30 people. Twenty of the injured were admitted to local hospitals.

Zakat is a mandatory annual Islamic donation system in which the welloff give the poor a portion of their wealth ahead of the Eid-ul-Fitr. As it often leads to chaos, the government encourages donations through a recently established government Zakat Fund. However, most people do not go by the government system.

BB discards redundant wings

As part of its reforms programme, the Bangladesh Bank (BB) vesterday merged four divisions with others and transferred nine general managers. The agriculture loan division, project loan division, and industrial loan

division have been merged together into a new agriculture loan and specia programme division.

The problem bank monitoring division has been merged with the department of banking operation and development.


Justifying the merger, the BB said there were seven banks being monitored by the division as problem banks. But two of them have already graduated from the status and a few more are on their way out.

As such, the workload of the monitoring division has diminished to a large extent, which does not justify its independent existence.

On the other hand, the BB has abolished the system of directed agricul-ture loans. Except Bangladesh Krishi Bank and Rajshahi Krishi Unnyan Bank, recapitalisation against agriculture loans has also been abandoned.

At the same time, the industrial and agricultural loan programmes financed by the Asian Development Bank and the IDA have ended and, as such, the credit guarantee division does not have any work. Therefore, the departments needed to be merged

Because of the mergers, the nine general managers have been transferred to different departments. However, the BB did not take any decision on the surplus manpower the reforms have created.

Writs filed against arrest of foreign journalists

The two foreign journalists and their local quide, arrested on a sedition charge, yesterday filed three separate writ petitions with the High Court challenging their 'illegal' confinement and detention and to be produced before the court within 24 hours.

Lawyers of Italian Led Poldo Brono Sorrentino and British Zaiba Naz Malik of Channel-4 TV network of Britain, and Moniza Pricilla Raj, their local guide, moved the writ petitions.

The lawyers of Saleem Samad, the Bangladesh representative of the Paris-based Reporters Sans Frontiers, also filed a writ petition.



102 bodies to sniff out arms licence flaws



The government has formed 102 committees to investigate if licences of arms and ammunition were issued in compliance with the law. An official estimate says that

there are 1,89,265 licences of arms issued to individuals, shooting clubs and financial institutions The committees were formed, as

a large number of licensed arms were not deposited till the November 21 deadline

Manirul Alam said the committees were instructed to submit reports by January 9

They will examine whether the rules were complied with in issuance of licences and collection of arms and ammunition

Everything will be examined seriously, as there are many allegations of the criminal use of licensed arms and ammunition. Alam said.

The PIO said that 27 committees were formed for Dhaka, including 16 for 22 police stations in the Dhaka metropolitan area, five for others of the district, one for the arms deposi

Odhikar report 202 killed by BSF, Indian criminals in last 2 years STAFF CORRESPONDENT

Incidents of human rights violation by the Border Security Force (BSF) and some criminals of India have accounted for death of 202 Bangladeshis in the last two years. Besides, 302 people were

injured, 170 arrested, 187 abducted and 30 people were missing during the period. Moreover, the BSF and the criminals were responsible for 22 incidents of looting cattle and crops, according to a report published by Odhikar, a human rights

The report is based on media information on violation of human rights
