A four-member appellate division bench headed by Chief Justice Mainur Reza Chowdhury passed the order upon an appeal against the High Court order.

Water Resources Minister and close relative of Bangabandhu Sheikh Muiibur Rahman, Abdur Rab Serniabat was killed along with eight members of his family on August 15, 1975 at his Minto Road official residence in the city.

The accused pleaded not guilty and demanded justice before the

fixed January 18 for trial of the case. In the case filed with Kafrul police station, it has been alleged that Prof Mostafa Chowdhury, Forhad Hossain Khan, Kabirul Alam Khan and Sharfuddin Ahmed Khan were involved in illegally allowing Syed Nurul Islam another accused in the case, to participate in the 20th BCS examination under the "freedom fighters" children's quota, producing fake documents. Nurul Islam allegedly submitted papers showing him as a son of freedom fighter although his father was not a freedom fighter.

The four accused also helped Nurul Islam to get the post of assistant police super, the FIR said.

Non-payment of VAT

Legal steps against 59 real estate companies soon

The government is going to take stern action against 59 real estate companies for 'not paying' around Tk 26 crore in value added tax (VAT) for long.

Certificate cases will be filed against these companies to realise the overdue amount, according to National Board of Revenue (NBR) sources

An NBR investigation recently revealed that these companies did not pay VAT, an allegation contested by

The government excluded the real estate sector from paying VAT in the current budget. But a huge amount remained overdue against their previous transactions,

These firms were served with demand notices and reminders for VAT payment without any result, the

When contacted, President of the Real Estate and Housing Association of Bangladesh (REHAB) Dr Toufig Serai said the VAT remained unpaid because of dispute over assessment.

He told The Daily Star that the housing companies are ready to pay the overdue VAT, but demand notices were served upon many companies with wrong assess-

"We are consulting with our lawyers for action against the NBR," he said.

The dispute over VAT assessment arose as the NBR calculated the amount taking into account all the flats under a project without excluding those not sold, he

Some 30 to 40 per cent of flats under any project are not sold at all and the landowner gets them for free in SEE PAGE 11 COL 8

Four in race for post of **AL** general secretary

With the central council less than a month away, speculation is rife within the Awami League ranks about the possible successor to the party general secretary, Zillur

Sheikh Hasina, who has already served as many as five terms as the All president since her homecoming in 1981 after a six-vear self-exile following assassination of her father Sheikh Muiibur Rahman in 1975, is certain to retain the party presidency during the belated council, billed for December 26.

As Hasina faces no challenge for the presidency, competition for the general secretary is the focal point at the moment.

Zillur has already been the general secretary twice - during the period of Bangabandhu and then from 1997 till date. Party workers are now busy working out who will replace him.

Sources in the party hinted that as many as three members of the party presidium - Abdul Jalil, Abdur Razzak and Amir Hossain Amu might become candidates for the

Besides, much to the surprise of the AL old guards, the party's sports secretary Obaidul Kader might also vie for the post, representing the younger generation of party leader-

Though they have not officially declared their candidatures yet, sources told The Daily Star that so far Abdul Jalil stood out to be the most formidable candidate among the old guards, with Kader being a challenger representing the young

Awami Leaguers. Earlier, a meeting of the AL Central Working Committee (ALCWC) on November 11 decided that the party councillors coming from across the country would elect a new central committee of the party through voting on December 26.

Two burned to death inside brick kiln in Rajshahi?

Police vesterday recovered "remains of two living

beings" from a brick kiln near the city. With this, the allegation that two persons were burned to death inside the brick kiln may come true.

"We recovered remains of two living beings from inside the kiln and sent those to experts for confirmation," Rajshahi Metropolitan Police Commissioner Abdul Mannan told newsmen yesterday.

Those were recovered at around 3pm yesterday following a thorough search inside the kiln after putting out the huge fire. The remains are suspected to be those of Ramesh

Sarkar Vedlu, 24, son of Debendranath Sarkar and Siddique Hossain, 30, son of Nur Muhammad of Lalitapur area of the city.

They were missing since they went to the brick kiln at around 9:00pm on November 26. Anawar Hossain Anar, a contractor and local BNP eader, owns the Auto Brick Kiln.

Allegations have it that Siddique's father Nur Muhammad had gone to Boalia thana on November 27 to file a murder case against Anar but police declined to accept a murder case. Instead, they recorded an abduction case

Ramesh's father Debendranath also filed a general diary in this connection on the same night.

Police picked up six workers of the brick kiln for Disappearance of the two persons created suspicion

and anger among local people, who held protest meetings and brought out processions demanding proper investigation into the incident. In the face of public protests, police on November 30 began a search in the brick kiln.

Vigarunnisa University hits a dead end

Govt detects irregularities, revokes licence

The government has cancelled the permission of Vigarunnisa University (VU) home to 133 stu-

The Ministry of Education in a notification on Saturday showed a series of malpractices and cancelled the permission under the Private University (amendment)

The university was established mostly with infrastructure and funds College (VNSC) for a five-year run with some conditions

But upon a VNSC complaint about transfer of its funds and land to the university, the ministry formed a committee to probe the irregulari-

"The committee has recommended cancellation of the permission as it detected numerous malpractices, which breach the condition of the temporary permission, said a key official of the ministry.

Grants Commission (UGC) and the authorities concerned have been asked to cooperate so that the university students could enrol at other private universities.

The notification also abrogated the university's authority to encash Tk 5 crore deposited with a bank. The official said "Government approval will be required to encash the funds.
