NSI also keeping an eye on some local journalists

The government has strengthened surveillance on foreign visitors to check 'spying' in guise of journalists or any other profession.

Highly placed sources in the government said the surveillance decision was taken in the wake of several reports in international media, linking

Bangladesh to al-Qaida network. They said after the arrest of two foreign journalists who entered Bangladesh in disguise the government was 'forced to up' surveillance on

Home ministry sources said the National Security Intelligence (NSI) has been assigned to watch foreign nationals and keep the ministry informed

The NSI is also keeping an eye on some local journalists, who are allegedly involved in dispatching important information to foreign agencies. The government has arrived at this conclusion from the confessional statements of the two arrested foreign journalists. He said the government has no plan to impose any restriction on or obstruct foreign journalists and a local one.

However, Information Minister Tariqui Islam told The Daily Star that the

Foreign ministry sources said instructions have been given to Bangladesh missions abroad never to refuse any visa seekers, but their purpose of visit must be clarified.

The information minister said nearly 40 teams of foreign journalists visited Bangladesh in the past one year and many are now in the country. But none of them were obstructed in carrying out their professional duties.

"The foreign journalists are free to visit anywhere in the country...they are meeting with ministers, opposition politicians and general people without any obstruction," said a high official of the information ministry.

However, a home ministry official said legal action would be taken if anyone s found involved in spying or activities that may destroy the country's image. Some ministers said a section of the international media, particularly the Indian press, is engaged in campaigns against Bangladesh to ruin its image

Sarwan powers Windies

Ramnaresh Sarwan scored his maiden hundred to power the West Indies to a comprehensive 84-run victory over the hosts Bangladesh in the second one-dayer of the Coca-Cola Series at the Bangabandhu National Stadium yesterday.

The 22-year-old batsman from Guyana, later adjudged man of the match, struck an unbeaten 102, helping the visitors recover from a sluggish start to pile up a commanding 266 for four.

The home side was shot out for 182 in 48 overs with only Mohammad Ashraful showing real character on a wicket that was keeping low and slow.

The young sensation scored an authoritative 44 before slashing legspinner Mahendra Nagamootoo to Wavell Hinds at point

The only entertainer for the 20,000 home crowd in the day-night affair, Ashraful won his second battle with fast bowler Jermaine Lawson, who conceded 20 runs in two overs before being taken off the attack Ashraful helped himself to 16 runs from the two-over blitz that featured a

HC refuses to accept writ petitions

The High Court yesterday refused to entertain the writ petitions of two foreign nationals and their two local aides challenging their arrest and subsequent detention on sedition charges. The court, however, disposed of

the petitions with directives to the government to allow the accused persons to consult with their lawyers twice a week and meet their representatives and relatives for supplying food and water. The court also ordered not to

maltreat the detainees during interrogation

A division bench comprising Justice Amirul Kabir Chowdhury and Justice Nizamul Huq passed the orders after hearing both sides

Earlier, Attorney General AF Hassan Ariff submitted the FIR and relevant papers and documents of the case as directed by the court.

Italian national Led Poido Brono Sorrentino and British citizen of Pakistan origin Zaiba Naz Malik working for Channel-4 TV network of UK, Saleem Samad of Parisbased Reporters Sans Frontiers (RSF) and guide Moniza Priscilla Raj moved the petitions.

Soreentino and Zaiba were arrested on November 25 when crossing the Benapole border. Police seized videocassettes from their possession. Guide Moniza was picked up from Goalondu while returning to Dhaka after dropping the two foreigners at Benapole while Salim samad was held from a house SEE PAGE 11 COL 6

Greening embankment still on drawing board

Government inertia has left the green belt project on the 30-kilometre flood-protection embankment from Lalbagh to Aminbazar in Savar hanging in the balance for the last nine years.

Non-implementation of the project has already taken its toll in the shape of frequent land erosion and subsidence at different sections of the embankment. Lack of plantation has also heightened the possibility of floodwater leakage.

According to sources, the project could not be implemented due to lack of co-ordination between the Ministry of Water Resources and the Ministry of Forest and Environment.

The project was designed to protect the embankment from land subsidence and erosion, strengthen its base and maintain adequate humidity in the city air, the sources said.

Officials of the Bangladesh Water Development Board (BWDB) said construction of most parts of the embankment was complete before 1990. The embankment protects nearly 150 square kilometres of the western part of the city from floodwater during the rainv

Sources said, in the 1993-94 fiscal, the government initiated a five-year 'Urban Afforestation Project' for tree plantation in the city, under which the green belt project was supposed to be implemented. The Department of Forest was in charge of implementing the project.

Under this project, in 1995-96 about 32000 saplings were planted along the embankment from Ashulia to Mirpur Botanical Garden, which covered only nine SEE PAGE 11 COL 7

Side by side they have also collected clippings of leading news dailies and magazines and also copies of Hasina's speeches
