HC grants bail to Saber, CMM sends him to jail

Shahriar's statement not recorded as per HC order

COURT CORRESPONDENT

The Chief Metropolitan Magistrate's Court virtually turned into a battlefield yesterday, with lawyers of five recently arrested eminent persons pitted against the prosecutors. The court disagreed with the defence counsels on the interpretation of

nine different orders of the High Court. The police had to resort to baton charge on lawyers and visitors in the

evening to cool off the heat on the court premises. The five persons - Awami League leaders Saber Hossain Chowdhury, Shafi Ahmed and Mukul Bose, columnist Muntasir Mamun and journalist Shahriar Kabir - were sent to jail yesterday after they were produced before

the CMM's Court on completion of their three-day remand each. All of them have been given one-month detention each under the Special

Heated arguments took place at the court when defence lawyers differed with the CMM's Court over some High Court orders issued for Shahriar, Shafi, Saber and Muntasir.

Two disagreements took place each in case of Shahriar, Shafi and Muntasir and three in case of Saber.

The High Court Wednesday gave Awami League leader Saber Hossain Chowdhury ad interim bail. The High Court order reached the CMM's Court on the same day. However, the lower court did not release Saber when the police produced him there at 2:20pm. The lower court sent him to jail under one-month detention.

The HC also instructed the CMM's Court to record verbatim the statement of Saber. This order was issued because previously the CMM's Court SEE PAGE 11 COL 3

Army raids Iqbal's city residence

21 listed criminals arrested across country

The joint forces carried out a threehour on the Gulshan residence of former Awami League lawmaker Dr HBM labal on Wednesday night.

A team of nearly 100 army, paramilitary Bangladesh Rifles (BDR) and police personnel began the raid at around 9:00pm.

Dr Iqbal was hosting a dinner for some private bank officials and

relatives when the joint forces came in. However, he was not arrested.

The AL lawmaker's residence was raided once before in November.

Meanwhile, the army rounded up 90 people, including 21 listed criminals, across the country in the last 24 hours ending at 8.00am yester-

They also seized 16 firearms including two pistols, five revolvers, four pipe-guns and a shotgun and 34 rounds of ammunition. The joint forces seized a magne-

sium flair used for ships from the city's Bijoynagar area at around 11.00am yesterday. In Sylhet an army team recov-

ered five powerful homemade explosives from an abandoned hall of residence at the Madan Mohan University College yesterday.

Sources told our correspondent three explosives fell down from the roof as labourers were pulling down

the abandoned building. Being informed, troops from the

Amartya Sen for human rights-based thinking

A human rights-based thinking is important for a just and peaceful society, said Professor Amartya Sen yesterday.

The Nobel laureate stressed the need for freedom and solidarity among people for implementing human

Legalisation is not the only way to make humar rights İegal', said Sen.

In case of imperfect obligation, no rights can be implemented through legalisation but by advocacy and

nurturing, he said while speaking as a guest of honour at the inaugural session of a two-day taskforce meeting on a Citizen's Social Charter for South Asia. Nurturing, advocating and monitoring human rights

belong to consequential thinking, said Sen. He held illiteracy and lack of consciousness respon-

sible for human-rights violation in South Asia. Organised by the South Asia Centre for Policy Studies (SACEPS) and the Centre for Policy Dialogue (CPD) at BRAC Centre Inn auditorium, the session was

Biswa Ijtema begins today

Biswa litema, the second largest congregation of the Muslims after Hajj, begins today on the bank of the Turag in Tongi.

Sermons by religious scholars began two days before the formal start of the three-day iitema. This year round, Tablig Jamaat

has organised the 38th annual congregation, which will come to an end on December 15 with akheri munaiat Around eight lakh devotees from

home and abroad congregated in an area of about 160 acres until yesterday afternoon, said sources. Organisers look forward to the

arrival of more than 30 lakh devotees on the concluding day. More than 2.500 devotees from 30 countries, including India, Pakistan, Saudi Arabia, Turkey,

Kuwait, England, China, Thailand and Malaysia have already arrived. About 10,000 devotees from 72 countries will attend the iitema this

year, the organisers hope. The ijtema venue on 150 acres has been covered with sackcloth by a large number of volunteers. Tinshed cabins are also being erected for foreign devotees in the north SEE PAGE 11 COL 7

Typical tales of 'torture'

The court yesterday heard similar tales of torture in police custody when Shahriar Kabir, Muntasir Mamun, Mukul Bose and Shafi Ahmed were produced before the Chief Metropolitan Magistrate's Court, Dhaka yesterday.

The four were recently arrested under Section 54 of the Code of Criminal Procedure (CrPC) and were placed on a three-day remand

Writer Shahriar, who was arrested on December 8 by the Gulshan police, told the court that he was not given food for 25 hours after his arrest. He was blindfolded and taken to the joint interrogation cell (JIC). He was also taken to the Cantonment Police Station where he was 'brutally tortured'.

The JIC team questioned him on issues like the alleged anti-state activities by two foreign journalists, the series of bomb explosions in Mymensingh movie theatres and alleged ill motives by the Awami League
