Three people were killed and 21 others injured in two separate road accidents on Dhaka-Mymensingh and Mymensingh-Haluaghat Highways yesterday.

Two people were killed and 21 others injured when a Dhakabound bus was hit by a truck from behind near KNK Textile Mills on Dhaka-Mymensingh Highway at around 1 pm.

One unidentified person, aged about 22, died on the spot while another unidentified passenger, aged about 35, succumbed to his injuries at the Mymensingh Medical College Hospital (MMCH).

Of the injured, seven people were admitted to Bhaluka upazilla health complex

In another accident, a septuagenarian, identified as Rahimuddin, died on the spot when a bus ran over him at Barabila on Mymensing- Haluaghat Highway at around noon.

3 killed, 21 hurt in Mymensingh Hearing of 1996 share scam cases begins today

Three and a half years after filing of petitions by the Securities and Exchange Commission (SEC) against a High Court judgement, the Appellate Division will begin today hearing of the sensational 1996

The capital market regulators on July 25, 1999 challenged a High Court judgement delivered on June 23, 1999 regarding 11 share scam

The cases are against Abu Tayeb, Rakibur Rahman and ASM Sahidul Haque Bulbul of Chittagong Cement, Mustaque Ahmed

Syed Mahbub Murshed, Hemayet Uddin Ahmed and Ahmed Iqbal Hassan of HMMS and Associates Nurunnabi of Rupon Oil and Feeds, Imtivaz Husain of Imtivaz Husain & Company and Rijwan Bin Farouk of First Capital Securities.

In the wake of widespread allegations of market manipulation, the SEC, after investigation, had filed 15 cases with the Chief Metropolitan Magistrates Court on March 27, 1997 against 35 directors of different publicly traded companies and stock market brokers. The cases finally landed in the High Court through various legal processes.

Thousands of small investors lost their savings after share markets nose-dived to an unexpected low after hitting unreasonable

Seven cases were filed against brokerage firms and their officials and eight were filed against listed companies and their directors.

Five of the cases were stayed by the High Court after the companies moved for quashing those. The companies and their accused directors are: A Rouf Chowdhury, Mashiur Rahman, S Chowdhury



Unplanned, unhygienic

Waste dumping in densely populated city areas poses public health hazard

materials found The Dhaka City Corporation (DCC) is dumping waste in an unplanned way at various densely populated areas of the city. The absence of an adequate number of dumping

grounds and the lack of initiative to implement the waste recycling project are responsible for extremely unhygienic garbage disposal in the city.

The DCC is dumping about 5000 tons of solid wastes every day at different places, and the largest of the unplanned dumping is taking place in Mugdhapara, to fill up low-lying areas. That poses a serious public health hazard and a nuisance to the people of the area.

The southern side of the proposed cricket stadium running parallel to the Biswa Road, has become filthy and stinky owning to regular dumping of garbage by the DCC. Farid Ahmed, a resident of Mughdapara, said that activities related to waste dumping continue throughout the day and make life unbearable for the residents. The Mughdapara area is densely populated and due to the presence of such a nuisance, many residents are thinking of moving away from there.

I have decided to shift my house from here because of the garbage and rubbish all around my house," Farid

Sarwar Hossain, another local, termed the DCC's

waste dumping at Mughdapara irresponsible. "It shows that they have no concern and respect for the tax payers. My family members are insisting every day to shift to another place," he said.

While the sufferings of the people continue, the DCC is yet to take any step to launch the waste recycling plant. Although Mayor Sadek Hossain Khoka has time and again pledged to commission the recycling project, sources said that apart from holding 'one or two' meetings, nothing concrete has so far been done.

Director (technical) of the Department of Environment (DoE) Reazuddin said that they have received some proposals from some organizations on waste recycling. They also held some meetings, but due to lack of enough information they could not take any decision'

"As it is a good initiative, we are planning to encourage recycling throughout the country," he added.

The Ministry of Forest and Environment is reported to be doing nothing with at least half a dozen proposals to recycle household wastes and produce energy.

The conservancy department officials said that they are desperately looking for new dumping grounds.

An official of the department said that in the face of

KCC commissioner, N'ganj Jubo League, BCL leaders arrested

The joint forces yesterday arrested Khulna City Corporation (KCC) Ward Commissioner Hafizur Rahman and his "armed cadre" Tuhin from United Club in Khulna

Sources said Hafizur, commissioner of Ward No 17 and wanted in several criminal cases including that for murder, was absconding since the anti-crime began on October 17. The joint forces also arrested Abdur Raquib Mallick, chairman of Senhati Union Parisad under Digholia upazila in Bagerhat district.

In Dhaka city, the joint forces raided several houses at Farashganj, recovered nine firearms with 16 bullets and arrested two persons.

In another raid the joint forces arrested a young man and handed him over to Tejgaon police. Police said the young man was handed over to them in an unconscious condition and they sent him to Dhaka Medical College Hospital (DMCH) in a "critical condition". Hospital sources identified the young man as Jalil but Tejgaon police could neither confirm his identity nor say whether he was involved in criminals activities.

Bank swindle case in Khulna: OC closed

Tozammel Hossain, officer-incharge of Khulna thana where the swindle case involving the Sundarban Foods Ltd (SFL) was filed, has been closed to the police lines with effect from 2:00pm on Thursday.

An official order of the police commissioner said the decision has been taken for greater public interest. But a reliable source of the Khulna Metropolitan Police (KMP) said the OC has been fired for helping the SFL chairman escape from her residence on Wednesday night to avoid arrest in connection with the Sonali Bank's 80 lakh taka swindle case. The chairman is wanted by police as a suspect in the case, which has created a sensation in the metropolitan city's banking

Sources alleged that SM Abul Hossain, the managing director (MD) of SFL and its chairman are involved in swindling out Tk 80 lakh from the corporate branch of Sonali bank at Khulna on December 4.

A high official of the bank alleged that the SFL MD and his close relatives carried out the swindle in a planned manner, adding that the same group of people including the MD's brother were involved in past financial scandals in connection with the shrimp export trade. The MD's brother SM Amjad Hossain is the managing director of Lockpur Fish processing Ltd. Amiad Hossain is the husband of the absconding SFL chairman, said the investigation officer (IO) of the case.

The IO is already under heavy police pressure to tamper with the case so that the outcome is in favour of SFL, said a reliable source of

Meanwhile, corporate branch of Sonali Bank has stopped any further payments to SFL for the time being.

According to DGM Abul Bashar Akhand of the corporate branch of Sonali Bank, SFL authorities did not inform the bank about the missing cheque before the money was swindled out, adding that the SFL authorities should have also informed the bank before filing a GD with the Rupsha thana. He however said the bank did not get a copy of the so-called GD lodged with the police on December 4 nor did anyone from the SFL contact the bank about the matter.

The SFL authorities however said a copy of the GD was sent to the bank through Katakhali branch of the Central Courier Service. But chief of central courier service Amal Kumar Dey denied receiving any copy of the said GD from the Southern Foods Ltd till Thursday.

The OC of Rupsha thana denied that any GD about the missing cheque was filed with the thana, adding that the copy of the GD being shown to police is definitely a forged one. Terming the accused as professional swindlers, he alleged that their version of the incident is a concocted story.

None from the Khulna branch of Bangladesh Frozen Food Exporters' Association (BFFEA) have so far come forward in support of SFL authorities. The vice president of BFFEA Belayet Hossain said

the real culprits must be punished. Meanwhile, the Chief Metropolitan Magistrate has placed four out of the five accused in the case on a two-day remand with effect from yesterday. The accused are SFL cashier Mushfiqur Rahman, chief cash officer Yakub Ali, senior officer Apurba Kumar Roy and cash officer Mostafa Ekramul Azad.
