# Dhaka, Yangon to establish joint trade commission

With high hopes to open up new horizon in bilateral trade, Bangladesh and Myanmar yesterday agreed to establish a joint trade commission and introduce accounts

trade and coastal shipping link. Moreover, the two neighbours will also revise the existing border trade agreement signed in 1994 to prohibit trading of third-country products. At present, the border trade agreement, which is in place since 1995, does not contain any specific provision to prevent trade in aoods of third-country origin. Under the agreements on

accounts trade and revised border trade, third-country products will not be exchanged between the two countries and manufactured goods will require at least 30 per cent value addition to be traded.

The agreements are expected to be signed next March in Myanmar where Bangladesh will hold a single-country fair, said officials.

The proposed joint trade commission to be headed by commerce ministers of the two countries will regularly review trade and identify products for trade. The commission will also identify and resolve the problems in bilateral trade. Bangladesh Commerce Minister

Amir Khosru Mahmud Chowdhury and visiting Myanmar Commerce Minister Brigadier General Pyi Sone in a 45-minute exclusive meeting at a local hotel yesterday finalised the

"Implementation of the agreements will substantially increase bilateral trade, while the current informal trade will be gradually turned into formal trade." Khosru told reporters at his secretariat

office after the meeting. He said an expected increase in trade between the two countries would help Bangladesh earn more SEE PAGE 11 COL 2

West Indies completed a clean sweep when they won the second and final Test by seven wickets at the MA Aziz Stadium here yesterday

It was yet another three-day defeat for Bangladesh in their 17th Test but not before young Alok Kapali entertained the boisterous home crowd with 85, his highest score in the five-day game

The 18-year-old batsman led a spectacular recovery after the home team, resuming the day on 40 for no loss, slumped to 126-5.

His scintillating 111-ball knock that contained a dozen boundaries and two sixes including a magnificent


pull off paceman Vasbert Drakes over mid-wicket kept Bangladesh in the hunt against a gradually frustrated West Indies pace battery.

Kapali's half-century in successive Tests helped Bangladesh score 212 in their second innings, giving the visitors an easy 110 runs to chase.

The homesick Caribbeans were in no mood to take the match into the fourth day as they overhauled the target in only 21.3 overs. Marlon Samuels hit the winning runs with a four off Kapali through mid-wicket, and with that the young guns of West Indies brought an end t o

### 3 to die for attack on Indian parliament

A special court yesterday sentenced three men to death on charges related to a deadly attack on the Indian parliament last year.

The court had on Monday found the three guilty helping five militants, who were all killed at the scene, carry out the attack last December which killed nine.

A woman who was found guilty of not disclosing information to police was sentenced to five years in jail.

Judge S N Dhingra handed down death sentences to Mohammed Afzal, a 35-year-old fruit merchant, Shaukat Hussain, a former student at Delhi University and SAR Geelani, a New Delhi college teacher [Details on page-9]
