10 'anti-socials' arrested

Ten alleged anti-social activists and criminals including the BNP district committee vice-president were arrested on Friday by the joint forces of law enforcing agencies.

According to police sources, Khondoker Chand, one of the vicepresidents of BNP district committee was picked up by army led joint forces from his residence at Rajbari crossing of Dhaka-Khulna highway. Khondoker Chand, a businessman by profession was charged with patronising corruption in tender business. He was sent to the court with a prayer for detention under Special Powers Act. Kotwali police also arrested nine other alleged criminals including three phensidyl traders from the East Khabashpur area of the town. The other arrested are alleged highway robbers, criminals and extortionists. All have been sent to jail.

Seeds, fertiliser for poor growers

NEWS SNAPS Over 5pc of RU students are drug addicts

Despite several anti-drug drives, the number of drug addicts has increased alarmingly in all nine upazilas of

According to Statistics Department of Rajshahi University, more than 5 per cent students of the univer-

Over Tk 5 lakh are being spent every year by the drug addicted students. The number of addicts is increasing day-by-day since the administration has failed to take any legal action against the shopkeepers who served drugs to the students

Different kinds of liquors including rectified spirit, country-made wine, Indian wine, phensidyl and heroine are being freely traded and consumed by the addicts, it is alleged.

Drugs are available at Kazla, Binodpur, Meherchondi and Bakhrabaz in villages Motihar upazila, Asam colony, Sheroil colony, Gurhipara, Horhogram, Tultulipara, Nagorpara and Redlight areas in the city, Pirojpur, Premtoli, Mohishalbari, and rail-gate areas in Godagari upazila, Talonda, Kolma, Kakon and Arhai under Puthia

Office sources, said the Puthia circle of the Department of Narcotics Control (DNC) filed 79 cases with Puthia thana in connection with illegal drug trading and arrested 26 people including 11 females in last eight

A large number of females have been engaged in the illicit trade and use drugs.

Narcotics Control Department recovered 2,283 bottles of phensidyl during recent drives while only 20 bottles of phensidyl were recovered from Puthia in 2001. Only 32 cases were lodged in this regard.

Drug traders as well as addicts from far-flung areas come here considering the place as safe for them.

Abundant availability of different types of drugs like phensidyl, heroin and hemp is yet another attraction to the drug users.

Ninety per cent drug carriers are husband-deserted woman or widow who are involved with the heinous trade. Wearing veil over their bodies, they carry 30 to 50 bottles of phensidyl even foreign wine concealing inside their veils, locals said

While visiting village Bakhrabaj it was found that 5/6 young boys were taking heroine sitting beside the hut of Jotsna, a heroin trade. The villagers told that such a scene was common both at night and day in the locality. Even Muslim, Jillur and Kalam of this village sell pathedine in wholesale price.

The conscious people did not dare to file any case against the unscrupulous drug traders. They informed that a section of unscrupulous drugs traders in connivance with law enforcing agencies had been doing brisk

Meanwhile, a father handed over his drug-addict son to the police as the latter did not give-up drug despite repeated attempts by his father, the people Horhogram in the city told. There is a growing concern among the guardians, as the number of drug-addicts is increasing sharply. A good number of families are on verge of ruin as their addicted sons have been involved in various crimes like snatching and extortion.

Meanwhile, the anti-terrorism, joint-operation team recovered bottles of phensidyl and over 100 bottles of rectified spirit from Sobjibazar of Upashohor, New Market and Horhogram area in the city recently.

During the raids the law enforcing agencies arrested the drug traders Abdur Rouf alias Rob of Shalbagan and Letin of Horhogram area in this regard.

Local people want to get rid of such inhuman suffering of the drug-addict family-members and anti-social drug-trade which is destroying social and family bond.

Contempt of court

ADC (Edn) of N'ganj, 3 others asked to show cause

The High Court asked the addi- and Justice Salma Masud hoc committee dissolving their tional deputy commissioner (ADC, Education) of Narayanganj, the chairman of the Board of Intermediate and Secondary Education, Dhaka and three others to show cause within three weeks of issuing the notice for contempt of court, says a press

Justice Md Hamidul Haque

Choudhury issued the Contempt Rule on November 11for violating a High Court order.

The story in brief is that one person named Iqbal Hossain and three others who are elected managing committee members of Gono Biddya Niketan High School, Narayanganj, filed a writ petition against formation of an ad regular managing committee by the Intermediate and Secondary Education Board, Dhaka, for which a Rule Nisi was issued. Justice Md Awlad Ali and Justice Syed Dastagir Hossain after long hearing passed a verdict on July 24 this year declaring the ad hoc committee illegal and reinstated the regular committee to function.

But the ad hoc committee continued to function defying the High Court order. Subsequently the writ petitioners filed contempt petition against the violators of the High Court order. After hearing of the High Court issued the Contempt Rule. The contempt petition was moved by Barrister Rabia Bhuiya with Advocate Majumder Saiful Islam.
