Call to reintroduce women's seats in JS thru' direct polls

Speakers at a discussion vesterday called for reintroduction of women's seats in parliament with provision of direct elections.

Though women constitute half of the total population, the eighth parliament is running without their representation, they said.

They called on the government to ensure that the ninth parliament should have more women's seats than before.

The Institute for the Development Policy Analysis and Advocacy (IDPAA) of Proshika organised the discussion on a survey report titled 'Increasing Women's Seats and Introducing Direct Election for Women' at CIRDAP auditorium in the city.

Bazlur Rahman, editor of the Sangbad, Mahfuz Anam, editor of The Daily Star, Prof. Nazmunnesa Mahtab of Dhaka University and Shirin Akther of Karmajibi Nari took part in the discussion. Proshika President Quazi Faruque Ahmad presided.

Quazi Faruque said that although the ruling BNP and the opposition Awami League are led by women, they represent 'socially male point of view' as both of them rose to power using their family identity.

Mustafa Abdur Rahman, deputy director, IDPAA, presented the survey report prepared by IDPAA executive members.

Full-fledged Jubo Dal committee announced

Jatiyatabadi Jubo Dal, youth front of the ruling BNP, yesterday announced a 171-member national executive committee with Barkatullah Bulu and Syed Moazzem Hossain Alal MP as its president and general secretary.

Earlier, the ruling party announced the name of president, general secretary and organising secretary of the Jubo Dal on April 29. It took over two months to form the full-fledged committee. Former DUCSU general secretary Khairul Kabir Khokon has been made organising secretary.

The new committee has been formed after 16 years. The previous central committee headed by Minister for Housing and Public Works Mirza Abbas and BNP joint secretary general Gayeshwar Chandra Roy was formed in 1986.

The new committee has 11 vice presidents, 13 joint secretaries, six assistant organising secretaries, 21 other secretarial posts, and 53

Bazlur Rahman urged the women's organisations to move forward through massive mobilisation and press the political parties to meet their demands for

their empowerment. Mahfuz Anam said the survey report reflects the common people's support for women's empowerment, voting rights and direct election to the women's

But the political parties often renege on their election pledges after taking over the office only to serve the 'vested interests', he

Anam also pointed out that the politicians do not dare to break the traditional system.

He called for breaking down the vested interests in order to protect women's rights. Voting power is a great weapon

for the women and they can use it to ensure their rights, he said. Prof. Nazmunnesa urged the women's organisations to unite

and put pressure on the government to ensure their rights. Shirin Akther said the rights of women would not be protected until women's participation in the

decision-making is ensured. Mahbub-ul-Karim, senior vicepresident of Proshika, M Sha habuddin, director of Proshika, and representatives of women's organisations also spoke.
