

Admission test for BBA programme in the IBA has become really tough and challenging for many students who want to be a business executive. Every year near about five thousand students participates in the test. Among them only 120/130students are selected from the written test and the rest of the students gets selected on the basis of their SAT/TOEFL score. After getting selected in the written test students have to face viva and only after passing that final hurdle one gets the chance to study in IBA.

The fact is that there is no such of system of waiting list, that exist in other institutions, in IBA and they always takes their admission test before the BUET, MEDICAL or the DU, so the scenario becomes really pathetic. It's because some of the students leave IBA after they get admitted to BUET and a few more to the medical colleges; and some leave for studying in abroad. Every year almost 10-20 students leave IBA for these reasons. Thus a lot of student miss the opportunity to study in IBA.

Its true, in Dhaka there are a few private universities that offer BBA with good standards. But the tuition fee of these universities's are very high. 
### Hide and seek game with Bogra munitions
