### Khaleda's JS speech draws **AL wrath**

Deputy Leader of the Opposition Abdul Hamid yesterday flayed Prime Minister Khaleda Zia for what he called a failure in playing her role as the leader of the House.

"Rather than working as the leader of the House, she (Khaleda) indulged the people who made parliament ineffective," Hamid told newsmen over a luncheon in the Sangsad Bhaban cafeteria.

Hamid pointed to Khaleda's valedictory address to the just-concluded budget session, in which she praised Deputy Speaker Akhtar Hamid Siddiqui for running the House effectively in the absence of the speaker.

The main opposition Awami League (AL) accused Siddiqui of not running the Jatiya Sangsad in line with the Rules of Procedure. # Four PBCP men shot dead by rivals in Khulna

Four armed cadres of the outlawed Purbo Banglar Communist Party (PBCP) were shot dead by unidentified men yesterday at Badhal of Ghatbhog union under Rupsha thana of Khulna district, police said.

The dead are Abu Saeed alias Kala Saeed, 38, Kala Mannan alias Mannan Howladar, 35, Biswajit Das, 28, and Shah Jamal, 30, all belonging to PBCP's Tapan group. Kala Saeed was second-incommand of the group operating in Rupsha-Terokhada belt and was wanted in as many as 13 murder and a dozen criminal cases in the southwestern region.

The deceased were suspects in Daulatpur Jute Mill rifle loot case,

Officer-in-charge of Rupsha thana said the bodies were recovered from shrimp enclosures at Badhal and bore marks of stab and bullet injuries. Kala Saeed and Kala Mannan hailed from Mahishagani of Rupsha upazila, and Biswajit was from Ajogarha of Terokhada upazila.

Six used shells of 303 rifle bullets were recovered from the murder spots. The bodies were sent to hospital morgue for

autopsy Police suspect the assailants belong to the outlawed party 'Janajuddho', which was floated last month by dissidents in Tapan group in conflict with PBCP's

Locals said four other PBCP cadres were picked up by Janajuddho' men.

### **Govt violated** Constitution, accuses AL

The main opposition party Awami League (AL) yesterday accused the government of violating the constitution and Rules of Procedures of parliament while forming 34 parliamentary standing committees on different ministries.

The constitution and the Rules of Procedures do not entitle the government to form such 'incomplete' standing committees, a presidium meeting of the AL observed quoting Article 246 of the  $Rules\, of\, Procedures\, of\, parliament.$ 

Leader of the opposition and party chief Sheikh Ĥasina chaired the meeting at the Dhanmondi office in the city.

The meeting said the government neither discussed committee formations with the opposition nor did inform them of the moves.

The unilateral decision of the government also violates an UNDP-funded agreement made during the previous AL rule when both the AL and BNP had agreed to

# Dhaka, Ho Chi **Minh City to** boost trade

Bangladesh and Vietnam yesterday agreed to explore economic potentials for greater cooperation and increased volume of bilateral trade and investment.

The agreement came when Vietnamese Foreign Minister Nguyen Dy Nien held talks with his Bangladesh counterpart M Morshed Khan yesterday after-noon, soon after his arrival on a three-day official visit to

Bangladesh. During the 45-minute talks, they also agreed to reactivate the Joint Commission and exchange business delegations between v

"Our talks focussed on trade and economic cooperation since the volume of bilateral trade is very modest ...We should look into it together," Nguyen Dy Nien told reporters after the talks.

He said business people of the two countries should meet and discuss how to expand two-way trade since Bangladesh and Vietnam have got enough potentials.

According to figures available, both-way trade was around \$15 million in fiscal 2000-2001. Bangladesh's major exports included leather, chemical fertiliser, pharmaceuticals, raw jute and shrimp while imports were g

### 23rd PW gives deposition

Additional Superintendent of Police, CID, Mojibur Rahman, the 23rd prosecution witness and investigation officer (IO) of the Shazneen case, gave his deposition before court yesterday.

Later, he was cross-examined by the lawyer of Shahidul Islam alias Shahid, the prime accused.

Kazi Rahamat Ullah, judge of the Second Special Tribunal for Prevention of Women and Children Repression, Dhaka, recorded the deposition. The court adjourned the hearing till July 21.

In his deposition, Mojibur Rahman told the court that he took over the charge of investigation April 27, 1998. He took the charge from Sub-Inspector (SI) Mohammad Shamsul Haq, the first IO of the Shazneen murder case, at the Gulshan Police Station. "After taking over the charge of

the case, I scrutinised the case diary, inquest report, postmortem report and evidences collected by the first IO and took the arrested accused Hemayet Mollah Humayun Kabir, Shafiq, Yasin and Faruk to custody.' "Then I, along with the first IO,

visited the place of occurrence and scrutinised the sketch-map, prepared by the first IO and found it correct. Moreover, I recovered

# Cop held for mugging Tk 5 lakh at Paltan

Two people, including a police constable, were arrested for snatching over Tk 5 lakh from a businessman in front of Polwell Super market, only a hundred yards away from Motijheel Police Station. The incident took place at 8:45pm on Tuesday.

The arrested were Tajul Islam, a police constable who worked as a computer operator at the A d d i t i o n a l D e p u t y Commissioner's (Prosecution) office and Sarwar Hossain, a wardboy of Rajarbagh Police Hospital.

"Six people led by constable Tajul intercepted a businessman, Jamal, and snatched away the Motjheel Police said.

After the incident, police came to know that a policeman was involved in the mugging. Following

Judge Jahangir Alam Mollah issued the order on the jail super as he (jailer) showed negligence in producing Reazuddin Ahmed Monir, brother of the ruling BNP MP, Nasir Uddin Ahmed Pintu, an accused in the Keraniganj double murder case, before the court

The court also asked the jail super to submit the report by July

In the order, the judge mentioned that the accused Monir was not produced before the court yesterday though it was fixed for trial of the case. Moreover, the jail authorities did not inform the court of not producing the accused in the court. So, the court could not begin trial of the case.
