Govt's blind eye to death trap

Launch disasters blamed on inadequate signalling

AKTER FARUK, Barisal

How much the government has to spend to improve the signalling system in the country's river

This question is now being asked by vessel operators and eople here after the July 10 launch disaster in the Meghna that claimed several hundred lives.

The 159km Barisal-Dhaka route becomes virtually a death trap for passengers at night mainly due to very poor signalling system, Idris Ali, Master of triple-decker MV Emdad Khan said.

Inadequate signal lights, underwater shoals and absence of danger marks about river currents have made naval routes from Barisal to other districts most unsafe.

On May 4, 1992, a group of armed people led by Soltan Ahmed and Lutfar Rahman attacked Abdul Aziz and his brother Hossain Ahmed of the same village. During the attack, acid was thrown on them causing severe burn injuries.

The court examined 14 witnesses and acquitted three others accused in the case.
