Govt college teachers abstain from work

Teachers of 265 government colleges including 11 Teachers' Training College and three Alia Madrassahs observed a daylong work abstention programme yesterday to press home their various demands including withdrawal of non-education cadre officials from education cadre posts.

No class was held at any government colleges in the country including in Dhaka, Chittagong, Khulna, Barisal, Rajshahi and Sylhet, says a press release.

The other demands of the teachers included creation of 5,000 new posts, regularisation of 3,000 teachers, and selection grade for lecturers. The BCS General Education

Association in a statement said a rally will be held in Dhaka College on August 1 to drum up support in

favour of their demands. The association also called for intervention of Prime Minister Khaleda Zia to realise their demands.

South Asia Court of Women begins **August 11**

A three-day 'South Asia Court of Women on the Violence of Trafficking and AIDS' begins in the city on August 11.

The Asian Women's Human Rights Council (AWHRC) organises the event in collaboration with the Policy Research for Development Alternative (UBINIG) and Narigrantha Prabartana.

More than 1500 women rights activists, experts, academics, media personnel, legal experts, and testifiers from seven South Asian countries will attend the programme, organisers said at a

press conference yesterday. "The court will neither be a substitute nor parallel to any existing court of law, rather a symbolic one, which will particularly concentrate on women's subjugation," said UBINIG Executive Director Farida Akhter.

"Fundamental character of this court is that the jury will hear the plaintiff in absence of judge and defender, and will draw future work plan," she explained.

The jury members will come from South Africa, Ireland, India, Nepal, Pakistan, the US, and host Bangladesh.

The court endeavours to provide women with an alternative space where they will get an opportunity to recount different forms of violence they faced, Farida said.

"Women and child trafficking occurs with the aim of sexual slavery, forced marriage, and collecting human organs. But once a trafficked woman is rescued, she suffers further social stigma in the name of HIV test," she said.

The court of women will seek to understand the issues in the context of violent global order calling upon the states and governments to make appropriate economic, social, and legal provisions to protect the rights of victims of trafficking.

Sayyda Akhtar of UBINIG said that 647 members of 102 organisations from across the country had already confirmed their participa-

The AWHCR has held 17 similar courts so far in India, Pakistan, Nepal, China, Japan, Egypt, Lebanon, Kenya, Morocco, South Africa, Australia, and Cuba. The event in Dhaka will be funded by the UNDP.
