Four get life for killing Naushin

Four muggers accused of killing a two-year-old child in May last year received life sentence from a court in Dhaka yesterday.

Marian Islam Naushin was cradled in her father Nazrul Islam's arms when a stray bullet fired by the fleeing gang at Uttar Badda hit her in the head on May 9, 2002.

The Second Additional Metropolitan Sessions Judge's Court handed down 38 years of rigorous imprisonment (RI) to each of Mohammad Moslem, Mohammad Saiful Islam Ratan, Abdullah-al-Mamun alias 'Ragkata' Mamun and Sumon popularly known as Baitta

Taking seat at 12:30pm, Judge Hossain Shahid Ahmed read out the 42-page verdict in presence of lem and Saiful in the packed courtroom. Two other convicts --Mamun and Sumon -- have been absconding since the incident.

The four were found guilty of the offence punishable under the Section 302 (murder) of the Bangladesh Penal Code (BPC) and given rigorous imprisonment for life (31 years). Each of them was fined Tk 50,000 and will have to serve one more year behind bars in failure to pay the fines. The gang was also found guilty of robbery punishable under Section 394 of the BPC and given seven years RI.

Six killed in Cox's Bazar landslides

NBR grinds to halt

as officials stop

work over arrest

of colleagues

Six people, including four sisters, were buried alive and nine others injured in two landslides on the outskirts of Cox's Bazar resort town early yesterday, police and wit-

The district administration and locals believe that torrential monsoon rains and multiple cracks caused to hillocks by Sunday's earthquake triggered the mudslides at Kalatali and Purba Kalatali Adarsha Gram, two neighbouring

Sadar police said huge chunks of mud crushed to death Rezia Begum, 16, Nurun Nahar, 14, Fatema Aktar Munni, 10 and Babli Aktar, 8, daughters of forest guard Muslem Uddin, at about 4:00am in Kalatali village, 3 km off the town

Muslem, his wife Lalmati, 50, their daughter Merry, 3 and son

Muslem and the surviving members of his family were sleeping in a room of the staff quarter of the forest department where they resided and the dead in another room at the foothill of a hillock

The mud and five big trees collapsed on the roof from 200 feet above, levelling part of the house

In Adarsha Gram, Sakina Khatun, 48, and Sabura Khatun, 30, wives of Md Siddique Ahmed, were killed in sleep under a giant pile of earth at round 4:30am.

Siddique, his sons Alamgir, 25, Rabi Alam, 7, Babul, 3, and daughter Banu Bibi, 5, were injured in the mud plunge.

They were admitted to Cox's Bazar Sadar Hospital.

"It was raining heavily and all were sleeping when the landslides hit," a witness said.

Wounds still fester

The court verdict on the killing of a two-year-old child with a stray bullet in gangland fire was not enough to heal the wounds her parents suffered.

Marian Islam Naushin died cradled in her father's arms when a gang of muggers fired at will to make a getaway after a mob chase on May 9 last year. Naushin's father Nazrul Islam

left the court, eyes full of tears and unhappy with the verdict that sentenced four muggers to life imprisonment vesterday for killing the child.

"I thought the court would punish them with death. I cannot accept it," an ailing Nazrul said of the sentence handed down by

Judge Hossain Shahid Ahmed of the Second Additional Metropolitan Sessions Judge's

Would you accept it if you had suffered the same shock?" Naushin's father, a businessman, asked waiting reporters on the court premises. Nazrul will appeal to the High Court against the judgement.

The outrage created by the killing of Naushin in Uttar Badda got a new edge after Home Minister Altaf Hossain Chowdhury's comment on the incident that "Allah has taken back His creature"

Achhia Islam, mother of Naushin, could not show up on the court premises yesterday

Dhaka court hands down death to 16 in a month

The Speedy Trial Court in Dhaka handed down 16 death sentences in last one month.

The court, which was set up in October last, has so far awarded deaths to 46 persons for murders. Besides over a 100 have been given

However, it will take between six and seven years to execute the verdicts, lawvers say. A lower court death sentence needs to be approved by the High

Boro growers gain little from govt grains purchase

Paddy growers are yet to get the price support the government's food grains procurement intended to give them in the current boro

The issue came up at an interministerial meeting of the Food Planning and Monitoring Unit (FPMU) recently as the drive failed to procure boro paddy from the growers but succeeded in procuring rice from the millers.

The cabinet had earlier decided that 5.5 lakh tonnes of rice and 1.54 lakh tonnes of paddy would be procured during the boro season

from April 1 to August 31. The meeting found that in the first three months of the season food officials procured 5.6 lakh tonnes of rice from the rice millers but only 26,000 tonnes of paddy

Meeting sources said State Minister for Finance and Planning Anwarul Kabir Talukdar, who was present at the meeting, suggested formation of an independent committee to investigate the poor procurement of paddy.

But the meeting decided that officials of the food directorate would be directed to gear up the SEE PAGE 11 COL 7

Three arrested NBR officials --Shawkat Hossain, deputy commissioner of customs at the NBR and

Sayeed Ali and Mofazzal Haq, superintendents at the customs house, Dhaka -- were sent to jail after the Metropolitan Magistrate Court, Dhaka rejected their bail

The trio was arrested on Tuesday in connection with a Bureau of Anti-Corruption case that accused them of releasing a consignment of varn without realising Tk 7,42,393 in customs duty in April 2001.




