

# BBC reporter defends Iraq story before British inquiry

A BBC journalist who claimed that London exaggerated the case for war in Iraq, leading to a political crisis for British Prime Minister Tony Blair, yesterday defended his controversial report before a judicial inquiry.

BBC reporter Andrew Gilligan read out interview notes backing his story in May, which claimed that the government "sexed-up" a dossier it published last September on Iraq's weapons of mass destruction.

Gilligan was the star witness on the second day of the independent judicial inquiry in London headed by senior judge Brian Hutton into the apparent suicide of government weapons expert Dr David Kelly.

The probe was ordered by Blair, who has been falling in the polls and who is at risk of serious political damage if the investigation's find-

ings are negative.

The government's 50-page dossier included a headline-grabbing claim that Iraq could deploy chemical or biological weapons in as little as 45 minutes.

Gilligan, 34, told the inquiry he had three meetings with Kelly since 2001, and that during one encounter on May 22 this year the scientist had told him the dossier had been "transformed a week before publication to make it sexier".

Kelly said that most claims in the official dossier were based on two sources, but the 45-minute claim was based only on a single source, according to Gilligan.

The BBC reporter used a newspaper article earlier this year to claim Blair's key aide and media chief Alastair Campbell was the man responsible for ordering intelligence officers to beef up the dossier to

make the case for war on Iraq more compelling. The claims have been strongly denied by the government, and sparked a furious row between ministers and the British Broadcasting Corporation, the world's biggest state broadcaster.

Gilligan, defence correspondent for BBC radio's agenda-setting Today programme, was Tuesday asked if it was Kelly who first mentioned Campbell's name.

Gilligan told the inquiry: "It was him, he raised the subject of 45 minutes and he raised the subject of Campbell."

Kelly was found with a slit wrist near his home in Oxfordshire, southern England, on July 18.

His presumed suicide came after he was identified by the government as a probable "mole", and followed hostile questioning at a parliament

At a press conference at Chittagong Press Club, the forum leaders also threatened to go for further agitation if Jamal Uddin was not rescued within August 21.

# Hazari hiding in India?

Joynt Abedin Hazari, a former lawmaker of the Awami League (AL) from Feni and an accused in at least 16 criminal cases, is reported to have been hiding in India for the last two years.

Of the cases, six are in the process of trial and 10 under investigation.

Since 1968, about 40 cases have been filed against Hazari and 24 of them floundered in the absence of plaintiffs or witnesses. Hazari, who hit the headlines for many criminal activities during the past AL regime, was awarded life imprisonment, along with one of his accomplices, in an arms case by a court at Feni on Sunday.

The joint forces raided Hazari's residence in the town in his absence

on August 17, 2001 during the tenure of the caretaker government and recovered a huge quantity of arms and ammunition. Hazari has since been absconding.

The District and Sessions Judge's Court, Comilla, is recording statements on a murder charge brought against Hazari. Cadres of Hazari killed Delwar Hossain, an official of Bakhrabad Gas Field, at his Masterpara residence in 1987.

The case of torturing Tipu Sultan, a United News of Bangladesh (UNB) reporter, is now in the process of trial at the Additional District Magistrate's Court, Feni.

Hazari's men abducted Tipu on January 25, 2000, and beat him up with iron rods before dumping him for dead. Tipu had to undergo a series of surgeries at home and abroad.

The cases that are under investigation include the murder of eight people at Sonagazi before the general elections in 2001.

Another murder case accusing Hazari of killing three persons is under investigation at the Dhagonbhuiyan Police Station.

Apart from these, the Bureau of Anti-Corruption (BAC) is investigating a case against Hazari for laundering about Tk 3 crore.

In July this year, Hazari in a newspaper interview from abroad said he would return to the country by October. But after the recent verdict in the arms case, Hazari's lawyer, quoting his associates at Feni, said he would not return as long as the present government remains in

# Rajshahi-Joydevpur rail link ready for inaugural

## Only 1 of 3 proposed trains to service the route

A direct rail link between Rajshahi and Joydevpur through the Bangabandhu Jamuna Multipurpose Bridge (BJMB) will be inaugurated in Rajshahi by Prime Minister Khaleda Zia tomorrow.

But only one of the three proposed inter-city trains will reportedly be running on the new railway

linking the eastern and western parts of the country that railway officials said would help accelerate economic development of the northern region.

The old inter-city Padma Express that ran between Rajshahi and the eastern side of BJMB has been renamed 'Silk City Express' to make the maiden trip.

Jamat Khan, convenor of

Rajshahi Protection Movement Council (RPMC) alleged that the decision to run just a single train was influenced by some Rajshahi-Dhaka coach owners including a top BNP leader.

"Introduction of the three trains will put bus owners under 'heavy competition' with the railway," he explained.

# S Asian women testifies to sexual abuse

Some 3,000 women shared the emotional testimonies of trafficked and HIV-infected women of South Asia yesterday, the second day of the South Asia Court of Women on the Violence of Trafficking and HIV/AIDS in Dhaka.

The court is being hosted at the Bangladesh-China Friendship Centre by Unnayan Bikolper Niti Nirdharani Gabeshona (UBINIG) and Narigrantha Prabartana as part of a worldwide initiative taken by the Asian Women Human Rights Council (AWHRC) in partnership

with the United Nations Development Programme (UNDP) and OXFAM South Asia.

Highlighting the four major circumstantial insecurities for women in South Asia in four sessions, the testifiers -- women and children either trafficked or infected with HIV/AIDS -- described their myriad ordeals of how these insecurities were linked to trafficking and its subsequent links to HIV/AIDS.

# Strangled children identified, their mother missing

The boy and the girl whose bodies were found in a dustbin at Shajadpur in Gulshan Monday were identified by their uncle yesterday.

Ten-year-old Sraboni Akhter and Anik Hamza, 8, were brother and sister who lived with their mother at their grandfather's house at Satbhaiapara in Sonargaon, Narayanganj. Their father, Hafez Amanullah, is an Imam of a mosque in Chandina, Comilla.

Sraboni was a student of class two and Anik class one at Baiderbazaar Pre-Primary School in Sonargaon.

Their mother is still missing.

Their uncle, Habibur Rahman, identified them at Dhaka Medical College Hospital (DMCH) at 4:00pm yesterday. The two and their mother, Sayema Akhter, were missing from Baiderbazaar residence since last Friday, he said.

Moghi, a domestic help at the

house, said she saw Sraboni, Anik and their mother in a rickshaw and Sraboni's aunt Lucky Begum in another rickshaw in Baiderbazaar Friday afternoon.

Their relatives believe the three went to Lucky's residence at Shahjadpur in Gulshan, where the boy and the girl were killed and later dumped in the dustbin.

The relatives also suspect that Lucky, wife of Sayema's brother Mizanur Rahman, might have a hand in the killing as she was against Sayema's living with her children in her father's house at Baiderbazaar.

"At Baiderbazaar, Lucky thrust a gamchha into Anik's mouth 10/12 days ago and the boy could eat nothing for two days," Habibur Rahman said.

Bodies of Sraboni and Anik recovered from the dustbin bore bruises. A gamchha was tied to the

## GP plans free mobile internet for rural schools

GrameenPhone (GP) yesterday said it will provide mobile Internet service free of cost to 10,000 schools in rural areas.

The announcement came while Minister for Science and Information Communication Technology Dr Abdul Moyeen Khan was speaking as chief guest at the launch of the voice-based news and information service by the GP and Impress Telefilm, the owning partner of private satellite network Channel i.

Moyeen Khan said in his speech that his ministry was considering providing Internet facility in 10,000 schools.

"GP will provide data-fax enabled cards free of cost to the schools for Internet connection, if they are under GP's coverage area," GP's Director (Sales and Marketing) Mehboob Chowdhury said.

Mehboob said GP subscribers would be able to have latest news, daily events, bus schedule, horoscope, by dialling 2626 at Tk 2 per minute.

GP has launched Short Message Service (SMS) based 'push and pull' service for news, transport timetable and other value added services, he said.

Earlier, GP launched voice-based news updates in collaboration with The Daily Star and the Prothom Alo. This service was first in Asia. Even many developed European coun
